FURLONG: Hey Joseph, how are you?

CHIDIAC: Yeah good David. Sorry mate I missed your phone call, my phone – you know Frank Carbone from Fairfield?

FURLONG: No, no, no, no. Nothing in letters mate.

CHIDIAC: Yeah okay. No, no but just because, just in case it goes to vote and he votes against it.

FURLONG: Oh no he can, he can vote against it mate. We got up eight-love last time.

CHIDIAC: Alright, okay.

FURLONG: I, I don't – I mean all, all they're, all they're being asked to do through no fault of theirs or ours if they have to vote again because the Department of Planning have basically fucked up about dates.

CHIDIAC: Yeah.

FURLONG: Nothing, nothing has changed. This is purely an administrative waste of time.

CHIDIAC: Yeah, alright, okay.

FURLONG: Nothing, nothing's changed in the building, nothing's changed in um, what the Council saw last time or what it will see this time.
