05/07/2022 E19/0569 THE COMMISSIONER: Take a seat. The oath that you took yesterday continues to bind you.---The affirmation, yes.

MS HEGER: Ms Tang, you invested an amount of money in Landmark Square, is that right?---Yes.

10 Was that about \$300,000?---Yes.

And you paid that into One Capital Group's account, is that right?---Yes, correct.

Ultimately you decided not to proceed with that investment so it became, in effect, a loan to One Capital Group?---Correct, yes.

Was that loan ever paid back to you?---No.

20 All right. And then One Capital Group went into administration in 2018, correct?---Yes, correct.

So have you attempted to recover that money from Wensheng Liu personally?---I've asked him a few times, yes.

All right. But you haven't recovered the money to date?---No.

When did you finish working on Treacy Street?---When the companies, pretty much shortly after when the companies went into administration.

30

Okay. And the same applied to Landmark Square, that's when your work on Landmark Square wrapped up?---Yeah. Around about there.

All right. And so from that date did you keep working with Philip Uy at all?---I actually still do, still do a little bit of work but mainly from home and I actually didn't completely finish up until probably around about July or August 2019.

When you say finish up, you mean on those two developments or were you doing some other work?---Oh, on those two developments.

Oh, okay. So you finished working on Landmark Square and Treacy Street about mid-2019?---Correct.

But after that you kept working with Philip Uy?---No.

Okay. So you finished working with Philip Uy about mid 2019 as well? ---Yep.

And does the same apply to Wensheng Liu?---Yes.

10

All right. Can I ask you to cast your mind back to late 2015, which is when you said you started working more closely with Philip Uy and Wensheng Liu, correct?---Yep. Yeah, around about there.

Okay. And you'll recall the application for the extra five storeys on Treacy Street was made in December 2015?---I know that it was made around the time that I was assisting but I don't know exactly which, like, exactly when.

Sure. Around that time, did you understand that Philip Uy knew Vince 20 Badalati?---I don't think so, no.

Right. Philip Uy hadn't spoken about Vince Badalati - - -?---No.

--- around that time, late 2015?---No, not that I could recall.

Around that time, did you understand Philip Uy to know Philip Sansom? ---Not that I could recall.

And what about Con Hindi?---Not that I could recall.

All right. But at some point, you did come to understand that Philip Uy knew Vince Badalati. Correct?---Yes.

And when did you develop that understanding?---I think I knew probably when I went to a dinner in Chinatown.

That's the one on 18 March, 2015?---Was that - - -

2016, I'm sorry.---Yes. Yes, that's round about the time that I first saw them.

05/07/2022 E. TANG 966T E19/0569 (HEGER) Is that the first time you met Vince Badalati at that dinner in Chinatown? ---Yes, I think so. That would have been.

And what about Con Hindi? Is that the first time you met him?---Correct. That's the first time I saw him. I technically didn't get to meet them because I wasn't introduced. I was just there.

You weren't introduced?---Yeah, no. No.

Okay. But you were sitting at the same table as ---?--No. I think I was sitting at a different table. I, I can't remember. There was a few tables there that night, yeah.

All right. There were a few tables in a private room. Is that right?---Yes, I believe so.

Okay. And so is that the first time you think you saw Philip Uy and Vince Badalati together at that dinner in Chinatown?---Yes, I believe so.

And is that the first time you saw Philip Uy and Con Hindi together at that dinner in Chinatown?---Yes, I believe so.

And Mireille Hindi was there, as well, of course?---I believe so.

Is that the first time you'd seen Philip Uy together with Mireille Hindi?---I think so, yes.

And does the same apply to Wensheng Liu? Is that the first time you'd seen him with Vince Badalati?---Yes, I believe we, that was the first time that I saw everyone, for the, yeah, for the first time, pretty much.

Okay. So that's the first time you saw Wensheng Liu with Vince Badalati and Con Hindi and Mireille Hindi. Is that right?---Correct. Correct.

Okay. And around this time that you started working more closely with Philip Uy, that is late 2015 - - -?---Yeah.

- - did he mention from time to time that he had contacts at council?---No.
- 40 Did that come later?---Yes.

Okay. When did he first start referring to his contacts at council, can you remember?---I don't recall.

All right. And what did he say about his contacts at council?---He just said that they're his friends.

That he had friends at council. Is that right?---He just said that they were his friends.

10 Well, did he mention anyone specifically?---No.

Did he say that they were councillors?---No. Not that I could recall.

And in what context did he mention that he had friends who could help him?---I don't recall exactly but it was in conversation. I don't know if, whether it was at a dinner party or whatever it was but he did mention it.

Was this in the context of talking about 1-5 Treacy Street?---I don't recall.

Was it in the context of talking about the Landmark Square planning proposal?---I don't recall.

Well, at a certain point, you were concerned about some delays with the Landmark Square planning proposal. Correct?---Yes, the companies were, were concerned, yes.

Right. That came later in about 2017 that you started having those concerns or that the company started having those concerns?---I believe so. I don't remember time lines exactly. It's been quite a while. But it was around about the time that I was working for both.

All right. And did Philip Uy refer to his friends in that context?---Sorry? Can you repeat - - -

Well, you said Philip Uy would from time to time refer to having friends at council. Is that right?---No. Philip mentioned to me probably once or twice that he has got friends. It wasn't technically "time to time". So I don't know how, how you want to phrase that, but – sorry. What was your question again? Sorry.

Well, I'm just trying to understand the context in which he referred to having friends. Did you understand him to be referring to friends who could help with the Landmark Square planning proposal?---I didn't think much of it. He just said that he had friends at council.

Well, it must have been in a context, Ms Tang. Can you try to remember the context in which he said he had friends?---Well, possible, possibly, yes.

Well, possibly what?---That, well, possibly that that's what he meant.

10

That they were friends who could help with the Landmark Square planning proposal?---I'll be honest with you, it, it has been a while so the only thing that I do remember clearly is that he said that he's got friends at council. So what he meant by that I'm not exactly sure but that's I guess open to everyone's interpretation.

All right. But around the time he was mentioning this you understood that he knew Vince Badalati. Correct?---Yes.

20 You understood that he knew Con Hindi. Correct?---Yes.

And you understood that he knew Mireille Hindi as well?---Yes.

So when he referred to friends at council, did you understand it to be one or more of them, well, one or more of Vince Badalati or Con Hindi?---Yes.

Did you understand it to be a reference to both of them?---I don't really, I knew it was one of them or all of them but for me it was just his friends.

- 30 All right. Around the time that that modification application was lodged for the extra five storeys do you recall any discussions occurring with Mr Badalati or Mr Hindi or Mr Sansom - -?---Yep.
 - - about that development?---No, I don't recall.

Philip Uy never mentioned anything to you about such discussions around this time, late 2015?---No, not that I could recall.

All right. And what about the Landmark Square planning proposal? You understood that it had been lodged with council in June 2015.---I think I did hear about it, yes, through the office.

All right. Which was before the time that you started working on the Landmark Square proposal. Correct?---The Landmark, yes, correct.

Yes. And around this time, late 2015, were you aware of any discussions between Philip Uy and any of Mr Badalati, Mr Hindi or Mr Sansom?---No.

Okay. Let's talk about that dinner in Chinatown on 18 March, 2016. ---Okay.

10

Who invited you to that dinner?---Both Philip and Mr Liu just asked me to attend the dinner.

When you say Mr Liu, you mean Wensheng Liu. Correct?---Correct.

And at that dinner Wensheng Liu and Yuqing Liu signed an agreement. Correct?---I don't know – sorry, who did you say again?

Wensheng Liu and Yuqing Liu.---Yes, yes, Yuqing, yes.

20

Is it easier if I refer to Yuqing Liu as China Liu?---Yes.

All right. I'll do that. You understood at the time that that agreement concerned among other projects Treacy Street and Landmark Square, did you?---No.

You didn't understand that.---No. I just knew that China Liu was interested in investing at Landmark Square.

30 And how did you understand that?---I was told by Philip.

THE COMMISSIONER: Were you told what the purpose of the meeting was?---That they're signing some sort of agreement for Landmark Square. That China Liu was investing in Landmark Square.

Thank you.

MS HEGER: All right. And of course Philip Uy was there at that dinner. Correct?---Yes.

And who invited Vince Badalati to that dinner?---I don't know.

05/07/2022 E. TANG 970T E19/0569 (HEGER) And what about Mr and Mrs Hindi, who invited them?---I don't know.

Did you have an understanding as to why Mr Badalati was there?---No. I actually didn't know that they were going to be there.

But once you saw them at that dinner did you form an understanding as to why they were there?---No. I still didn't know why they were there.

All right. But you understood at the time that both 1-5 Treacy Street and Landmark Square were before Hurstville City Council. Correct?---At that time I knew that we had submitted applications and so on but I don't know the extent of where it's at, like what, what sort of application.

All right. And you understood that both Mr Badalati and Mr Hindi would vote on those applications at some point in the future.---No.

Well, you understood that they were councillors at Hurstville City Council at this dinner, didn't you?---No.

20

They weren't introduced to you as councillors.---No.

Okay. Was there any mention at this dinner of Treacy Street or Landmark Square?---I don't recall.

Well, you understand now that both of them were Hurstville City Councillors at the time, correct?---Yes. I understand now.

And you understand now that they would have needed to vote on both 30 Treacy Street and Landmark Square, correct?---Now I do, yes.

And you understand now that the agreement concerned Treacy Street and Landmark Square?---Correct.

And you did understand at the time that China Liu was interested in investing in Landmark Square, correct?---Correct.

And so is it really your recollection that neither project was mentioned at this dinner at all?---Well, I know that they were signing agreements and I was actually just sitting at another table having dinner. So I actually don't recall exactly what was mentioned.

05/07/2022 E. TANG 971T E19/0569 (HEGER) You didn't witness any discussion where Mr Badalati or Mr Hindi said "What's this agreement about"?---No.

All right. Did you leave the dinner before or after Mr Badalati?---I don't recall.

Did you leave the dinner before or after Mr and Mrs Hindi?---I don't recall.

10 Who paid for the dinner?---I don't know.

You didn't pay for your own dinner, I assume?---No, no.

Did you see Mr Badalati leave any cash on the table at this dinner?---No, I didn't see anything, I don't recall.

Did you see Mr and Mrs Hindi leave any cash on the table?---No, I don't recall and I didn't see.

Did you witness any discussion at this dinner about Mr Badalati or Mr and Mrs Hindi travelling to China?---No.

You know they did in fact travel to China in April 2016, correct, all three of them?---I know that they were there when I was there.

And do you know who invited them?---I have no idea, no.

All right. You didn't witness any discussion about that at the dinner?---No.

Was that "no"?---No. Yes, sorry, that was "no".

All right. So you flew to China on 10 April, 2016, correct?---It was around about that time.

You were on the same flight as Chris Yan?---Yes.

Okay. And you flew into Beijing, is that right?---I believe so.

Okay. Who paid for your flights to and from China?---I believe it was Mr 40 Liu, Wensheng Liu.

All right. And why do you believe that?---Because he asked me to go.

All right. You weren't involved in making the payments?---No.

Were you involved in making arrangements for Mr Badalati or Mr and Mrs Hindi?---No.

Do you know who did make arrangements for them to attend?---No.

Well, did Chris Yan have some involvement?---Not that I'm aware of.

All right. Can I show you volume 2.30, page 14? Can you look at message 118 at the top? It's a message from yourself to Philip Uy on 1 April, 2016 at 11.28am. Do you see that?---Yep,

It says, "Philip, make sure you arrange for tickets to fly to Beijing by 11th at 12.00 or 1.00pm." Which tickets were you referring to there?---I don't recall.

Well, you understand that on this occasion Philip Uy flew from Shenzhen to Beijing, do you?---I knew that he went to Hong Kong before I was due to leave.

All right. And you can obviously cross the border from Hong Kong into Shenzhen, correct?---Yes.

And are the tickets you're referring to here tickets from Shenzhen to Beijing?---I don't know if they are referring to that.

All right. Well, I can tell you that Philip Uy in fact did fly from Shenzhen to Beijing on 10 April with a number of people. So do you think it's likely that that's what you were referring to?---I don't know to be honest. I knew that he was going there with some people from Hong Kong.

On your understanding, was Philip Uy going to make the bookings for these tickets that you're referring to?---Yeah, that's what my message says, so I assume so.

Yeah. And on your understanding, did he intend to pay for those tickets?---I don't know, to be honest.

Do you know whether he did pay for those tickets?---No, I don't know.

All right. You'll see further down the page if we scroll down at 122, there's a message between someone called Connie and Philip Uy. Do you know who Connie is?---No.

You see there 's an attachment to that message which I can tell you is a passport for Mireille Hindi. Do you know where he got a copy of that passport from?---No idea.

10

You didn't have any involvement in arranging that?---No.

Okay. If we move to page 15, I'll just mark page 14 for identification. That'll be MFI 38.

20 MS HEGER: Move to the next page of 2.30, page 15. Can we scroll down to message 131.---131.

131 is a message from someone called Emily Ly to Philip Uy. Do you know Emily Ly is?---No.

Right. Well, I want you to assume for a moment Emily Ly is a travel agent.---Okay.

And you'll see there are eight names listed there?---Mmm.

30

And it says, "Take off from Shenzhen 16.45. Arrival into Beijing Capital Airport." Do you see that?---Yes.

Do you know who number 2 is, the person listed there?---No.

Do you have any idea why they were on this trip?---I have no idea.

Do you know who number 5 is?---I don't know the Chinese, no, as in, like the written Chinese name.

You don't know that person?---Not that I, not that I could recall.

Okay. You don't know why they were on this trip?---I know the Yuan Hei Tung. He was at the trip - - -

That's number 6 in this text message?---Yes. Yes. I know number 6. And number 8 I know. I believe that was Mr Wong, so, and all the other names I have no idea.

All right. Starting with number 6, is that person also known as John?---Yes.

10 Correct.

Right. And why were they on this trip?---They were, I think what I was told was that they were somehow related to the company, I think GR Capital or representing GR Capital or one of the companies, I don't recall exactly.

Could have been GR Capital Group or could have been The One Capital Group. Is that right?---Yeah. Could have been.

And who told you that?---Philip.

Did you understand that person was an investor in Landmark Square?---Mr

Number 6.---John. Yes, number 6 was an investor. Correct.

And who told you that?---Philip told me that and I've met him a few times when he came to Australia, so, and I also met him in China, so I knew that he was an, I was told he was an investor and he told me he was an investor.

30 In Landmark Square or Treacy Street?---From what I could recall, it was Landmark Square.

All right. Number 8 you said you knew. Correct?---Yeah, I believe, if I'm correct, it should be, I forgot his name, Mr Wong, I think that might be Philip's brother.

Also known as Tommy Wong?---Yes, that's it. Yes. Tommy Wong.

And why was he on this trip on your understanding?---I believe he was part of the, I guess, one of the staff or something of the companies.

All right. And number 7, do you know who that is?---No.

Okay. And you don't know whether Philip Uy paid for the flights for these individuals from Shenzhen to Beijing?---No. Not that I'm aware of.

Okay. From Beijing you travelled onto Tangshan, correct?---Yes.

And was your transfer arranged for you?---Yes.

And did you understand it was arranged by China Liu or his staff?---Yes. His staff came to pick us up.

All right. And you met Philip Uy in Tangshan, is that right?---Correct.

Along with Wensheng Liu?---Correct.

And Mr Badalati and Mr and Mrs Hindi, you met them in Tangshan as well?---Correct.

20 And there you visited the Xinfeng building, correct?---Yes, correct.

I'll just mark 2.30, page 15 as MFI 39.

THE COMMISSIONER: Thank you.

MS HEGER: I'll show you Exhibit 200, volume 2.27, page 7. Exhibit 200. I hope that's the right photograph. Exhibit 200, volume 2.27, page 7. Did you see this sign at the Xinfeng building?---I've seen it before, yes.

And do you think it was at the Xinfeng building?---It was in one of the buildings that we visited. It might have been, yes.

All right. And when you visited the Xinfeng building, Mr Badalati was there, correct?---Yes. I did see him there.

40 And Mr and Mrs Hindi?---Yes. I did see, I believe I did see them there.

Can I just understand, when you got to Tangshan you met up in a group with Mr Badalati and Mr and Mrs Hindi, correct?---I met them when I was doing the tour of the waste renewal facility that Mr China Liu had.

Did you go to the facility first or the Xinfeng building first, can you remember?---I can't recall, no.

Okay. But you toured the waste-to-energy facility as a group with Mr Badalati?---Yes. I believe they were there.

And Mr and Mrs Hindi?---Yes, I believe they were there.

All right. And do you also remember going to the Xinfeng building?---Is it different to the one that was at the facility? I don't recall.

How about you tell me which buildings you visited.---I know that we went to a garden, we went to - - -

Is this on the first day in Tangshan?---I don't recall exactly which day is which but I could only just recall all the places we visited. Exactly where, I don't know, but we went to the waste facility, we did go to another building but I don't know if we, it was within the same complex or not. We visited a garden and then we also visited Beijing. But - - -

And that came at the end after you left Tangshan?---Yes, yes, correct, yes.

All right. Generally speaking on these couple of days in Tangshan, did you move around as a group with Mr Badalati and Mr and Mrs Hindi?---I mainly moved around – I don't recall but I know that there was a trip that I was with Philip and Mr and Mrs Hindi, I believe. I think, I, to be honest, yeah, I don't recall exactly but we did move around as a group as well as, I was always chauffeured around so I just went wherever I was asked to go,

I understand. Do you remember any discussion about this sign on this trip in Tangshan?---I know that we went there to, obviously to tour the facility and also I know that China Liu invited us there just to kind of like celebrate our, I guess, joint venture, if that's what you call it.

You're referring to the agreement signed between China Liu and Wensheng 40 Liu - - -?---Correct, yes.

05/07/2022 E. TANG 977T E19/0569 (HEGER) - - - about Treacy Street, Landmark Square and other - - -?---That's what I was there for, yes, correct.

Okay. So you don't remember any discussion about this sign in particular? You'll see it refers to Landmark Plaza at the bottom.---Yeah, yeah, I know. I could see that, yes.

You don't remember any discussion about the sign?---Well, I wasn't really there to, I wasn't really discussing stuff. I'm just there because I got invited to go.

But you obviously had some discussions with Mr Badalati and Mr and Mrs Hindi in these few days in Tangshan.---No. I - - -

You didn't speak to them at all?---No, no, I did speak to them.

Ah hmm.---So I, from what I understood was that we were there to obviously sign the agreement with, or China Liu was there to sign the agreement with Mr Wensheng Liu, and Vince and Con and Mireille went there for the waste renewal is what I understood.

All right. Well, at some point on these few days in Tangshan you must have mentioned to – let's start with Mr Badalati, "I'm here because an agreement is being signed between Wensheng and China Liu."---Of course, yes.

All right. And you said that agreement concerns a number of projects in Australia.---I really didn't have those in-depth discussion because that was actually the first time that I officially met them. So it was really I'm just there to, I guess, I don't know why I was invited. I think it might be because we, from what I understood was that it was just China Liu inviting the company here in Australia to visit them, to visit their facility and what they do and also to sign the agreement. So I didn't have in-depth discussion with any of the councillors, like Con or Vince or Mireille.

I'm not suggesting they were in depth, but you saw Mr Badalati a number of occasions in Tangshan. Correct?---Yes, we were there.

Yes. And you must have mentioned to him at some point I'm here because my boss is signing an agreement with China Liu.---Yes, of course.

It's only polite to - - -?---Of course, yes. Of course.

Correct?---Correct.

And you must have given him some indication as to what that agreement was about.---No. I wasn't aware of it at the time.

Well, I'm sorry I thought your evidence earlier was that you understood you were going over there for a signing ceremony between - - -?---Yes, but - - -

- - - China Liu and Wensheng.----Correct.

And you understood that that agreement involved a number of projects including Treacy Street and Landmark Square, didn't you?---I understood it to be Landmark Square at the time.

Okay. And so you must have mentioned to Mr Badalati at some point they're working on Landmark Square together.---That China Liu and Mr Wensheng Liu was working on, yes, Landmark Square together. Of course, yes.

Yes. You recall mentioning that to Mr Badalati at some point on this trip. ---I don't know if I mentioned it exactly to Mr Badalati but like you said, we might have exchanged pleasantries and they might have asked what I'm, what we're here for and I might have mentioned it but I don't recall exactly.

Okay. You don't have a recollection but you think it's likely you mentioned it at some point to Mr - - -?---Possibly.

- - - in Mr Badalati's presence?---Possibly, yes.

Possibly. And would the same apply to Mr and Mrs Hindi, you don't recall but it's likely you've mentioned it at some point in their presence? ---Probably, yes.

Okay. You checked into the same hotel in Tangshan as Mr Badalati and Mr and Mrs Hindi. Correct?---Yes, I believe so.

40 All right. And the next day, so this is now 12 April, you attended that signing ceremony. Correct?---I attended a signing ceremony, yes.

And that was held at the Xinfeng, a hall in the Xinfeng building.---Yes. That one I remember, yes.

And Mr Badalati gave a speech on that occasion.---I believe he did, yes.

Who asked him to give the speech?---I don't know.

And in that speech he talked about Hurstville. Correct?---I'll be honest with you. I was probably there just to attend and I was sitting with some of the people that visited from Hong Kong because that's how we've kind of like formed, not formed but that's what we were told that we are all from GR Capital Group, like probably the Hong Kong I guess office and the Australian office. I was sitting with them most of the time and walking around and eating and drinking, so I know that he did do a speech, yes.

20 You can't recall what it was about?---No.

When you refer to the Hong Kong office, are you saying that was the Hong Kong office of GR Capital Group or One Capital Group?---That's what Philip told me but I don't know for sure.

All right. Can I show you Exhibit 178, which is volume 2.8, page 19? This is a picture from that signing ceremony, correct?---Yep.

You can see in the background there's a picture of China Liu, Mr Badalati and Mr Hindi. Do you see that?---Yes.

You recognise that as a picture from the dinner in Chinatown, correct?---I believe so, yes.

All right. Obviously somebody provided that picture to the organisers of this event. Do you know who did that?---I have no idea.

It wasn't you?---No.

Can I show you the next page in that volume, which is Exhibit 179, volume 2.8, page 20? This is another picture from the signing ceremony, correct? ---Yep. I believe so, yes, of course.

All right. You see in the background there's a picture of Mr Hindi and Mr Badalati and China Liu with some orange curtains?---Ah hmm.

Do you know what event that is a picture of?---No.

All right. Do you know who provided that photo to the organisers of this event?---No.

And on the right, can you see the two gentlemen in orange high-vis?---Yep, yep.

Who is the gentleman on the left?---Kurt Vegners.

Who was the builder for 1-5 Treacy Street, correct?---Correct.

20 And who you'd worked with fairly closely before?---Yes.

By this time, had Mr Badalati met Kurt Vegners, do you know?---Not that I'm aware of.

What about Mr and Mrs Hindi, had they met Kurt Vegners by this time that you're aware of?---Not that I'm aware of.

Okay. All right. Following the ceremony was a dinner, correct?---Yes.

Which you attended?---Yes.

And Mr Badalati attended?---Yes. I, I did see him, yes.

And Mr and Mrs Hindi were at the dinner?---I don't recall seeing them.

All right. Mr Badalati must have asked at some point "What's this ceremony about?"---He didn't ask me.

Well, did you see him ask anybody?---No.

Was there any discussion in Mr Badalati's presence as to what this ceremony was about?---Not that I'm aware of.

All right. But you spoke to Mr Badalati at some point during the ceremony or the dinner, is that right?---I don't recall.

No, no, I'm not suggesting that.---Yeah.

But if she's asking for receipts, they weren't her receipts because if they were her receipts, she'd have them?---True.

So it's likely to be in respect of some sort of payment or payments made by the business that you work for?---I don't know.

And who do you mean by friends?---Well, there's only three friends he's got at the moment. Either Con, Vince or Mireille.

Okay. Did he actually tell you he got that document from Con, Vince or Mireille?---No.

You formed that belief based on what?---The contents of the email.

All right. And the fact that you knew Philip Uy was friends with Vince Badalati at this time?---Yes.

And the fact that you knew he was friends with Mr and Mrs Hindi at this time?---Yes.

And the fact that he met with all of them regarding the Landmark Square
40 planning proposal by this time, as you understood it?---I believe he did meet
with them.

The first one says, "I'm writing this letter to express our disappointment with the rezoning process for the above properties which the One Capital Group has a significant commercial interest."---Mmm.

Is that your handwriting?---No.

10 Whose handwriting is it?---I have no idea.

Is it Philip Uy's handwriting?---I don't recall. It's possible.

But that note indicates an understanding of the English language which Philip Uy doesn't have, is that right, on your understanding?---He, yeah, possibly.

You don't know who wrote this note, is that right?---Yes, that's correct.

Do you have a suspicion or belief as to who wrote it?---I, I need to see Philip's handwriting to work out if it was he that wrote it, but I don't think he wrote it himself.

Okay. And who do you believe wrote it?---His friends.

And who are you referring to?---I don't know which one. I'm referring to the three friends he had.

All right. You believe it was Mr Badalati or Mr Hindi or Mrs Hindi, is that right?---That's what I believed.

All right. And the basis for that belief is just again that you know Philip Uy knew all three of them?---Yes, correct.

And you knew that he'd been speaking to them about the Landmark Square planning proposal?---I know that he meets up with them, yes, and speaks about it, correct.

All right. You didn't actually – did you attend a meeting with Mr Badalati about this email or its contents?---No.

Did you - - -?---I don't, I don't recall, no.

Did you attend a meeting with Mr and Mrs Hindi about this email or its contents?---No, I don't recall.

And when it says there "in which One Capital Group has a significant commercial interest", did you understand that to be a reference to the rezoning agreement I mentioned earlier?---I don't know.

Well, by this stage One Capital Group had sold the land to Prime Hurstville, correct?---Yes, I believe so.

And so what other interest did One Capital Group have in the Landmark Square planning proposal at this time, August 2018?---The only interest they would have is the payment for the agreement, that I am aware of.

You mean the rezoning agreement I referred to earlier?---Yes, yes. That I'm aware of, correct.

All right. As far as you know – well, did you ever mention that agreement to Mr Badalati?---Not that I could recall.

Did you mention it to Mr or Mrs Hindi?---Not that I could recall.

Did Philip Uy mention it to any of them?---I don't know.

Do you have belief or suspicion as to whether he did?---He might have.

Well, what does that mean? Do you believe he did or not?---I don't know 30 for sure so he might have.

All right. Did he give you any indication that he had?---Not that I could recall.

Can I show you volume 1.6, page 170, again part of Exhibit 129. This is an email from Catherine McMahon at Georges River Council to Meryl Bishop at Georges River Council, amongst others. You're not copied to this email, and I'm not suggesting you ever received it, but I'm going to ask you a question about it. It's dated 11 September, 2018 and you'll see it's said to be a file note on a meeting with Elaine, Gencorp and Greg Hynd regarding

the Landmark VPA. You understand that's a reference to the voluntary planning agreement?---Yep.

And in the second-last dot point – well, first of all, do you recall attending a meeting with Ms McMahon around this time, 11 September, 2018?---I don't recall exactly but I have had meetings with Catherine.

All right. In the second-last dot point it says, "Elaine then said she was advised by council that a DCP was not required. I said that if she was referring to the staff meeting held with Councillors Hindi and Badalati, then that was incorrect, both councillors supported a DCP." You recall there was some debate around this time as to whether a DCP, that is a Development Control Plan, was required or not?---I don't recall exactly but there might have been.

All right. Did you have some discussions with Mr Hindi or Mr Badalati on that topic around this time?---Not that I could recall.

All right. But you've accepted from time to time you met with Mr Badalati around the Landmark Square planning proposal, correct?---Sometimes, not, yes.

And some of those meetings occurred in 2018, correct?---I don't recall when exactly.

I think you've accepted that there were some in the time period 2017 to 2019.---Correct.

But you can't recall what year they were in, is that right?---Correct.

Okay. You said you finished working on the Landmark Square planning proposal about July 2019, is that right?---I believe so, yes.

Okay. Can I show you volume 16.2? This is an invoice from E Creative Solutions, which is your company, correct?---Ah hmm.

It's dated 4 June, 2019. So that's around the time that you finished working on Landmark Square, is that right?---Probably, yes, around about that time.

40 And you've issued the invoice to Vertex Corporation Pty Ltd. Do you see that?---Ah hmm.

Well, were you doing – first of all, why did you issue this to Vertex Corporation?---I believe that was a company that belonged to Mr Wensheng Liu. I don't recall. But it's, it's one of the companies that I was just doing work that related to Landmark Square, yes.

By this time the One Capital Group had gone into administration, correct? ---Yes.

And did Wensheng Liu tell you to invoice Vertex Corporation on this occasion?---He might have.

Well, can you recall any discussions with Mr Liu about Vertex Corporation?---I don't recall exactly, no.

All right. But you formed an understanding that if you were going to issue invoices for your work on Landmark Square, you should issue them to Vertex, is that right?---Correct, yes.

And that understanding was based on something Wensheng Liu told you, is that right?---Correct.

Okay. And this invoice was paid, I take it?---I don't know but I guess so. I assume so, right.

Who paid it?---Either Mr Wensheng Liu or Chris.

Chris Yan?---Yes.

All right. I'll tender 16.2, Exhibit 221.

MS HEGER: I'll show you volume 3.2, which is Exhibit 198. This is an invoice issued by Golden Miles Travel to "Mr Hindi and partner". Do you see that?---Ah hmm.

It's dated 16 April, 2016, so around the time of that trip to China.---Ah hmm.

10 It says "one year return ticket from Sydney to Hong Kong", do you see that?---Yep.

And the total cost, excluding the credit card charge, is 4,240. Do you see that?---Ah hmm.

Have you seen this document before?---No.

Right. Could I show you another document, which is volume 2.8, page 49, which is Exhibit 202.---Ah hmm.

Now, I can tell you that Mrs Hindi has confirmed this is her handwriting. ---Okay.

I can also tell you that this photograph was found on Wensheng Liu's phone.---Okay.

You can see that the 4,240 is the same figure that appeared on that invoice I showed you earlier.---Okay.

Have you seen this note before?---No.

Now I want you to think carefully before you answer this question. Are you aware of any arrangement involving Wensheng Liu or Philip Uy to reimburse Mr and Mrs Hindi for their travel expenses to China?---No.

Do you have any explanation as to why this note – and I appreciate it's not your note and it wasn't found on your phone – but do you have any explanation for why this note was on Wensheng Liu's phone?---No.

All right. I'm going to show you another document which is – and when I ask you the next series of questions, I want you to assume that the date of that photograph of that note was 11 August, 2016.---Okay.

If we scroll down, please, to entry for 12 August, 2016, the next page? So, Ms Tang, this is a record of cash transactions, and the 12 August 2016 one, in particular, records a cash withdrawal from the Gencorp Pty Ltd account. Do you see that?---Mmm.

And then can we scroll through to the last page, the very last page? There'll be some highlighting in yellow. You see at the bottom there, these are the details for that cash withdrawal from the Gencorp account. And it records that you withdrew \$10,000 in cash at 12.18pm on 12 August, 2016?---Okay.

And it records that there were forty \$100 notes and one hundred and twenty \$50 notes?---Mmm.

Do you recall making that withdrawal?---No.

20 Can you explain what the withdrawal was for?---No.

THE COMMISSIONER: It's a lot of money. And you say you can't remember?---No, I don't. Did I actually, went to the bank and withdraw that?

MS HEGER: That's what the details record, that this was made by you personally, this withdrawal.---That I went to the bank - - -

Yes.--- - - to withdraw that?

30

You withdrew the cash.---Okay. I don't even recall.

Well, if you withdrew this amount, that would have been on Philip Uy's instructions. Is that right or wrong?---Correct.

And do you have any idea why he instructed you to withdraw \$10,000 around this time?---No.

All right. Well, I can also tell you that there was a cash deposit into a

Sydney Realty bank account on the same day. You understand that Sydney
Realty is Mireille Hindi's real estate agency. Correct?---Yeah.

I can tell you that that deposit was made earlier than this withdrawal. It was at 11.30am - - -?---Okay.

--- on 12 August.---Mmm.

And it was a cash deposit in the amount of \$10,000.---Okay.

Does that help you to remember the purpose of this withdrawal?---No, no.

Was that a "no"?---That's a "no."

Well, did you give Mrs Hindi \$10,000 in cash around this time?---No.

All right. I'll take that down, please. I'll mark that for identification.

MS HEGER: Can I show you another document? And can we go through to the entry for 24 May, 2017 in this document, please? I can tell you this a, well, I want you to assume, this is record of cash, well you'll see there are some cash withdrawals from various bank accounts associated with Wensheng Liu but then on 24 May, 2017 there is a transfer out of Wensheng Liu's bank account to yourself in the amount of \$60,000.---Yep.

What was that transfer for?---I don't recall.

10

Do you recall receiving \$60,000 from Mr Liu around this time?---I did get some money from Mr Liu, yes.

And what was it for?---I don't recall what it's for.

Well, it's quite a large amount of money, Ms Tang. Do you often receive transfers for \$60,000?---No. I know that sometimes if Philip or Mr Liu is not on the, in town, like in Australia, and if I have to pay some bills it will come to my account.

So on some occasions, just explain that to me again. If Mr Liu or Mr Uy is out of the country they might arrange a transfer to your account?---I believe it happened once. I don't really, actually I don't recall what that \$60,000 is for. I'd have to go back and - - -

Okay. But let's go back to your earlier evidence about them being out of the country and arranging transfers to your account. Whether or not this was such a transfer, speaking generally, why would they transfer money to your account, as you understood it?---There was one time when Philip was overseas and I had to draw a cheque for the Everest Financial, the bank. So he put it into my account and then I just had to go and do a bank cheque and deliver it to the solicitors.

But you had authority to draw cheques from the Gencorp account?---Yes.

You also had authority to draw cheques from that loan account that you mentioned, the Everest loan?---Technically, no, because it needs to be approved by the bank, the Everest.

But I think your evidence earlier was that there needed, there were two - - - ?---Signatures required.

There had to be two signatures.---Yep.

From yourself and Chris Yan. That was your evidence, wasn't it?---No. It was one had to come from Everest, which is the bank, and one had to come from the GR Capital Group for that loan account. So it has to be one from that party and one from this party. It's never two from this party or two from that party.

I understand. One from the bank, one from GR Capital. But insofar as GR Capital was concerned, that could be either you or Chris Yan, is that right? ---Correct, yes.

Okay. And I think I asked you this before, but did you have authority to draw money from GR Capital account or the One Capital Group account? ---No.

Okay. But Chris Yan did, didn't he?---I believe he did.

So in those circumstances, why would it ever be necessary for them to transfer money to your account to pay some sort of expense?---I believe at the time, I believe at the time that what I am talking about is actually when Philip had to give some money to the bank, which is Everest. So then he actually loaned it, lent it from his friends, apparently, is what I've been told. So then they put it into my account.

You never saw that happen?---No.

Do you know anything about that?---No.

Philip Uy never gave you any indication that he paid Mr Badalati an amount of money?---No.

Mr Badalati has also given evidence that Mr Hindi told him that Mr Hindi received a similar amount from Philip Uy. You're aware of that evidence? ---I saw it in the news, yes.

All right. And did Philip Uy give Mr Hindi an amount of money for Treacy Street?---Not that I'm aware of.

No. Did Philip Uy do or say anything to suggest that he had?---No.

And what about Wensheng Liu? Did he do or say anything to suggest that he'd been involved in giving money to Mr Badalati or Mr Hindi regarding Treacy Street?---No.

You're aware Mr Badalati's also given evidence that he was given \$100,000 in cash from Philip Uy regarding Landmark Square?---Yes, I saw it in the news.

All right. And did Philip Uy give Vince Badalati \$100,000?---Not that I'm aware of.

Did Philip Uy do or say anything to suggest to you that he had?---No.

And you're aware Mr Badalati's also given evidence that Mr Hindi also received \$100,000 from Philip Uy in respect of Landmark Square?---Yes, I am aware from the news.

40 And did Philip Uy give Mr Hindi \$100,000 for Landmark Square?---Not that I'm aware of.

10 THE COMMISSIONER: All right. Are there applications to cross-examine?

MS HEGER: Not as far as I'm aware.

THE COMMISSIONER: No? All right. Thank you for your assistance

MR FAHD: Commissioner, can you hear me?

20 THE COMMISSIONER: Yes, I can.

MR FAHD: This is Mr Fahd, solicitor for Mireille Hindi. I believe Counsel and I will like to cross-examine Ms Tang. Mrs Hindi, as you know, is still under the summons. It would require us to obtain some instructions in relation to certain evidence given today.

THE COMMISSIONER: Well, I haven't received an application, you see? I suppose you say that this evidence came as a surprise?

MS HEGER: Commissioner, that's a document that I may wish to ask

cash transactions. Obviously, I read out certain entries from that table. I'm
happy to provide the details of those entries to Mr Hood but as for the entire
table, I only asked questions about one entry in it. Happy to give the details
of that entry.

THE COMMISSIONER: Yeah. Yes.

MR HOOD: Well, that makes it very difficult, Commissioner, with respect, to serve the interests of my client when - - -

THE COMMISSIONER: Well, it makes it difficult, too, if I hand that material over before your client's been asked about it.

MR HOOD: Well, if that's the case, Commissioner, with respect, could the witness stand down to some other time when I - - -

THE COMMISSIONER: No. No, I'm not prepared to do that, I'm really not. She was asked questions about one entry. You can have that one entry. But what's the forensic purpose from your point of view to have all the entries now?

40 MR HOOD: Well, I didn't get to look at all the entries and how they may relate, if they do, to my client in any way whatsoever.

THE COMMISSIONER: All right. We'll give you the one entry and if you can satisfy me that it really is necessary to get this witness back, to be asked questions about other entries, then we'll do that. But I'm not proposing to put this witness over to meet everyone's convenience. The fact is we've got to get on with it and we don't want to keep this witness here unnecessarily. You've heard what I said to those representing Mrs Hindi. Be prepared to go at 2 o'clock. And, quite frankly, I really can't see what the forensic utility is of the other entries in respect of this witness.
