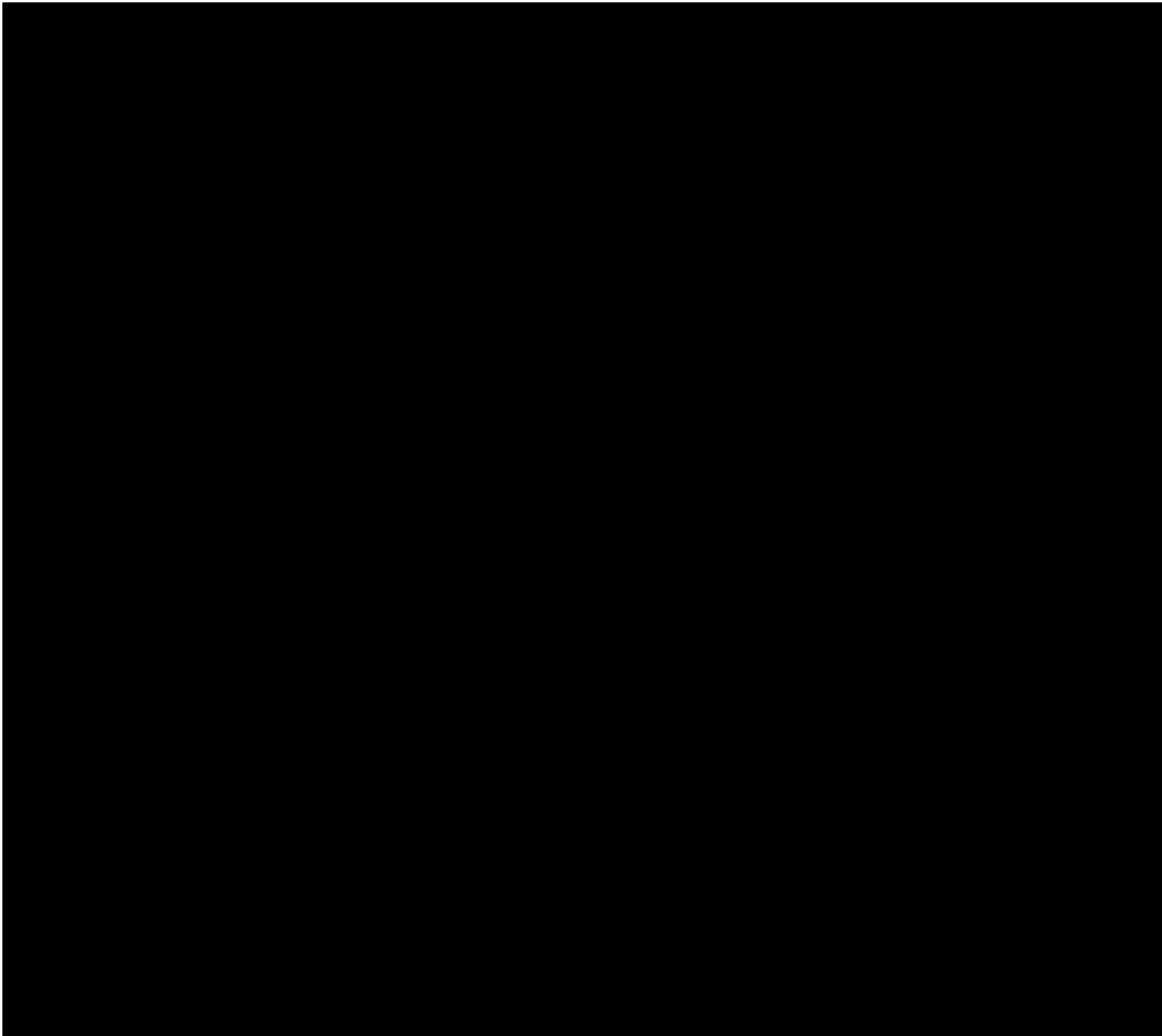

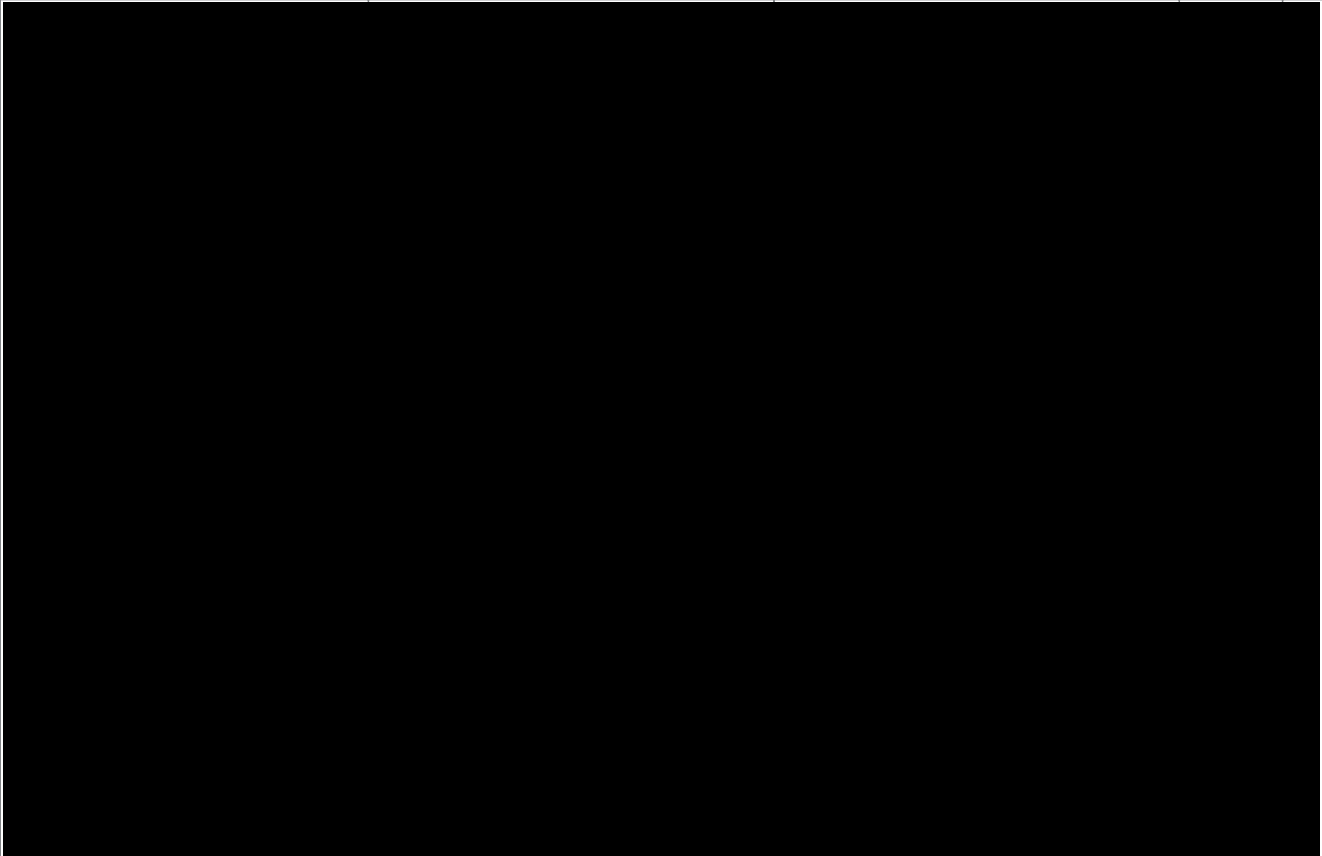

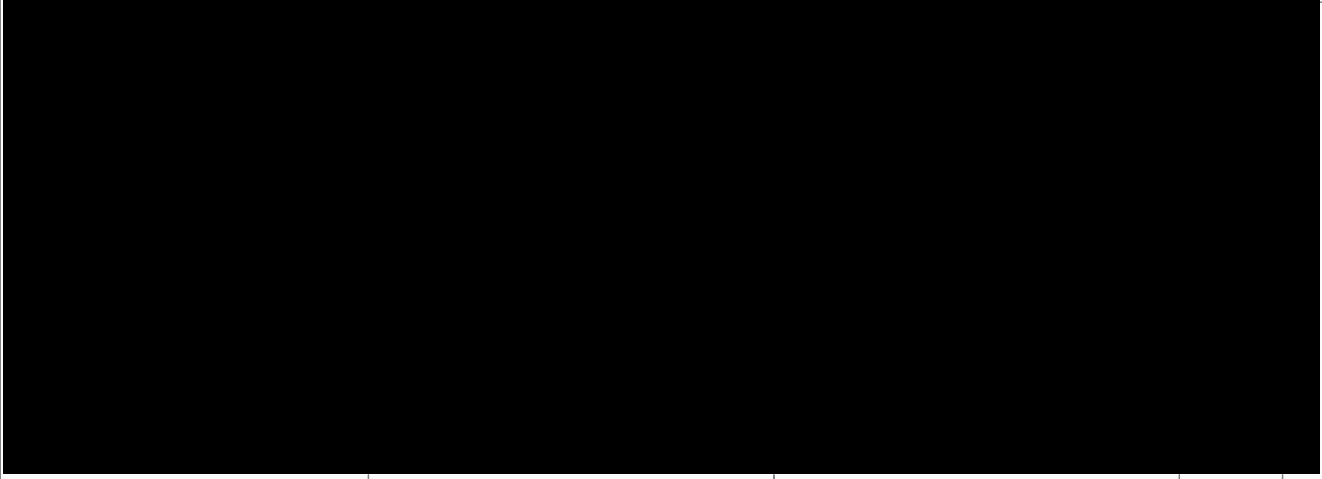

I met with the person who introduced himself as Mr Liu through his interpreter. There were maybe two or three people with him. He told me through his interpreter that he comes from Tanshang and that his city was flattened by an earthquake. He also said he was in the business of "waste to energy " where they collect the kitchen waste from the entire city every day and send it to the factory where the waste is converted to electricity and other products. He indicated that he would like to do the same in Sydney where he is willing to invest \$1 billion dollars to build such facility.He then invited me to dinner at China town to discuss the matter further. I was interested as I was the chair of SSROC that dealt with cheap electricity and obviously recycling waste. I accepted the invitation and asked councillor hindi to accompany me as he is an engineer and he was interested in waste to energy as he has been researching it for over two years. He accepted the invite. When we arrived at dinner I saw cr hindi with his wife and About 7 or 8 Chinese whom I may or may not have seen before as I have met so many Chinese in hurstville. I was surprised to see Mr Liu amongst those at dinner.during dinner there was some documents being signed and. It was in Chinese and I asked the interpreter what was that about and he said an MOU to do business in China. At the end of the dinner myself and cr hindi were invited by Mr Liu(China) to visit his factory and see first hand how waste is converted to energy. We accepted the offer and arranged a date and a time to meet in China. Mr Liu interpreter paid for the dinner but we did not accept it as he would not take money. I took two fifty dollar notes and put on table and hindi put two hundreds dollars on table for the dinner for him and his wife.</p> <p>In April hindi and I decided to go on a private trip as a holiday to HongKong, then Shenzhen and Beijing. We stayed in Shenzhen in a hotel and then travelled to Beijing here we stayed for one night. Then Mr Liu arranged for his staff to pick us up and take us to Tangshn. We stayed in a hotel and Mr Liu took us to see his factory and we are impressed with the operation. In the afternoon he invited me to attend a presentation at the factory hall with over 400 workers attending. THE two Lius signed some MOU which I assumed is the same one they signed in Sydney and that is to do work together in China. I was asked to make a speech which I did d that was the end of it. In the morning we went to breakfast and after breakfast we went to pay for the hotel and we were told that it has been paid for by Mr Liu as his guests. We refused it and took 2000 RMB and hindi wife Miray Took out 4000 RMB and we gave them to MR Liu staff. We said it was for the dinner last night and he hotel accommodation . He refused to take it but we insisted that he takes it which eventually he did.</p> <p>We returned to Beijing.
