**Reason**: Having proper regard to the principle of view sharing as set forth in <u>Tenacity</u> Consulting v Warringah Council [2004] NSWLEC 140 the proposal, without these modifications, would have a devastating impact upon the district views of the neighbours and a more skilful design could provide the applicant with the same development potential and amenity and reduce the impact on the views of neighbours.

**Note**: The effect of this condition is that it requires design changes and/or further information to be provided with the *Construction Certificate* drawings and specifications to address specific issues identified during assessment under section 79C of the Act.

**Note**: Clause 146 of the *Regulation* prohibits the issue of any *Construction Certificate* subject to this condition unless the Certifying Authority is satisfied that the condition has been complied with.

**Note**: Clause 145 of the *Regulation* prohibits the issue of any *Construction Certificate* that is inconsistent with this consent.
