ABDI: Yeah

NGUYEN: Yeah, quick I got about 15 missed calls from him.

NGUYEN: Yeah.

ABDI: Say, say to 'em one came at, say Brefni came at 450 and another one came at 600. You know. And then say, and then, and then say to 'em, meaning like -

NGUYEN: I just wanna, I just wanna this one looks like exclusion, (UNINTELLIGIBLE), Brefni.

ABDI: No. All, all he -

NGUYEN: Brefni.

ABDI: Brefni is the only person that had the exclusion and it's just a walkway and er um, and I've forgotten what else, what he said signs or some shit. But –
