ABDI:                      Hey.

NGUYEN:                Yeah. So tell me the story. I don't know understand how – what do you mean by it?

ABDI:                      He's a fuckin' – he's – so I met up with him yesterday.

NGUYEN:                Yeah.

ABDI:                      And then – so I wanted to – so I – like I - I said let's turn off our -

NGUYEN:                You didn't give anything away, right? You didn't give anything away right?

ABDI:                      Nah, nah, nah, nah, this guy – this guy he loves to talk. So I just let him – you let him talk.  
You never talk when you –

ABDI:                      So I said 'listen let's turn off our phones and have a proper chat' and then – then we started  
yapping away and all this bullshit so I can figure out where his –

you'. So he's the one that's been saying for months since last year I want to do something with you. Like I want to do – I wanted you to do something for me right. I want you to work with me, I want to do something with you. So then I – anyway so then I – then I thought what have you got. Then we're talking bullshit and then out of – out of nowhere, then I started saying, then I was like trying to lead him onto subbies and money and how this is the last job and I said 'look this is the last project, this is the last job, we've got to fuckin' milk it because of this – the pandemic the subbies and really desperate and shit'. Then straight away – then – as soon as I said that, without even – I haven't even mentioned anything yet, he said 'oh yeah, yeah I know, I know, you wouldn't believe the other day I was speaking to that, you remember that guy, Aidan – Aidan Cox from RJS'. I said 'oh, Aidan Cox'. I said 'isn't Monty and Tony' and then he goes 'nah, nah, nah, Aidan's from RJS' and then the – I just bullshit like that, you know.

NGUYEN: Yeah, yeah, yeah, yeah.

ABDI: And then he goes – and then he goes 'oh he was fuckin' calling me, he was telling me, calling me and saying oh well you tell me whatever you want, whatever you want'. Like basically acting like a Lebo. You tell me what you want and that's it, give me the job like that. Meanwhile this guy's is telling me –

ABDI: No, this is - this must be another phone call man. This – this is not – because he said to me, Aidan rang him and said to him 'Vlad you tell me what you..' and I didn't even ask him –

ABDI: Why would he tell me that? I'm not even linked – I'm not even linked to RJS. He doesn't know. He – he's thinking I'm there for - because I want to set something up with him. Why

would he lie to me? Like why would he even make –

NGUYEN: No. The phone call at night I was in the car with him on the way home.

ABDI: Yeah but this – I’m telling you this is probably not that phone call man because he’s exact –

NGUYEN: But then – yeah but then why would he say that without – he doesn’t have any control of anything.

ABDI: His exact words for me was ‘I know what you’re saying because the dude - that Aidan Cox from RJS is ringing me up and he’s like fucking telling me oh whatever you want man, whatever you want I’ll sort it out for you Vlad’ and then I was like ‘oh yeah’. Then he goes ‘what a fuckin’ idiot. I fuckin’ – he pisses me off that guy’ and then I’m like ‘oh yeah, yeah, I go – but I don’t think – I don’t think he’s from RJS man, are you sure I thought Monty and Tony were running RJS’. He goes ‘nah, nah, he’s one of the guys too. He works there too’. I go ‘oh okay’. So I’m just trying to distance the fuckin’ guy and then he’s going off and he’s saying and then he started going on to a tantrum about him. ‘Oh he’s fuckin’ annoying man. He fuckin’, you know, like he’s just, he thinks he fa...he knows everything and then he – and then I’m telling him – and then he – and then he’s telling me oh I can do anything you want me to do. I’ll do whatever’ and then he’s like ‘what do you mean you can do anything’. He’s like ‘I’ll do electrical, I’ll do this, I’ll do that’ and then he goes ‘what are you just going to subbie it out?’

NGUYEN: No that’s – that’s – that’s – that’s no – I had – no that’s the same – it has to be the same phone call because he asked what can you do and Aidan said ‘we do building and civil. That’s all we do’.

NGUYEN: And – and – and then Vlad said ‘do you do any electrical work’. He said ‘no well usually you guys take on electrical’.

ABDI: But why – why would he make that up, why would he make up that to me? I – he – I’m not even linked to RJS. He doesn’t know -

NGUYEN: I’ve no idea but this sounds like the same convers – because he asked us – he asked me ‘what do you guys do? What’s your specialty?’

ABDI: But did Aidan call him afterwards though like maybe a couple of days after that?

NGUYEN: No, no, he hasn’t heard, no, he would have told me. He told me no because – because you know Sina?

ABDI: Yeah.

NGUYEN: Sina called Aidan as well.

ABDI: Yeah that’s because Sairam, yeah there- our name. The problem is everyone there thinks it’s fuckin’ Aidan who’s the face of RJS because we’ve put our name on every single pre-station. Every single package and your name has completely got faded away. Like it’s just his name.

NGUYEN: No because the way I think, this is Kevin, this is from Kevin. He thinks that I’m commercial and Aidan is technical.

ABDI: Yeah well that’s the problem.

NGUYEN: That's the way they see it. That's the way they see it. They go every – every discussion you have with all these Downer that calls him it's all about technical stuff. It's never been about 'oh can you price work for us or can you do this work'. Vlad was the first one to say 'what do you guys do'. Vlad was the only first person that said to Aidan, he was the first person out of all the Downer to say what do you guys do.

ABDI: Well I don't know. I don't – I don't - I don't know why he would have to – like he would – would even say that to me.

NGUYEN: They've both have had bad – they've both have had bad blood from Lithgow anyway.

ABDI: Yeah well I don't know why he says that to me because I didn't even – I didn't – I haven't even got –

NGUYEN: And then – then when I met Sina at - because Sina was – I met Sina on Canley Vale. You know the station up at Canley Vale?

ABDI: Yeah, yeah, yeah Canley Vale, yeah.

NGUYEN: I said I'll get there morning just to cover for Aidan for like three hours and Sina was there and he said 'oh yeah I heard about you. Vlad said you guys are good, very good and all that stuff'. I said 'oh fuck' because I know that Vlad had been bagging us. When you told me that Vlad said 'oh we're too high, we're too high', was bagging us out.

ABDI: Yeah he's one that was there but we're going around. We like – even – even after our conversation, even when he said that to me about Aidan and him saying all this shit and I said – I said 'yeah, yeah, but you know what man, they're fuckin' guns. I tell you something even all the transport people in Chatswood love 'em when they - with their building quality and their civil works, they're fuckin' guns man. Everyone in Chatswood

just brags about it' and he's like 'yeah, yeah, yeah I know, I know, I know' but - and then he still made that comment 'oh they're a bit on that expensive like - and I said 'who gives a shit man. If you don't have a headache, if you don't have a headache why the fuck, who gives a fuck. Like who cares if - like if they're expensive'. You know what I mean and then - and then -

NGUYEN: So he's a - so then he's a no go?

ABDI: No, he's a no go. He's nothing. We've just got to -

talk. I let him say what he wants to say and what he wants to do and like how - what he's got planned out and then when he was going on a tantrum outside of fuckin' Downer. He's talking about like I've got this guy called Jack. Basically he'd described Aidan. Like he was describing, oh yeah, he - he can -

NGUYEN: Who's Jack? As in Jack, what's his name, as in what's the - as in for Dalski?

ABDI: Jack, I don't know, I didn't - I didn't ask his fuckin' name. He works for Dalski at this stage but he's not a Dalski owner. He goes and does - he works - he does tendering like he goes and wins jobs for everyone, for Dalski, for everyone right.

NGUYEN: Yeah.

ABDI: And anyway then when he said that to me and then he's like oh he's talking about 'oh yeah we're going to sit tight Nima, in six months' time we're going to win a three million dollar job and I want you to come and run it and we'll cut you in' and then I'm like 'yeah, yeah, yeah, yeah for sure, give me a call. Like yeah, yeah bro'. Like when he started talking like that, like this - that's it I was like 'oh I've got to go now. Like I'm late'. Like I was just alright you're wasting my time. Like you - you're not - then because he started talking about Downer. Like he started saying - like he started talking bout Downer like how he, nah, nah, he doesn't want - he wants to stay legitimate with Downer.
