COX:                              Yeah, hello.

NGUYEN:                        Hey, fuck, I just got off the phone to Nima. He's telling – he's telling me that Vlad wants in.

COX:                              No, he's not.

NGUYEN:                        Huh?

COX:                              Vlad wants in?

NGUYEN:                        Yeah, he called you, because he thought you had Dalski so he called you to suss you out. I don't know, so I think you have to kind of indirectly say something. (LAUGHS)

COX:                              Um, what – how do you – how do you know that?

NGUYEN:                        Because Nima told me because he's been bitching to Nima saying fuck 'why cant you get Dalski in' and said Dalski (UNDECIPHERABLE) I can't do anything, like that's it. It's out of my hands. He said 'fuck, do you know anyone'. He goes 'I don't know anyone', it's like alright I don't know anyone, yeah.

COX:                              I don't want Nima involved in any of this.

NGUYEN:                        No, well that was, I've got to talk, what do you think, I don't know. Like, fuck, did you just do that.

COX: Fuck Nima.

NGUYEN: Huh?

COX: Fuck Nima.

NGUYEN: Stay away from it?

COX: Stay away from him. Sure, we'll get in anyway. I'm telling you we're going to get in anyway. Kevin's going to get us in.

NGUYEN: Yeah alright. Yeah Kevin will get us in but then Vlad could cook it up for us.

COX: Yeah but your Vlad may cook it up anyway. We don't Nima for that. Nima's just gone oh (UNDECIPHERABLE) Vlad.

NGUYEN: Yeah, yeah, yeah, I know, I know, what are we going to do is like fuckin' give Nima like –

COX: Fuck Nima. Just stay away from Nima. Nima's a bollocks, hey. If – if Nima was any good we'd – Stuart would have been ringing me this afternoon to say that we got the Hornsby job.

NGUYEN: Oh they'll send that email saying oh sorry (UNDECIPHERABLE) yeah, yeah.

COX: Stay away, those three stations have got nothing to do with Nima.

NGUYEN: Yeah, oh yeah.

COX: He's (UNDECIPHERABLE). So Nima's probably chancing Sairam saying I think.

NGUYEN: Oh he's probably, you know what, he probably – probably trying to plant the seed that no one fuckin' – it was Vlad that - I told Vlad to get you in (UNDECIPHERABLE).

COX: Vlad rang me last week asking me what packages we wanted to price. So basically Vlad needs somebody to do the work for him, right.

NGUYEN: Yeah.

COX: Um, Vlad needs somebody to do the job for him and make him look good. We're going to be that somebody.

NGUYEN: Yeah because probably Kevin Watters is saying try – try RJS.

COX: Yep and then – and it's um – it's not um, it's no secret that Ben's already told me that Kevin Watters is singing our praises, right. All the PM's because he's, um, he's already told me it.

NGUYEN: Ben?

COX: Ben.

NGUYEN: Yeah.

COX: Because Andrew Gayed said to Ben that Kevin Watters is pushing RJS.

NGUYEN: Yeah.

COX: So Nima's got no control over this, right.

NGUYEN: No, yeah, you're actually right. Nima has no control. He's trying to make out that he has control.

COX: He's trying to create, he's trying to create something, right, out of nothing.

NGUYEN: This, yeah, yeah and then.

COX: Well if – if we fuckin' – no, don't fall into that trap. If – if – Vlad –

NGUYEN: Oh you know fuck no I think – how do I bring you up, how do I approach to say that Aidan's going to get half the share of the company.

COX: Just tell him, just tell him –

NGUYEN: Just tell him straight, yeah?

COX: Just tell him, fuckin' truth, what have you got to lose.

NGUYEN: Well anyway what's he going to do. Yeah, he's going to say he might have a falling out with me. Oh so why'd you do that.

COX: Do you know what, if you don't want to tell him, don't tell him. I don't really care.

NGUYEN: No, but I need to tell him, fuck I need to tell him they're fully on board. The longer I leave it the - fuck.

COX: I don't care if fuckin' – I'll tell them. (UNDECIPHERABLE) I'll give him a call now.

NGUYEN: Kevin (UNDECIPHERABLE). Huh?

COX: I'll give him a call now.

NGUYEN: Who you calling now, what are you going to say?

COX: 'Hey Nima, do you know why I want half of RJS?'

NGUYEN: (LAUGHS) Oh.

COX: (LAUGHS) Right, Jenny's killing me for not entertaining the kids.

NGUYEN: Oh yeah, yeah, yeah, okay, okay, I know. I'm just letting you know like what are we going to do with Vlad, should we approach him indirectly or just –

COX: No, like um he – he rang me the other day fuckin' basically asking what we want to do, you know. What packages we want on his project.

NGUYEN: Is that the same as fuck let me in, let me in or is that just saying oh fuck I just got to tell you because fuck my boss asked me to go to you?

COX: I don't know. I don't know what – I'm not going to say fuckin' something stupid to the lad over the phone, you know.

NGUYEN: No, you'll go have a coffee obviously. Don't do that. Have a coffee, don't be like Kevin, texts you 'oh give me a cut'.

COX: Okay, I'll let you go.

NGUYEN: Alright, go, go, go. I'll catch ya.

COX: Don't worry about the bollocks (UNDECIPHERABLE).
