NGUYEN: It's hard to make out – where's his – I don't know I'm trying to – listen this is for Transport or this is for we think Downer?

COX: This is Downer's selling price to Transport but I don't believe that Downer -

NGUYEN: Hey?

COX: I can't believe that Downer's would have, well maybe they would, maybe they've got like, um, an internal price and then one where they've marked everything up by 80% or something.

NGUYEN: But then –

COX: I think – I think I need Kevin, Kevin Watters to give it a bit of a –

NGUYEN: Yeah he wants 80 % of his eh – I don't know how -

COX: So there's - there's a few things here right. The - the direct cost of the project is half of the total value of the project, right.

NGUYEN: Yeah.

COX: And it's got fuckin' – there's three million for staff.

NGUYEN: Yeah I know, I saw that, that's the salaries huh?

COX: There's three million for staff. We've got, um, nearly two for design. For design, fair enough and then they've got a, um, you know whatever it is for the insurances.

NGUYEN: Yeah.

COX: Three and a half for the staff and office's insurance and all that shit and 1.8 for design and then management fee, (UNDECIPHERABLE) is 1.2 but then they've got those trade prelims, right. Those trade prelims is a reimbursable cost.

NGUYEN: Which you reckon, this is – you reckon this will be it?

COX: Honestly I don't think trade prelims, like that's –

NGUYEN: Trade prelims is the site establishment and early works isn't it? Just the south site because there's no design for site.

COX: So – so like mobilisation and de-mobilisation some of the – some of the budget probably sits in that. Say you offer (UNDECIPHERABLE) these some of the budget that – that -

NGUYEN: What (UNDECIPHERABLE).

COX: Well who knows because you need the sheets behind this.

NGUYEN: Yeah.

COX: This is – this is done in Canley and on every one of those lines you click on that and that will bring you to a whole new spreadsheet of its own.

NGUYEN: No I don't know if he can get – no I don't – I don't think - I don't think Downer would submit that to Transport.

COX: Um, they'd normally – normally what should happen is there's probably an AE that reviews all this, um, and they'd have access to the Canley files.

NGUYEN: Yeah I know but that – that's probably, um, confidential where this one here is just for –

COX: Yeah but somebody, like what they should have is, do you remember back at Glenfield you'd have, um, the Project Manager on file, an A4 file. You know the thickness of a telephone book with all the sheets behind this.

NGUYEN: Yeah, yeah, yeah, yeah.

COX: Somebody should have - if you had the breakdown of this stuff –
