ABDI: He doesn't bring in the paper that you think he does. Like okay do – do your maths, right. Like last year he did more work than we did but his profit for RJS was 30 grand. He did more work, contract wise, more with Macdonaldtown was like 400. Then you had 250 with Jacobs or with Arcadis. So he – he did – he did like say 700 – 800,000 dollar contract where we did – we did 250,000, 300,000 dollar job. Forget about Lithgow. 300,000 dollars is Kingwood and we brought home 200 grand each.

NGYUEN: Yeah I know. I know but like, fuck.

ABDI: But what I'm trying to say is once – well what I'm trying to say is if you put his name on paper you might think oh yeah he knows what the gig is but when he legally owns the share he's – and then he sees like okay he'll do a one and a half, he'll do a two million dollar job.

car. I go no fuck off we're not going to buy you a car. We're going to pay you the money. So I've just been holding off on him so I can - we can pay him out and then pay everything out.

NGYUEN: Yeah.

ABDI: And then like, so just like because he's fuckin', he's really annoying me, you know what I mean.

NGYUEN: Yeah, yeah, yeah, he's just, yeah, just wants to buy a car.

ABDI: I know – I know what you're thinking. I know what you're thinking but Aidan is doing – he's got the wrong idea. Aidan needs to be another Abdul. Then he – then he'll make a shit load of money and he's a fuckin' idiot because he's got the power and the experience to go.

NGYUEN: Oh.

ABDI: In a more powerful a position than Abdul

NGYUEN: Oh, Yeah I know but if you have too much power, when have too much power you have no control. Abdul even said – Abdul had an interview with what – what did you tell me. Who did he have the interview -

ABDI: MTR, MTR.

NGYUEN: Yeah.

ABDI: He had a – he had an interview with MTR. So MTR wants him now to go in as like a Construction Manager or a Project Director. Pretty much a PD.

NGYUEN: Yeah mate he won't have pull. He won't have pull.

ABDI: Yeah bro he's got pull but you know what. No but I ring up all the boys from Metro. Like I rang up – I rang around from Transport side and MTR has got rubbish contract. MTR has got all the – remember when it was only in Glenwood how we did all the signals and coms, all the sigs and comms, and all the ops tech?

NGYUEN: Yeah.

ABDI: MTR does all that. That's rubbish Raj, there's no money in that for us. Like it's all rubbish. So nothing in it. So you got like – you got like – so now – and now he wants to go – he reckons there's a Project Director role with Langs and he wants to put his hand up for that. He asked me if it's for my job. Like for the TAP. The new TAP, I said I don't know. Just apply for it and let's see what it's about, who cares.

NGYUEN: For Langs, for Langs?

ABDI: Yeah that idiot, that Aidan he needs to be doing shit like this. He keeps saying, you know he's being an idiot. You know he said oh it's hard, da, da, it's locked out. It's not bro. He can get in there and he can fuckin' influence. He can push. If he's a high ranking person he can go in there and say, no, no, no, I want you guys to use this contractor because they were on – they were on x, y and z because now we have a reputation so we're not hiding anything. He just thinks oh no fuck it man I'll just – I'll stick with them and then I'll just do a couple of jobs here and a couple of jobs there like bullshit, what petty cash. You're going to leave fuckin' Council. So what you do one and a half million you're gonna probably walk away with like what 50 grand each. We walk away with 50 grand each, that's nothing.

NGYUEN: That's fuckin' more than what I made in the Council. Fuck.

ABDI: Yeah but that – yeah but you’re not – you’re not keeping in mind that you’re just thinking of the money. You’re not thinking about the amount –

NGYUEN: Yeah I know, I have to think about it. If I’m going to be jobless I need know how I’m going to make money, fuck.

ABDI: Yeah that’s what I mean like I mean – I mean that’s all I said. See how the hell Council goes but in the background we’re working. In the background we’re doing stuff with – like we’re doing stuff with Sairam. Vlad’s been trying to call me up. Vlad they’ve pushed him off the – they pushed Dalski off and he’s been trying to call me. I was meant to call him back today.

NGYUEN: Why – why is he trying to call you is he trying to get Dalski back on?

ABDI: Yeah he’s trying to say like he – he wants me to help him get Dalski back on but I was talking to Indian and saying fuck it maybe we should cut – if we cut Vlad in we can – we can like quadruple what we made –

NGYUEN: No, no, no, that’s dangerous. No that’s so dangerous.

ABDI: I know, I know, I know. He’s saying it’s dangerous too.

NGYUEN: If he finds out you and you know something about RJS you’re fucked.

ABDI: No, no, no, no,no, no, I had a strategy. I was never going to do that. I was going – I was going to full pin it on you. I was going to get you – I was going to say that you because I got to know you guys, you and Monty through Kingswood you rang me and said can I help you out blah blah blah. There’ll be, so - you’ll give me little hand out.

NGYUEN: Yeah he likes Aidan for some reason. I get the feeling he likes Aidan does he?

ABDI: No, no, he doesn't care. Like he - he respects him. Like he doesn't care but what I'm saying is these guys it's their last job they're all fucking preparing for money. That's all they're doing right now. This is all their last job. So they're all going on like a pack of hungry wolves and trying to set themselves up. So I was thinking of saying that you approached me from, as the transport guy because of Kingswood and asked me if I could -

NGYUEN: No, no, then you know what, then someone - someone would find out. Oh yeah these guys were on the Glenfield job. No, no, no, no, don't – let's not do that. Fuck.

ABDI: What about Monty. What about Monty approached me because everyone knows Monty. Everyone thinks Monty runs the show. Everyone – everyone thinks Monty is the main guy and then if you get you and Monty to go to talk to Vlad and have a coffee and literally outside and say hey Vlad, look we can work. We can help each other out in Banksia and you know he holds the key. Vlad holds the key like Sairam said.

NGYUEN: Oh yeah, Vlad – Vlad would be – would be like (UNDECIPHERABLE) no, I know.

ABDI: Yeah and he – he – and man the budget is double. Just remember that. The budget is double. Even if you cut him in. Like Abdul goes – Abdul goes tell him – tell him you're here. We'll give you a hundred grand cash. Like don't worry just get us in. Let us cook the whole fuck out of it and we'll give you a 100 grand cash. Like you and Monty, like I set it up. I call him, you and Monty go see him face to face.
