COX: (In background) After six I get back in here. Hello.

NGUYEN: You good to talk?

COX: Yeah.

NGUYEN: Did you – did you – did you call Sairam?

COX: Didn't bother.

NGUYEN: All right, so the story is – he can convince (UNINTELLIGIBLE) – the part – the – the footing works when I – he's 99% certain that we got it already because (INAUDIBLE) –

COX: What's that?

NGUYEN: - the – the footing, 99% that we got it.

COX: Oh yeah

NGUYEN: He has a assessment meeting tomorrow. So he's doing the paper or he's doing the whatever the – the memo whatever it's um now as we speak, um – so and then the part – he wasn't too sure that we could pull this one off. I said nah I've fuckin got a proper con – contractor and everything.

COX: Who's he?

NGUYEN: So Sairam.

COX: Sairam. Yeah –

NGUYEN: Yeah.

COX: - we got a proper contractor (INAUDIBLE) –

NGUYEN: I know – I know that's why – yeah I said (INAUDIBLE) –

COX: So just tell him to give us the whole fuckin thing based –

NGUYEN: I told him that –

COX: - based on that prices, as is –

NGUYEN: - yeah – yeah – yeah and then – and then obviously there comes a fee, I said fuck give me the job, so give (UNINTELLIGIBLE) so this is from Nima yeah, so Nima said yeah - get the job and then they will – we'll give you a fee, there'll be a fee. So I told him Nima how much, I said cost price is seven hundred thousand, it's ninety grand profit. So that's split 50-50 between me and Aidan. So I'm gonna split 50-50 with you and Sairam, and you can deal with the rest –

COX: Fuck that hey, no way I'm – no way are we giving them twenty grand. In fact if you want to give them money you can give them money, but he's not getting a fuckin bean out of me.

NGUYEN: No that's what I'm saying, no that's what I'm saying like I'll – I'll fuckin – I'll – I'll cop that just if I can get the job.

COX: Nah.

NGUYEN: (UNINTELLIGIBLE)

COX: Nah, fuck it. I'm not doing it. You can hand them whatever the fuck you want, but he's not getting, he's not getting shit out of this tender. He's not...you can tell him whatever the –

COX: But you've already spoke to them?

NGUYEN: No I spoke to Nima, and Nima said yeah we'll the (UNINTELLIGIBLE) yeah he wants to see I said fuck I don't know just given that like – don't say – don't say anything yet-

COX: Why are you tell them – why are you telling them that there's ninety grand of profit in there for?

NGUYEN: Because obviously our (UNINTELLIGIBLE) it's – it's – it's cost, it's (UNINTELLIGIBLE) is cost, so - and then – yeah because we put in some (UNINTELLIGIBLE), he knows how much our (UNINTELLIGIBLE) price is seven-ninety. So I can't – we can't say well it's only fifty grand and say fuck what's – what's (UNINTELLIGIBLE) doing this work. And then I say half of it is yours, so I can't touch half of it. So that means I got forty-five grand to play with and I said nah there's no way I'm doing more than half of it.

COX: I can't believe you're giving – I cannot believe that you fuckin agreed to that.

NGUYEN: It's not agreeing, I said I still have to run it through you.

COX: Nah. Fuck it. Fuck it let the work go. I aint gonna get backed into a corner with those fuckin wankers and that's the start of fuckin that whole project. Who's to say fuckin Sairam and Nima are actually gonna do anything. They're probably gonna do fuck all anyway –

NGUYEN: They can do fuck all.

COX: - Ross is fuckin – hey?

NGUYEN: Yeah of course they're gonna do fuck all.

NGUYEN: Ah that's why he – that's the reason why Sariam doesn't pick our call because he made sure this – this is reason why, that's how he gets his ah –

COX: Bullshit –

NGUYEN: Yeah.

COX: - bullshit – bullshit. I'm not – you know what if we don't get the work fair enough, if we do get the work and you're gonna pay them two boys find another contractor to do it. You should have fuckin ran this past me before you came up with this shit. What – weren't we talking about Ross, see when we were saying about Ross and giving him fuckin payments, weren't you saying not much- a thousand dollars.

NGUYEN: Yeah.

COX: How is it that these boys you're gonna give them fuckin twenty. Not a chance, but you (INAUDIBLE) whatever you want you – it's coming out of your fuckin – it's 100% coming out of you, anything that you pay those boys – alright fair enough we'll go for it right, but anything that you pay them comes 100% out of your pocket.

NGUYEN: Oh yeah- yeah I – I know that this is (INAUDIBLE) I don't know it sounds like is–

COX: - for this and for every other fuckin agreement that you – you make with them. I can't believe you fuckin – like for fuckin Ross we're talking about two grand, and we're still probably gonna – and I'm still gonna have to give him something. He's the one that's fuckin kept us up to speed, he's the one that's in fuckin um Vlads' ear. Like Sairam won't even fuckin answer the phone.

NGUYEN: Yeah.

COX: So whatever you want, but um it's coming out of your pocket. I can't believe you just agreed to that.

NGUYEN: It's not a agreement, I said I gotta run through you.

COX: Yeah, but you should have said ninety grand then. If you're gonna tell them that you're gonna split things down the middle with Nima then you can, you can split them down the middle but you won't be fuckin splitting anything – any fuckin hard work and effort that I put into it is going into my bank account not Nima's.

NGUYEN: Oh yeah well I have to make it realistic I don't know how – like as in (UNINTELLIGIBLE) as in – how much (UNINTELLIGIBLE) do you know what I mean, it's like seventy-ninety we put in, how much profit is that –

COX: Yeah, but what is he doing? What the fuck is that fuckin cunt doing for anything?

NGUYEN: I know.
