Ignoring my messages to try and talk to you at a time that's convenient to you hasn't been helpful, so I'll say what I was going to via this email.

Hopefully your emails aren't monitored but if they are, so be it.

I've gone to great lengths to try to explain to you our financial problems and I keep looking at the amount of money you owe me that I've spent for you and given to you for goods not received.

I've given you a list 3 times of what I'm talking about and you will know, that this is all my money that's been spent to provide you with whatever you've wanted over the years. I've also paid a stack of extra Tax, since I've put all these invoices through legitimately and fully paid GST and Tax on the inflated amount of turnover.

Remember, this is my money that's been given to you for, e.g. cars/van I don't have and supposed extra income made through Council that's gone straight to you.

I can't carry you any more and need you to pay me what you owe me. The \$2K you sent last week is an absolute joke. Funny how you can look after everyone else who comes to you but you're not willing to give me back what I've actually spent for you.

You told me on 29th July you "Should be able to send tomorrow". On 13th August you asked for my Bank Details, as you got a new phone and lost all numbers. On 19th August you told me "not to stress and 40K coming". For the second time you've also said that you're waiting for a "mate" to repay you some money he owes you so that you can give it to me.

Last time I spoke to you, you said you got knocked back in your applications for Credit Cards but a couple of weeks prior, you told me you had approval for 1 card for \$20K and another for \$25K and were waiting for another one to come in for I think another \$20K before you deposited all into my Account.

You've always told everybody to be a good bullshitter, you need a good memory. You also told me about 3 years ago that the Bank was going to take your Dad's house, so you had no money. You told me the exact same thing a couple of weeks ago, so this is a very patient Bank. You also told me that I'd get some business from Sam, who I've never heard from and that I'd pick up the deal for the replacement PC's for Council, that hasn't happened either.

When all is said and done, I know you "haven't got any money or assets or any capacity to get a loan". Don't know what your Salary is but it is way better than mine, not to mention your bucket load of Super. I also don't have multiple Fuel Cards, Company Car, Cabcharge, Avis, Campbells, Mobile Phone and Air Fares paid for. You don't even need to pay for the Newspaper and I don't know what else has been added in the last few years, so who is in a better financial position?.

I need you to deposit the full amount of \$161K (\$163K minus the \$2K) in to my Account by Monday 14th September to repay your debt to me. I have Invoices and Bank Details of all the transactions I have made for you and will forward that down to you in a package if I see the money go in.

If you insist on ignoring/flicking me, I'll ring Council on Tuesday 15th September and make an appointment to meet with the GM and Lorraine for the following week and show them all the documentation that I have.

This might not get me my money but at least it'll highlight to them what has gone on before and put you under close scrutiny, so you would see what it feels like to have to live carefully, as we do. I'll also talk to anyone else who might be interested and reveal everything I know.

I do not want to do this but I've been chasing you for years trying to get this money back and can't carry it any more. Remember, I'm not asking for help or a loan, just trying to get my own money back. You should think about the amount of money I've managed to get for you. As best as I can calculate it's around \$1.3M!

If I do need to come down to Sydney, Lea will be with me and you can tell her face to face why she can't get her teeth fixed and will have to wait for a Hospital Procedure that can be done now in a Private Hospital but she'll have to wait for the Public System to get looked after, as we had to forego Private Health Insurance a year ago as we couldn't afford it.

We're actually living on Lea's money now but that won't last long.

Hopefully you'll think about this and do the right thing. If I come down there and you change your mind and offer me the money, I'll need \$165K, \$161K for the original debt and \$4K to cover our expenses coming down.

If I get this money, I'll send you everything I have and close the book. I'll never get in touch or bother you again.
