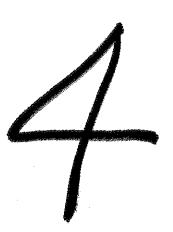

The letters from Immigration state there is no right for review. That means we cannot appeal the refusals. If the applications were Sponsor Visitor Visas then the sponsor would be able to appeal the Migration Review Tribunal (MRT). However, that is not the case here.

The only thing we can do is submit a new application with new information and new evidence.

The main reason for the refusal is the applicant's ability to support themselves. They have not provided evidence of employment and a savings history in Thailand.

Our costs for the visitor visa is \$2,000 for each person.
