We thank you for your recent report and advise that the Independent Commission Against Corruption is now requesting that an urgent update of Mr Goodman's condition be provided by no later than 4pm today.

We kindly request Doctor's opinion as to the following:

1. Mr Goodman's present condition;
2. Any complications that have come to your attention;
3. The condition of Mr Goodman's right leg and whether it is also infected;
4. Details of the Bone Scan booked for Mr Goodman and when the results are likely to be obtained;
5. Any recommendations with regard to amputation of the right leg as the result of the risk of further infection and/or blood poisoning;
6. When Mr Goodman is likely to be discharged and be fit enough to give evidence at the ICAC Enquiry.

We thank you in advance for your assistance and would be obliged if you would attend to this matter as soon as possible.

Dear Michael Abboud,

Re: Gary William Goodman; MRN: 0237527, DOB: 31/10/1956

Thank you for your letter. Unfortunately the infection in Mr Goodman's right leg is a separate issue from his necrotic left great toe which we have amputated. The orthopaedic team have been consulted regarding possible bone or metal hardware infection and ongoing management thereof. They have requested further investigations but have not provided us with an updated plan. I will address the questions as best as I can but I cannot speak on behalf of the orthopaedic team.

1. Mr Goodman is well
2. There have been no complications
3. The right leg appears to have a bone or metal hardware infection based on xrays which we have arranged. There is a small amount of pus tracking to the skin from likely a deep infection
4. The bone scan has been booked. It will be prioritised based on clinical urgency determined by the nuclear medicine department
5. As per orthopaedic team, likely after reviewing scans
6. Can be discharged from vascular point of view with regards to his left great toe amputation. Right leg as per orthopaedic team
