ASSISTANT COMMISSIONER: Yes, Mr Mack.

MR MACK: Commissioner, I propose to continue with Mr Kabite's examination.

ASSISTANT COMMISSIONER: Yes. Mr Kabite, you are still bound by the same affirmation you took. Yes, just take a seat. Thank you.

10 **NOSIR KABITE, on former affirmation**

MR MACK: Mr Kabite, do you recall yesterday when I was discussing with you a phone call in which Mr Izzard said that he was pretending to investigate Bandon Road, do you recall that?---Yes.

And I think you agreed with me when I put to you that that was wrong for Mr Izzard to do.---Yes.

Were you ever worried that Mr Izzard would get caught pretending to investigate Bandon Road?---Yes, sometimes.

And why were you worried?---Because there was illegal dumping.

Because you were illegal dumping? And were you worried that if Craig got – if Mr Izzard got caught that you might get in trouble as well?---Yes.

Were you nervous?---When?

When you were illegally dumping?---Yeah, sometimes.

Was Mr Izzard nervous?---I don't know.

Did he seem afraid that he might get caught pretending investigating Bandon Road?---No, no.

No, he didn't seem afraid? Do you know Sam Abbas?---Yes.

Do you know Mr Abbas by any other names?---By other names?

Yeah.---No. Just Sam.

Do you know Ali Abdul-Rahman?---Yes.

Do you know Mr Abdul-Rahman by any other names?---No.

How do you know Mr Abbas?---From our industry.

From the industry? And how do you know Mr Abdul-Rahman?---Ali, it's a different story. We were friends for a long time.

Friends for a long time. I'll come back to that. Do you know if any cameras were installed on Bandon Road?---Yes.

Do you know if Mr Izzard installed cameras?---Yes.

For the purpose of surveillance?---Surveillance, yeah, because people were dumping on the road, on this road.

Did Mr Izzard ever share with you information about what had been captured on those cameras?---No, not really.

I'll play you a phone call. This is phone call 4-1-1-9, from 4 January, 2016.

MR MACK: Do you accept that Mr Izzard was sharing information with you from the cameras?---I forgot about this one, yes, true, but that was when someone stole the gate from the yard.

All right.---A night before someone stole the gate or a couple of night before.

Did you have a conversation with Mr Izzard about the stolen gate?---Yes.

And did you actually - - -?---And they stole the cameras, yes, true. I remember now. It wasn't a lie. I didn't mean to lie but forgot about it, yeah, true.

Was there any other occasions where he shared information with you about the cameras?---Maybe, yeah. We spoke about the cameras many times.

Well, on other occasions why were you speaking about the cameras? ---Because people were dumping on the road night-time and once someone pinch our generator and they burned one of my nephew's car. We call the cops.

They burned your nephew's car, they took your gate and somebody was dumping on the side of the road?---Yes, yes, yes.

In relation to the dumping on the road, was that near your place?---Yeah, near the place.

Was it on your place?---No, near the place.

Well, why did that concern you?---Concern me?

Yeah, what did it have to do with you if it wasn't on your place?---Because it's on the road. One time just right on my gate was tyres and rubbish, like, demolition waste and furnitures.

Did you get any plate numbers from the photos?---No.

Did you ever follow up with any of the surveillance or anybody that was caught on the surveillance?---No.

What were you going to do if you found them?---I don't know. I do something.

Bash them?---No, not really. Not necessarily. Probably I call the cops. There was one that they stole the generator and the gate. We call the cops and they were there with - we had the cops there.

Why wouldn't Mr Izzard call the cops?---Sorry?

Why wouldn't it be Mr Izzard's responsibility to call the cops?---No, that was inside the yard, not outside. Generator when – this generator was in the office.

So you found out who stole the generator?---No, I didn't.

So who called the cops?---I did.

30 In relation to the stolen generator?---Yes.

And the second half of that conversation related to Mr Beydoun's application, didn't it?---Yeah.

And we've already discussed Mr Beydoun's application, which I might return to later. I'm going to ask you some questions now about Mr Abdul-Rahman. Did you meet Mr Abdul-Rahman for the first time around 20 years ago?---Yes.

40 When you moved to Australia?---Yeah.

Did you live next door to him?---Yes.

And were you in the courtroom when Mr Abdul-Rahman was giving his evidence?---Yeah, outside, but.

Outside. So you heard what he said? So do you accept that he paid you \$18,000?---Yes.

And do you know if that was by cash or cheque?---Cheque.

And do you know when?---When?

Yeah.---Not exactly. It was a few months ago.

I'll show you a document. Do you recognise this document?---Yes.

10 Is that the cheque that you received from Mr Abdul-Rahman?---Yeah.

And it's made out to ATM Excavation & Demolition, which is your company.---My son company.

Your son's company. And it's dated 23 July, 2015.---Yes.

Can you recall if you put that in the bank?---Yeah.

Commissioner, I tender that document.

MR MACK: What was the \$18,000 for?---Just a favour. A loan.

30

A loan?---Because I was, we were buying excavator, so we short of some money.

Wasn't a drink, was it?---A drink?

Yeah. A drink.---No.

Wasn't a drink for Craig?---No way. This one's got nothing to do with Craig or anyone.

40

I'm going to play you a phone call now. It's in evidence. It's in Arabic as well. It's call 2-5-0-8 and it's Exhibit, part of Exhibit 24.---Can you just see the transcript.

You just want it on the screen?---Yeah, please.

That's fine. Okay. And I'll start on page 1 and this is your nephew Mohamad.---Yeah.

And you will see just further down the page there Mohamad says to you, "Now this Ali Abdul-Rahman called my Uncle Ahmed yesterday. He was calling him", and then Mohamad says to you, "Hello, yeah, and he threatened him and at the end threatened him. I don't know what he said to him so my Uncle Ahmed said to him you can make one mistake. I'm going to cut off your hands and legs off Ali Abdul-Rahman." Do you know if your brother Ahmed ever threatened Mr Abdul-Rahman?---I wasn't threaten. Like Ali called my brother because we didn't return the money to him straightaway, took some times and they were having an argument.

Sorry, what was that last, you had an argument?---Argument, yes.

With Mr Abdul-Rahman?---Yes.

Why didn't you pay back his money?---Because we didn't have it at the time.

So what did you do with the money?---We bought a machine.

You bought a machine. What were the terms of the loan?---It wasn't any term.

How long - - -?---I said to him – I don't remember exactly but I said some time like, a month or so.

A month or so. So this call is on 27 November so there's about four months between when the cheque was made out and this phone conversation. ---Mmm.

Well, over the page at page 3 you say, "Do you know, do you know what Ali Abdul-Rahman's job is?" And then Mohamad Taleb says, "What is it?" And then you said, "Ali Abdul-Rahman is Craig's job, Craig's job".---Yeah. That mean excavation and stuff, tips.

Sorry?---That mean tip, he's got a tip.

That means who has got a tip?---Ali.

40 Ali has got a tip?---Yes.

Is Ali's, is Ali - - -?---Waste facility, yeah.

But Craig is a reference to Craig Izzard isn't it?---Excuse me?

Craig is a reference to Craig Izzard.---True.

So how is it Craig's job?---Craig's job, that mean the same industry.

The same industry?---Yes. Job. Craig job to look after things like that. That's the meaning of it.

Why didn't you say Ali Abdul-Rahman is involved in the tipping industry? ---Tipping industry, yeah.

So instead of saying tipping industry you said Craig's job. That's what you expect the Commission to believe is it?---Mr Mack, it's – when I said it's Craig's job that mean Craig doing – looking after job like that. That mean job like my job, his job, any excavation job or tips.

So Craig was looking after other excavation jobs was he?---What do you mean by that?

Well, you said it's Craig's job - - -?---Craig job, that mean Craig and us and him same industry which is the guy looking for – after stuff like that. That's his job to do.

20 So was Mr Abdul-Rahman paying Craig in relation to a job that Mr Abdul-Rahman was doing?---No.

No or you don't know?---Don't know.

You don't know. Well, down the page Mohamad Taleb says to you, "So what do you mean it's Craig's job?" which is the question I just asked you and then you answered on the phone to Mohamad, "Craig's job means that Craig did a job for him and it didn't work." Craig was doing a job for Mr Abdul-Rahman wasn't he?---I don't know.

And it didn't work so the drink had to go back. That's right isn't it?---I don't know about this one.

And you were the middleman, weren't you?---I don't know about this one, really.

I think you do, Mr Kabite.---No, no, no. If you can just, I - - -

All right.---(not transcribable).

Well, you can go through it. There's plenty more material. I can take you through it and it might refresh your memory.---Okay.

I'll take you to the transcript from call 2-5-0-0, part of Exhibit S29. And this is you talking to Fred. Do you know who Fred is?---Ah hmm.

Or do you want me to play you the call? Fred says, "Yeah, Nosir." You say, "Fred, listen to what I have to say to you exactly."---Mmm.

Do you want me to play you the call or are you happy with the transcript? --- Transcript all right.

All right. And then Fred says, "I am on my own, on my own. I'm going to the bank to withdraw some money." And then you say, "Okay, okay. Ali Abdul-Rahman, we did a job through, what I'm about to say to you has to stay between you and me, and if you tell him I'm going to get upset with you, Fred, because I shouldn't tell you this." And then Fred says, "Yeah, yeah." And then you say, "We did a job for him, our friend from the council. He did a job for him and he's not happy with it, and he wants the money back. Do you understand how?"---Mmm.

And then over the page it says, "So he's calling me and I keep telling him I will check with the person from the council today, tomorrow and so on." And you say, "But I was the middleman between him and the other one. That's it. No more, no less, you understand?" So you were the middleman for a job between Ali Abdul-Rahman and Mr Izzard, weren't you?---Yes.

Well, what was the - - -?---But wasn't any, we spoke about it but nothing happened. Ali want me to, because a guy was operating without licence or DA.

Who?---I don't know. A guy in this area over there. And Ali wants a favour of me, just if I can get Craig to stop this guy, because he's operating without a licence and affecting Ali business.

So did Mr Izzard try and stop - - -?---I'm not sure. After I spoke to Andy - -

Mr Cannuli?---Yes.

Yes.---And Andy spoke to Craig, I reckon, or Andy been telling me he spoke to Craig, and Craig on a job, this and that. But in the end of the day, we found out it's all bullshit. Andy didn't do nothing.

So, I'm just going to take you back through that.---Ah hmm.

Ali knew somebody who was operating - - -?---Without DA.

40

Without a DA?---Yes.

And Ali wanted the person who was operating without the DA to stop operating?---Yes.

Because that person was in competition with Ali, is that why?---Yeah.

Yes? And so you acted as a middleman because Ali paid you \$18,000 - - -.

---No, no, no, no. The \$18,000 has got nothing to do with this one, no.

All right. Well, it's got nothing to do with this one? So you acted as a middleman because you then told Mr Izzard about Ali's colleague who was operating without a DA?---No. Not me. Andy.

Andy told Mr Izzard?---I spoke to Andy about it and I ask him to talk to Craig.

And what did you say to Andy?---Just, I explain to him what's going on and Andy said, okay, I'll talk to Craig. And we waited about two or three months. Nothing happened.

So the \$18,000 is unrelated, is it?---No, Mr Mack, no. \$18,000 has got nothing to do with this.

It's completely unrelated, is it?---Unrelated, believe me.

So Mr Izzard was going to do a job for Mr Ali Abdul-Rahman for free, was he?---It's not a job. It's, like, his job to do. Someone operating. I think Ali spoke to him before me. He spoke to Craig, I reckon. Because when Craig once rang me, he said, "Do you know a guy called Ali?" I said, "Yeah, I know him." He said, "He wants to meet me, talking about something."

And how much did you expect to get out of the transaction?---What do you mean?

Well, how much did you expect - - -?---If the job done - - -

- 30 --- to get --- ?--- Yeah, I would have ---
 - --- being the middleman?---I would have got some money, yeah.

How much?---I don't know. Whatever.

What do you mean, you don't know, whatever? You charged \$10,000 for Mr Beydoun for a - - -?---No, Ali, Ali is my friend. Ali different story.

Yeah, well, how much?---Well, I - - -

40

How much would you expect?---I don't know.

\$5? \$100? \$10,000?---Mr Mack, Ali my friend. We been friend for long time. I didn't, I don't know. He just, I left it for him.

You left it for him? So if he had have given you a hundred bucks, would have you said, "Oh, thanks, that's enough"? Or would have you asked him for a bit more money?---No, I wouldn't do that.

You understood he was going to give you something, though?---Well, yeah, he should have.

And that was – some of that you would have had to give to Andy, is that right?---Yes.

And some of that you would have had to give to Mr Izzard.---Supposed to be.

Supposed to be. But the job didn't get done, did it?---No.

And so you didn't get paid for it, is that right?---No.

You didn't get paid? You have to speak, Mr Kabite.---No. No, Mr Mack, I didn't.

Did you ever repay any of the money to Mr Abdul-Rahman?---Yes.

20 How much?---A few thousand. Through Fred, that guy Fred.

And why did you repay the money?---Repay?

Yeah.---Because I owed him the money.

And you say it was for an excavator?---Yeah.

And you expect the Commission to believe that?---Well, that's what happened, Mr Mack. The \$18,000 has got nothing to do with Craig or anyone.

Are you sure it wasn't a drink?---Hundred per cent.

I need you to listen to a phone call now and identify a voice for me. This is call 2-5-3-5. 27 November, 2015. One of the voices is yours.

THE WITNESS: That's my nephew. My nephew.

MR MACK: Mohamad?

MR MACK: All right. Well, who's, who's the man in front of you, that he will give him the money now? Do you see that? This is what Mohamad says to you, "Didn't he tell the man in front of you that he will give him the money now?" What's that a reference to?---(not transcribable). Can't recall on this one.

Do you want to play it again?---Yes, please.

THE WITNESS: Oh, yeah, that was about the money, yeah. That was with the money. The money, because he said he's going to bring some money for me then I said Craig was coming - - -

MR MACK: Mohamad's going to bring some money for you?---Yes, yes, like I said yesterday and he said I'll get the money and I'll come.

Is that because Craig is coming in 45 minutes?---No, it wasn't. He wasn't coming.

So you say Craig is coming in 45 minutes?---Yeah, that's what I said but he wasn't.

Well, who is the man in front of you, what's that a reference to?---No, he said he, the guy said something in front of me which is he's going to pay Mohamad.

Who said that?---Mohamad was seeking money from someone and the guy said yeah. I spoke to that guy - - -

Who is the guy, what's his name?---His name Ahman.

It's what?---Ahman.

Ahman?---Yeah. He's – Mohamad done some loads for him and he said he's giving me a hard time, he's not paying the money. Then I spoke to the guy. He said yeah, I will give it to him. That's what I said when I start talking to Mohamad. I spoke with the man and everything all right.

So why did you tell Mohamad that Craig was going to be there in 45 minutes?---Just as an excuse, you know. Just to get the money off him and Atef.

And so you say Craig is going to be here in 45 minutes and then Mohamad says something in relation to Ahman?---Yes.

Are you being truthful, Mr Kabite?---Yes, sir, about this one - - -

I'll play you another phone call on the same day. I want you to identify some more voices. This is call 2-5-6-9 from 27 November, 2015.

MR MACK: Do you recognise that voice - - -?---Yes, yes.

--- that says, "Okay not to worry" in English?---And he is my friend. He rang me. I said I'll get back to you because I'm with the council guy.

Well, what's the reference to I'll pay you 5,000, is that what you're saying to Mr Izzard?---No. When?

Well, at the very start of the phone call you say to somebody in the background, "I'll pay you 5,000". I'll play it again. It's at the very start of the call but just listen very carefully at the start of the call.

MR MACK: Do you agree that you said, "I'll pay you 5,000"?---Yes.

Do you know who you were speaking to?---Not exactly. Definitely not Craig.

But Craig was with you?---I think so. He was there but not with me.

Do you know where you were on 27 November? This is all the same date as you were having that conversation with Fred.---Mmm.

When you were having that conversation with Mohamad.---Ah hmm.

40 Do you recall where you were, were you at Bandon Road yard?---At the yard, yeah.

And Craig is there?---I think so.

Can you recall discussing with Craig a job for Mr Abdul-Rahman?---Maybe. So could the \$5,000 be in relation to the job for Abdul-Rahman?---No, no, no. No, Mr Mack. I didn't discuss any money with Craig for Ali because Andy was talking to Craig.

I'll show you a text message now. It's a text message between you and Mr Izzard. It's 4-2-4-9 from 7 January. This is a text message from Mr Izzard to you and it's on 7 January, 2016. It says, "You might have bigger problem. The man that wants his drink back rang me today and wants to meet next week".---Yeah.

Who wanted their drink back?---Ali.

Ali wanted his drink back? So it was a drink?---No. Craig call it a drink but he wants the \$18,000 back.

Ali wants the \$18,000?---Yes, the money he lent me. And he spoke to Craig because he wanted to embarrass me in front of Craig.

Ali wanted to embarrass you in front of Craig? Why?---Because I didn't get the money back to him on time.

What money?---18,000.

The 18,000. So the 18,000 was for Craig to do a job?---No, Mr Mack. It wasn't for Craig. It was for me.

It was a drink for you?---It's not a drink. It's a loan.

It says it's a drink.---He call it a drink because we call money drink.

So did he think that – did Mr Abdul-Rahman think that Mr Izzard might have some sway over you?---May have what?

Have had some influence over you?---Yes.

I'm going to play you a phone call now from 9 January, phone call 9-5-2-2.

MR MACK: So the reference to Andy there is a reference to Andy Cannuli?---Yes.

And you're discussing the job that you arranged with Andy for Ali through Craig, that's correct, isn't it?---Yes.

And the deal was that Mr Izzard would be paid for doing the job, wasn't it?

---Sorry?

The deal was that Mr Izzard was going to get paid, wasn't it?---Mmm, yes.

How much was he going to get paid?---We didn't discuss that.

But the drink was worth \$18,000, wasn't it?---Mr Mack, the \$18,000 has got nothing to do with Craig. That was a loan from Ali. I went to his place, I got it.

You took the drink before you'd done the job. That's right, isn't it? The same way that you took a drink from Beydoun before the job was done. That's correct, isn't it?---That's not correct.

I'll play you phone call 4-2-7-7 from 10 January. My apologies. It's a text message. This is a text message from you to Mr Izzard. "I sorted out with Ali guy. No need for you to see him tomorrow."---Ah hmm.

"Make sure I see you in the morning at the yard, Riverstone."---Yeah.

Do you recall sending that text message?---Yes.

And what do you mean by you'll sort it out with Ali?---I spoke to him because, as I said to you, he went Craig and ask him for his money, "Tell Nosir to give me the money."

Were you worried that Mr Abdul-Rahman might dob on you?---Dob on me?

Yes.---In what way?

30

Well, he might go to the police or tell somebody about your relationship with Mr Izzard.---Why want to go to police?

Were you worried that he might expose you - - -?---No, no.

- - - for illegal dumping?---No.

You weren't worried?---No. I spoke to Ali. I sort it out. I said it's got nothing to do with Craig. I'll pay you the money.

40

And if you didn't pay him the money, what was Mr Abdul-Rahman going to do?---Nothing.

Nothing?---As I said to you, we're friends. We're not going to hurt each other over money. He was upset with me because I didn't return the money on time.

Well, did he ever suggest that unless you paid him, Mr Abdul-Rahman might go and tell somebody about the illegal dumping?---Probably.

Probably?---Yeah.

So you were worried - - -?---Possible.

So you couldn't trust Mr Abdul-Rahman to keep his mouth quiet?---No, it's not about trust. It's, if you upset, probably you will do anything.

I'll play you a call from 11 January, 2016. Call 4-2-8-6.

MR MACK: It's pretty clear, isn't it, Mr Kabite, from that phone call, that you and Mr Izzard were doing a job for Mr Abdul-Rahman?---Yes.

20 And you had to do something else for him, didn't you?---Ali asked for - - -

Because he wasn't happy with - - -?---No, Ali asked for meet with Craig. He said I've got something to talk to him about.

Sorry?---Ali said I need to meet with him because I've got something to talk to him about.

Wanted to talk about the job he wanted Mr Izzard to do, didn't he?---Well, I told you about the job already.

30

Well, what was the other thing you had to do for him?---I didn't, he didn't tell me.

He didn't tell you?---He said - - -

That's what you're saying to Mr Izzard. It says, "So we've got another thing to do for him. Just come past the yard, can you?"---Yes.

What was the other thing you had to do for him?---Something related to the industry, that's all.

Well, what was it. You have to tell the truth here, Mr Kabite.---It is the truth. Ali wants to - - -

Something related to the industry. Be more specific?---Ali wants to meet up with Craig to talk to him about some kind of business like something related to councils.

Something related. You know what it is. Be more specific, please. What was it?---No, no, no. I don't know what it is. Honestly, I don't know. he said I need to talk to him about something very important. Something like, he said I'll talk to him about it in front of you. He said, okay, I'll arrange meeting.

So Ali was upset with you because – why was Ali upset with you? —Because of the money.

Because of the money? What money?---\$18,000.

Which was for the job for Craig, wasn't it?---No. It wasn't for Craig, no. It was a loan. You need to believe me on this one, Mr Mack.

So you've got another thing to do for him?---He wanted to talk to Craig about another thing, something related to a tip or - - -

Because you'd already taken the drink, that's why, isn't it?---No.

You didn't perform on that, so you had to do something else.---No, no, no, no, no. No.

Well, what did – what did you understand Mr Izzard meant when he said that Ali was going to give you up?---Probably he's going to dob me in or something.

Going to dob you in?---Mmm.

What was he going to dob you in for?---For dumping.

30

For dumping?---Yeah. That's what I understood but probably I'm wrong. And I didn't take it seriously because Ali is my friend. He won't do, he won't hurt me. Talk behind my back, yes, but hurt me, I don't think so.

This all went wrong, didn't it, with Mr Abdul-Rahman, didn't it?---Sorry?

This all went wrong with Mr Abdul-Rahman, didn't it?---Sort of.

What was meant to happen?---What do you mean by that?

40

What was meant to happen? If it all went right?---I don't know.

You do know.---No, no. What was going to happen?

If it all went to plan, Mr Izzard was going to stop one of Mr Abdul-Rahman's competitors or fine him. That's correct, isn't it?---Yes.

And Mr Abdul-Rahman was going to give you some drink, wasn't he?

---Supposed to be.

Supposed to be. How much was he going to give you?---We, we didn't, we didn't talk about it.

Didn't talk about it. That's not the truth is it?---It is the truth.

You didn't talk about how much money you were going to make.---Well, I told Ali, I told Ali anything we do must be some drink, you know.

Did you give him a quote?---No. That's what I said to him but we didn't discuss any amount or anything.

You realise that what you were doing was getting Mr Izzard who was in charge of investigating matters to influence somebody on somebody else's behalf – do you want me to put that to you again?---(No Audible Reply)

You understand what you were doing, you were getting Mr Izzard to fine somebody else on behalf of Mr Abdul-Rahman.---To fine?

Well, what was he going to do, fine?---Check on the guy. See if he's operating without the licence or DA because that guy was affecting Ali business, selling the stuff \$3 cheaper or something Ali told me.

So why couldn't Mr Abdul-Rahman just go through the normal channels, why did he have to go through Mr Izzard and yourself?---Because Craig was looking after this area at the time.

Well, that's what Mr Izzard gets paid for. Why did he need – and he gets paid from the council for doing that, why did he need Mr Abdul-Rahman to pay him?---What do you want me to say?

It was a bribe wasn't it?---It was.

Yeah. And you and Mr Izzard were co-operating with each other - - -.---Yes.

- - so that Mr Izzard could receive bribes.---Possibly.
- 40 Possibly or yes?---Yes.

ASSISTANT COMMISSIONER: Was that the agreement between you and Craig?---It wasn't a clearly agreement, Your Honour.

Sorry?---It wasn't clearly agreement or something. It was like we understand each other.

Are you saying that Craig knew that that's what was happening?---Yes.

Thank you.

MR MACK: And you were in it together weren't you?---Sorry?

You were in it together weren't you?---Yes.

And if you both got caught doing it you'd both get in trouble. That's right isn't it?---That's right. Correct.

ASSISTANT COMMISSIONER: What about Mr Abdul-Rahman, did he know that this was going on too?---Sorry?

Mr Abdul-Rahman, Ali, did he know about this, did he know that if he paid you money that you would talk to Craig and that there was this understanding between you and Craig?---Obviously.

Obviously?---But, yeah, somehow he - - -

Yes, he did you're saying?---But he didn't like – when he ask me, Your Honour, he said something about this guy and, and mentioned something to him like my friend if anything is going to do must get drink. Just like that but I don't know if he got it or not.

He was very angry with you at this time.---Who?

Mr Abdul-Rahman.---What do you mean, very angry?

Well, he was going to give you up. He was filthy with you.---That's what I've been told by Craig, but he didn't mention anything to me. Every time I talk to him, we're nice to each other and - - -
