Q I said: (en yd) sir

Please explain to me what's  
has been happening with  
your property over the past  
2 years "APRX".

A It's about 12 months ago  
and a fortnight I got  
[REDACTED] to lease that  
section up the property.  
This is because the property  
was really bad to be able  
to ride my horses etc.  
[REDACTED] said it was ok for  
what we were doing but  
if your going to get  
break horses up you will  
need a D.A.

Q How did you meet [REDACTED]  
A Through [REDACTED] (redacted).  
Q How many truck loads  
did you get to come in  
of fill? c

A. I don't know, I don't keep track of it.  
 (cont'd.)

I spoke to Anna and  
 Frank, Anna was from  
 Liverpool council and  
 Frank I believe was from  
 Penrith.

They told me that I  
 couldn't do that and but  
 no one could locate  
 Nasir.

I then told Anna that  
 I put in a D. A. I  
 worked and worked but I  
 heard nothing. (Anna said they  
 lost it.)

I didn't hear from them  
 but I put in another

D. A. I then got a  
 call from Anna and  
 said it was all

Ok. I assumed I  
 could go and kill  
 I thought I could

After all this several officers have  
 come to my property

A Nothing. I don't know why, maybe cause his friends with me.

Q Was he being paid by anybody?

A No, I don't know. Mr Matthews was formally instructed under the Act "P.O.E.O." to stop all Earthworks on the land fill section of the property. Stop all contractors from bringing in any more land fills.

SQ I will advise you that Mr Nasir takes "Kabite"

Has been frustrated on more than 2 occasions to stop filling our worksite.

Q I will make sure this takes place.

- I then informed Mr Matthews that we will be informing him directly re: all Council Actions.

Mr Matthews informed us that two other set of officers have come through the property and didn't speak to me. They spoke to Magid. That's the emphasis, they should have spoken to me.
