ATTACHMENT A

Penrith City Council plan of action in response to ICAC recommendations made into the conduct of a Regional Illegal Dumping Squad Officer and others

Introduction

Penrith City Council and the WS RID Management Committee will implement the two recommendations as described in the report.

Recommendation 1:

That the WS RID Management Committee restructures reporting arrangements within the WS RIDS to ensure that field officers report to a single manager who is responsible for overseeing their actions and approving key enforcement decisions.

Plan of Action

Action taken

Implemented.

Penrith City Council in conjunction with the WS RID Management Committee appointed an Acting Coordinator in May 2016 to directly oversee the operations of the WS RID squad.

Activities, allocating responsibility, measures to be used

The Acting Coordinator does not undertake any patrolling duties and directly oversees the officer's duties. This has ensured a comprehensive oversight of all incidents investigated by RID Squad Officers.

Previously the RID Coordinator was assigned a Local Government Area to patrol however the arrangements now ensure that the Coordinator is fully dedicated to coordinating the squad and is not assigned an area to patrol.

The Acting RID Coordinator reports to a newly created position of Environmental Health and Compliance Manager. The new Manager has taken a proactive role, ensuring regular engagement with the Coordinator and the RID Squad, active involvement in recruitment, oversight of new governance measures and reporting on performance.

The Acing RID Coordinator has recently developed Standard Operating Procedures regarding the management of illegal dumping investigations and is currently developing a protocol between the RID Squad and member councils which will determine the types of incidents allocated to the RID Squad.

The Coordinator Position Description is currently undergoing a formal evaluation process by Penrith City Council in conjunction with the EPA. The evaluation process will take into account the additional governance responsibilities and requirements that have been included in the draft EPA Project Agreement. The position will be advertised externally as a permanent role and the recruitment undertaken in conjunction with the EPA. This recruitment is expected to be completed by 30 October 2017.

Recommendation 2:

That the WS RIDS Management Committee ensures field officers are rotated between member councils on a periodic basis to avoid the building of inappropriate relationships with members of the community.

Plan of Action

Action taken

A rotation system for RID Investigation Officers has been implemented.

Action taken

Activities, allocating responsibility, measures to be used

RID Investigation Officers will be rotated between Council areas every 12 months. The 12-month period will allow sufficient time for Officers to engage with staff from that Council area and ensure continuity and consistency in service delivery and allow time for investigations to be undertaken. The first rotation will commence in October 2017. The RID committee will oversee the rotation policy and officer assignments will be reported back to the committee every six months.
