



The company retains a database of past and present individuals and companies who undertake training; whether it's a short course with no accreditation or a course providing a specific qualification. All students applying for one of our courses are entered into a database which records their personal details, and courses attended / qualifications attained. Any individual attending a qualification course (e.g. Diploma of Project Management) must be formally enrolled onto our system. Our policy is to retain a record of all individuals that attend accredited courses for a minimum of 30 years; as per ASQA requirements.
- 6. Blue Visions Management Pty Ltd was first registered as an RTO in June 2007.
  Prior to this date our organisation was not delivering qualification based courses.
  A Diploma of Project Management being considered a qualification based course was not provided prior to June 2007.






