1. Confirmation of Minutes of Previous Meeting

The Members of the Mine Subsidence Board confirmed the minutes of the meeting on 26 October 2011.

2. Report on the Management of the Board's Operations

At their meeting held at Newcastle on 23 November 2011, the Members of the Mine Subsidence Board discussed and noted the report.

- 4. FN80-00645P0—TCLM07-00249P2— LOT 546—DP 9278—NO 17
  Chapman Street TAHMOOR—

At their meeting held at Newcastle on 23 November 2011, the Members of the Mine Subsidence Board confirmed refusal of the claim under review as it was determined the damage has not resulted from mine subsidence.

The Board Members noted the initial claim assessment accepted 3 of the 4 items for which damage was claimed and cracking to pavement was observed in a Pre-Mining Inspection undertaken on the 12 October 2004.

5. FN80-01301P0—TCLM11-00772P2—LOT 60—DP 246831—NO 3 Pandora Place TAHMOOR—

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board confirmed refusal of the claim under review as it was determined the damage has not resulted from mine subsidence.

The Board Members noted the claim review identified other possible causes for the damage and a Pre-mining Inspection was not sought. 6. FN80-00550P0—TCLM07-00271P2—LOT 1—DP 245153 NO 45 Brundah Road THIRLMERE—

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board approved the purchase of the property, if this was the preferred option for the claimant. Rebuilding had been approved previously.

The Board Members agreed the structure be demolished following purchase and options for the land would be reviewed in 2 year. They noted additional costs would be incurred as a result of purchasing the property due to mine subsidence damage.

  - At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board discussed the legal advice from Kilmurray Solicitors. They asked the Chief Executive Officer to confirm action that will be taken by Stockland before advising the claimant of the Board's position.

  At their meeting held at Newcastle on 23 November 2011 the Members of the
  Mine Subsidence Board confirmed refusal of the claim as the nearest mining is

around 1.5km away and the damage has not resulted from mine subsidence.

9. FN83-01312L0—TCLM11-01950L1—Work Plans 1 to 16, & 20—F3
Freeway—Toronto—ROAD & TRAFFIC AUTHORITY
At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board approved \$5m as a fund for repairs to the F3 and delegated authority to the Chief Executive Officer for the project. The Board Members agreed that a Scope of Works be submitted to them prior to the construction phase and regular updates are included in the Chief Executive's

The Board Members approved the payment of \$37,472 to the RTA for urgent works completed and noted additional expenditure was still being negotiated. The Board Members also requested consideration is given to 'loss of useful pavement life' in any discussions.

The Board Members agreed with the CEO's advice that every effort should be made to complete repairs during 2012.

10. FN07-16626P0-Jemena v Mine Subsidence Board

Management report.

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board discussed the status of the Supreme Court litigation with Jemena (formerly AGL). The Board Members ratified the additional expenditure and noted that a summary of advice from the Crown Solicitors Office was being prepared for their consideration.

11. Chain Valley Bay Residents-Inspection Reports

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board discussed the independent reports prepared by A Grieves and A Shirley for 5 properties at Chain Valley Bay.

The Board Members agreed to accept the independent advice in the engineer's reports for Barrow, Cambourn, Fuller / Smith and Gulliver. The Board Members agreed that Axford's claim had been the subject of Court intervention and outcomes have been a matter for the Axfords and Elcom (now Centennial Coal). The Mine Subsidence Board has had no involvement and full disclosure of any settlement has not been made available. The Board Members agreed that, without prejudice, they would agree to compensate the \$2100 for cleaning.

The Board Members requested the Chief Executive Officer;

- i. Correct the summation error in Table 10 of the Fuller / Smith report
- ii. Prepare a brief for the Minister
- Provide a draft correspondence for the Board Members approval. Write to the 5 residents, enclosing a copy of the report.
- iv. Give each of the 5 claimants the opportunity to meet with the Board Members and engineers at a scheduled meeting early in 2012. The residents are to advise if they wish to do this within 14 days of receiving their report
- Arrange for payments agreed to by the Board Members to be made to those residents who do not request an appearance before the Board.

# 12. FN67-03336L0—TBA11-19470L1—LOT A—DP 387434—NO 181 Pacific Highway CHARLESTOWN—TEMPLAR CHARLESTOWN DEVELOPMENT

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board noted that the Board's approval has expired, although the applicant has Lake Macquarie City Council approval to 2013. As there are no changes to the application, the Board Members approved the development for a further 2 years.

### 13. FN11-08700P2—TBA11-07778P2—1 (PART 17) DP PART 270536—LEND LEASE COMMUNITIES (WILTON)

At their meeting held at Newcastle on 23 November 2011 the Members of the Minc Subsidence Board approved the buildings subject to the following design conditions:

- The final drawings to be submitted prior to commencement of construction, contain a certification by a qualified structural engineer, to the effect that any improvement constructed to meet the specifications of such final drawings will be safe, serviceable and repairable taking into account the following mine subsidence parameters:
  - a. Maximum vertical subsidence of 950 mm
  - b. Maximum ground strains of ± 2.5 mm/m
  - c. Maximum tilt of 6 mm/m
  - Maximum radius of curvature of 10,000 metres
- Final drawings are to show brickwork articulation in accordance with the Building Code of Australia.
- Attention is to be given to all internal finishes to ensure they have been installed in accordance with relevant codes and standards. Particular attention is to be given to tiled areas.

4) Drainage/sewer design needs to provide for subsidence effects determined in the geotechnical report. This may necessitate additional downpipes and drainage points.

Drainage pits are to be designed for subsidence movement.

- All major services are to be located under landscaped or turfed areas to limit removal of hard stand areas to carry out repair or replacement of services.
- 6) Roads and driveways are to be constructed in bitumen or flexible pavement. If concrete areas are required, specific design is to be provided to demonstrate the area will remain safe and serviceable and any damage will be slight. Concrete design would need to include full articulation and separation /sacrificial sections where appropriate. Kerbing is to be articulated and have minimum points for surface and roof drainage access. The Board would not consider repairs where damage is within the Board's Pavement Policy at the time of mining.
- 7) All windows are to be installed to the underside of eaves lining or be light weight construction above, unless specific design is provided for brickwork above and below windows.
- Upon completion of construction, work as executed certification by a qualified structural engineer is to be forwarded to the Board confirming construction was in accordance with the plans submitted.
- 9) Permanent survey marks shall be established on each of the buildings following their construction. A baseline survey shall be undertaken upon installation of the survey marks and a further set of readings taken after 12 months. The location of all permanent survey points and the survey results shall be provided to the Mine Subsidence Board.
- Approval is granted in the knowledge the Mine Subsidence Board would not consider relevelling structures where tilts are less that 7mm/m.

The Board Members did not approve the swimming pool as it exceeds guidelines and the applicant had not demonstrated it can be designed to accommodate future mine subsidence impacts. They delegated authority to the CEO to approve the swimming pool, or variation thereof, if satisfied the pool will not be damaged by mine subsidence.

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board confirmed approval subject to the following conditions:

- The final drawings to be submitted prior to commencement of construction, contain a certification by a qualified structural engineer, to the effect that any improvement constructed to meet the specifications of such final drawings will be safe, serviceable and repairable taking into account the following mine subsidence parameters:
  - a. Maximum ground strains of ± 2 mm/m
  - b. Maximum tilt of 2 mm/m
- Structural separation of units at 22 metre maximum centres.
- Masonry walling is to be fully articulated taking into consideration, the Building Code of Australia site conditions and mine subsidence parameters affecting the property.
- The location of articulation joints are to be clearly shown on plan and elevations.

- Attention is to be given to all internal finishes to ensure they have been installed in accordance with relevant codes and standards. Particular attention is to be given to tiled areas.
- Drainage/sewer design needs to provide for subsidence effects determined in the geotechnical report. This may necessitate additional downpipes and drainage points. Drainage pits are to be designed for subsidence movement.
- 7. Roads and driveways are to be constructed in bitumen or flexible pavement. If concrete areas are required, specific design is to be provided to demonstrate the area will remain safe and serviceable and any damage will be slight. Concrete design would need to include full articulation and separation/sacrificial sections where appropriate. Kerbing to be articulated and have minimum points for surface and roof drainage access. The Board would not consider repairs where damage is within the Board's Pavement Policy at the time of mining.
- Upon completion of construction, work as executed certification by a
  qualified structural engineer is to be forwarded to the Board confirming
  construction was in accordance with the plans submitted.

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board made a recommendation to advise the applicant that the Board would consider high-rise structures upon receiving an application with supporting details including:

- (a) Modelling of structures in the event of a worst case scenario as indicated by the geotechnical assessment
- (b) Advice that structures over 8 storeys will not be damaged in the event of mine subsidence.
- (c) The Board may not approve structures if basements are involved.
- (d) Provision to allow for accuracy of workings
- (e) Certification by a qualified engineer as to design.
- (f) Supporting geotechnical advice
- (g) Separation of the area in distinct zones

The Board Members delegated authority to the CEO to continue discussions with the applicant to ensure that the development application is designed to limit any potential liability that could arise from mine subsidence damage.

If the Division of Resources and Energy - Coal Advice confirms there are coal resources beneath the area then the additional conditions are to apply;

- The applicant is to be advised that there are coal resources beneath the site and these may be mined in the future.
- Signaling and communication cabling is to be installed to allow for ground movement that is expected to be associated with mine subsidence.

- The applicant is to be advised that there are coal resources beneath the site and these may be mined in the future.
- Signaling and communication cabling is to be installed to allow for ground movement that is expected to be associated with mine subsidence.

The item is not included in the Agenda Papers and was tabled at the meeting for consideration by the Board Members.

### FN94-00306P0—TENQ95-00064P0—LOT 2—DP 835196—NO MENANGLE RD MENANGLE—Durham Green Retirement Village

At their meeting held at Newcastle on 23 November 2011 the Members of the Mine Subsidence Board approved development of the Dementia Ward only subject to design conditions to be set by the CEO so the structure will remain safe and serviceable and any damage would be slight and readily repairable and restricted to the full articulation joints.

The structure exceeds surface development guidelines. The conditions are to require the owner to provide a plan to demonstrate how the structure will be managed during the mining process. The approval is granted based on research and development is to be undertaken to enable a report on the performance of the structure during mining to be provided to the Mine Subsidence Board.

The Board Members advised that the conditional approval is without prejudice and is not to set a precedent for other 3 storey development in the area or in any way to suggest the existing 3 storey structure, constructed without approval, was acceptable to the Mine Subsidence Board.

The item is not included in the Agenda Papers and was tabled at the meeting for consideration by the Board Members.
