- Tol rang to say he had been terminated by R.A.M.C. with Red Corp sighting breach of employment terms related to getting money from a supplier and referring to an email from my A.L.T. on 12-12-12 related to my loan of money to him. He was in a highly emotional state & crying on the phone, and could not expand.

- 7:00pm I immediately called Phillip Johns to inform of the event and the allegation and the implication in myself ~~stealing~~ and possible fallout for V.H. I explained in brief my full and only motivation for lending money to Tol was as a friend for his use in issues & difficulty his daughter was ^{for} facing. Phillip recommended a discussion with Payne Dale (Legal) 14/2/13

- 8:00pm I spoke to Tol to inform him about my need to inform V.H. more formally. At home I then penned a formal letter to Phillip in preparation for a discussion with Payne. 4:30am (Also notes on next page).

- I met with Payne Dale in his office for a discussion on the topic. 15/2/13

- Payne advised not to send the formal letter yet and that it should just be discussed first.

- We discussed if there was a need for a formal witnessed statement and Payne indicated that he would take notes and if it was decided later these notes could be drafted into a formal statement for me to sign.

- Payne also indicated that may/may not be a need for me to seek other personal legal advice, but If he thought there was a need, he would discuss with Murray McCandle (knows legal) and let me know on fact lets go recommend a suitable legal rep.
