- GUSHEH B: He was a boss, he was ah the Managing Director at the time of company and I was a Project um Engineer residing at the job site and my office was in near Berowra in Hornsby on the road side. And um we we didn't have ah for first few years we didn't have any any direct
 15 communication or anything with each other, I knew he was he was about four levels, five levels higher than me.

WIGHTMAN: Yes.

GUSHEH B: He is the boss.

WIGHTMAN: Okay, so in the 28 years in the 28 year period so um towards the end of your time with Abigroup and towards of um the end of Mr Cassidy's time were you guys, were you friends? Did you socialise outside?

GUSHEH B: Its in John's nature, it wasn't with me it was yes to answer your question I was friend, John was friend with thousand people.

WIGHTMAN: Hmm.

	WIGHTMAN:	And we are here to talk about information that we have received that
		you were engaged to do something at the hotel. Do you remember
		what it was that you were engaged to do?

5 GUSHEH B: It is ah I don't remember the how the the nature of the the the proposal came but it is John knew that I'm retiring and and I might be just interested in some of that activity. He asked me one day to go to Armidale to said he's ah I don't know at that time and I don't, I think it was 2008 or 2009 or 2007 in that area –

10 WIGHTMAN: Hmm.

GUSHEH B: He asked me to go there and ah he's he he he either said he had purchased that hotel or he is in the process of purchasing that hotel or or whether he is going to purchase it. When I said your email I gathered that the hotel was owned by Darrell, which I didn't know 15 until I read your email. I didn't know that - anyway he didn't tell me the full detail but he asked me, he wanted to know my opinion because ah I I work on construction sites and hands on he he – the hotel was very run down absolute eh dilapidated place, he wanted to know what is the best way to turn this hotel into the ah the convent - because he 20 was running the University at the time and people that were coming to meeting they didn't have ah meeting place something like that -WIGHTMAN: Yes.

GUSHEH B: - he wanted a place with the room and meeting places to have seminars and thing like that you know (inaudible).

25 WIGHTMAN: Yep.

GUSHEH B: And he asked to come there to look at the hotel and and give him my opinion what is in construction wise what is the best way to fix up that hotel.

WIGHTMAN: Okay.

- 5 GUSHEH B: I got on an airplane that day very early in the morning, I went Darrell was supposed to come with us that day. I went to the Armidale two times and and that time I don't know remember whether it was that time or the time after that Darrell um missed the aeroplane, he didn't get to there on time –
- WIGHTMAN: Yes.
 GUSHEH B: even though I got his boarding card when it was one of those ah local aeroplanes, I think it was either Qantas Country or Rox (inaudible) –

WIGHTMAN: Rex or Qantas?

GUSHEH B: Yeah Rex, Rex, Rex.

WIGHTMAN: You think it was Rex that he flew?GUSHEH B: I think it was Rex, I think. I went down there but Darrell didn't show,

didn't come I flew and as it happened that Darrell that day he overslept he came with the flight after of day. And I went and I looked at the holiday and I tell you before you ask question I tell you what is in my mind so freely –

WIGHTMAN: Please do, yeah please do.

GUSHEH B: - and and um Darrell when he came in he went with other business which I don't know what it was, it was um I really don't know. I went to the hotel and we looked at, the hotel had some managers working there, couple of people working there at the time and I looked around the hotel was a disgrace, disaster and the main thing I told John I remember is that ah the hotel didn't have any parking and I said - how you want to run a convention centre without the parking, you know that people come here where are they going to park. The hotel

was a was a mess and and I told them that you have to get ah you have to look at it to some design and and find a do the parking in and get the council permission and go from there. That was the whole ah – so then in the middle of the day, or I don't know if it was that trip or the one after I separated from John, John had some business prop with his running of the thing. He went through with his business and I went around around the main street, I never been around that before, I went around the street to see what sort of ah structure it is and what if you want to find a car park where there is gen eh eh a public car park or not and and gain my information about the situation and it was about I think it was about two three o'clock or four o'clock in the afternoon I flew back –

WIGHTMAN: Okay.

GUSHEH B: - on the first day. On on on the second day it was I went there to to see then on by that time it is my retirement was was coming in and I went to see whether there is any further development in the project or not, I went there and it was exactly the same the same as it was before. I didn't get involved in John about any of the details of the nature of running the business –

WIGHTMAN: Sure.

GUSHEH B: - but the only thing he talked about, we talked we went to the room we say he said the best way to do the room, we talked about he said yeah how we can fix it up temporally so it can be used, but I kept telling him without the car park you cannot use this place. And and ah talked about in general how we going to fix the hotel and um I flew back and I told

him that he has to get the plans, he has to get the designers and get the get the specially design something with a car park get council permission and after he got these things let me know and I might just go and and and try and work with him, I didn't tell him that I would or not. Then I came back and talked to my wife and realised that I am retired I am not going to work even though if he offers me to work and I am not going to go there. But in general I tell you this thing I am willing this evidence in front of anyone.

WIGHTMAN: That's fine.

GUSHEH B: In my opinion John and Darrell both of them, to my extent of knowledge are very nice people and I am willing to back up and I am willing to give evidence and I am willing to be a witness to today.

WIGHTMAN: Very well, your trip up to Armidale there is two trips. One trip you talk about getting on a plane up to Armidale, Darrell Hendry missing that flight -

20 GUSHEH B: Yep.

WIGHTMAN: - but you go up and meet with John. Look, how much notice did you have of heading up to Armidale? Was it something that was arranged weeks prior, a month prior or would you just get a phone call in the morning saying get to the airport?

GUSHEH B: I don't remember, I I think I don't remember it maybe it wouldn't be –
 it wouldn't be more than three, two or three four days I don't think so –
 WIGHTMAN: Okay.

GUSHEH B: - so this is what ah ah whether it's called the convention or it's called a gathering or it's called or whatever it's called I don't know, that was the nature of thing he was thinking to to turn. I think he was thinking 25 he wasn't adamant at the time but he was he was tossing ideas around of what to do. Sure. Can I ask um in relation to your engagement um were you paid a WIGHTMAN:

GUSHEH B: - when I talk about Darrell I mean Darrell.

WIGHTMAN: Fine. Can I ask you more about your interactions with Darrell? Did

you talk to Darrell about the Tattersalls Hotel?
