ASSISTANT COMMISSIONER: Please be seated. Yes, Mr Downing.

MR DOWNING: Thank you, Commissioner. The next witness will be Mr Norm Cerreto.

MR NEIL QC: Commissioner, while Mr Cerreto is coming forward can I indicate that he would take an affirmation and I've explained to him the effect of section 38 of the Act and he would ask for a declaration.

- ASSISTANT COMMISSIONER: Yes, thanks for that. Take a seat there, Mr Cerreto. Pursuant to section 38 of the Independent Commission Against Corruption Act, I declare that all answers given by this witness and all documents and things produced by him during the course of his evidence at this public inquiry are to be regarded as having been given or produced on objection and there is no need for the witness to make objection in respect of any particular answer given or document or thing produced.
- PURSUANT TO SECTION 38 OF THE INDEPENDENT

 COMMISSION AGAINST CORRUPTION ACT, I DECLARE THAT ALL ANSWERS GIVEN BY THIS WITNESS AND ALL DOCUMENTS AND THINGS PRODUCED BY HIM DURING THE COURSE OF HIS EVIDENCE AT THIS PUBLIC INQUIRY ARE TO BE REGARDED AS HAVING BEEN GIVEN OR PRODUCED ON OBJECTION AND THERE IS NO NEED FOR THE WITNESS TO MAKE OBJECTION IN RESPECT OF ANY PARTICULAR ANSWER GIVEN OR DOCUMENT OR THING PRODUCED.

ASSISTANT COMMISSIONER: Yes, Mr Downing.

MR DOWNING: Thank you, Commissioner.

Mr Cerreto, could you please state your full name for the Commission? ---Norman Cerreto.

10

And your date of birth?---20/12/75.

And your address?---....

And you're a resident of the Ryde Council area?---Yes, I am.

And you have a number of business interests situated in the Ryde area? ---Yes, I do.

- Commissioner, there are a bundle of documents that I'm going to be referring to Mr Cerreto during the course of his evidence. I'll tender them now and can I indicate for the record there are, first part of the are some emails between Mr Cerreto and Councillor Petch. There are then some bank account statements for Delitalia Gourmet Foods and for the Weekly Times and then finally another email from Councillor Petch to Mr Cerreto. I'll provide and we'll have copies made available to the interested parties, Commissioner.
- ASSISTANT COMMISSIONER: Yes. That bundle of documents in respect of Mr Cerreto will be exhibit 62.

#EXHIBIT 62 - BUNDLE OF DOCUMENTS IN RELATION TO MR CERRETO

MR DOWNING: Thank you, Commissioner.

- Now, Mr Cerreto, correct isn't it that one of the businesses that you operate is Delitalia Café and delicatessen in Coxs Road - -?---Yes.
 - --- North Ryde? And is that through a company Delitalia Gourmet Foods?---Yes.

And is the land that that operates from, well first of all could you tell us the address that that operates from?---144 to 148 Coxs Road.

And is that land owned by a different company?---Alramon Pty Limited.

Is that A-l-a-r-a-m-o-n?---Yes.

ASSISTANT COMMISSIONER: Mr Cerreto, do you mind moving a little closer to the microphone, thank you?---Sure.

Thank you.

MR DOWNING: And does that company Alramon Pty Limited do something else besides own the land?---No.

All right. Separate to Alramon is there another company in which - I withdraw that. Are you a shareholder and director in Alramon?---Yes.

And is there another company that you have an interest in Senaca Projects Pty Limited?---Yes.

And again are you a director and shareholder?---Yes.

20 And what does that company do?---That just owns a house.

Is that a house - - -?---That's a house out - - -

Is that at 12 and 14 Hunts Avenue?---Yes.

In which suburb?---Eastwood.

And, actually just coming back to Alramon for the moment and the building in which Delitalia operates from has that, has the company owned that land for some time?---Yeah, I think for 20, 30 years, yeah.

And was there a period approximately 10 years ago where the company put in a development application and made some alterations to the property? ---That's correct.

In order to configure it as it currently is with shops and offices?---Correct.

Or shops, cafes and offices I should say?---Yes.

40 So that, there was a DA put in, approval obtained and some works were done?---That's right.

And can I ask the offices upstairs do you use that partly for your own purposes?---Yes.

And is part of it leased out to Mr Laface the solicitor?---Yes.

And he operates an office from there?---Correct.

All right. Well coming back I think - Senaca Projects is that, it only owns the land in Hunts Avenue, Eastwood?---That's correct.

And has it put in some applications to develop that land?---It put in an application I think '09 I think or '10 for a DA.

And was it approved?---Yes, it was.

But have the works not been done?---The DA expired.

Right, okay. Now is there another company which you have an interest AGG Group Pty Limited?---Yes.

And is that a company which is a form of joint venture?---A form of joint venture. Me and Simon Goubran are a director of that company.

Right. And Simon Goubran being John Goubran's son?---That's correct.

And does the company, sorry. And are the shares hold, owned, in that company owned by you for one part?---My family trust.

Your family trust company. Sorry, you need to verbally respond rather than just nod?---Oh, yes,. My, my family trust.

And is that a company?---Yes.

And what's the name of the company?---Alramon.

30 So that's Alramon Pty - - -?---Yes.

- - - Limited? And - - -

ASSISTANT COMMISSIONER: I'm sorry, Mr Cerreto, you're not really being heard very well. Can you speak up and please try to speak above the microphone?---Sure.

Thank you.

40 MR DOWNING: It just helps to get closer. I had the same difficulty, Mr Cerreto?---My stomach's in the way.

Now so - - -?---Is that better?

--- Simon Goubran also had an interest in, in AGG Projects?---Yeah, he's a director.

Oh, sorry. The AGG Group Limited isn't it? I don't want to get the name wrong?---The AGG Group, yeah. AGG Group I think, yeah.

So does, does he or does the company that he has an interest in also own some of the shares in the AGG Group Limited?---Yes, it's his family trust.

Okay. And what does that company do, or what does it own?---It owns a property at Concord, 38 Burton Street.

And is that a property with the company tends to develop?---Ah, no. It's run as student accommodation to rent.

Okay. But no intention to develop the land?---At this stage, no.

All right?---But in the future you never know.

All right. Now, I think I asked this already but the café Delitalia, is that operated through a company, Delitalia Gourmet Foods Propriety Limited?---Yes it does.

20

And are you a director of that?---Yes.

And a shareholder?---Yes.

And is there another company in which you have an interest, Arthur Street Developments Propriety Limited?---Ah, yes.

And what does that company do?---Um, I think that might be just a holding company. Doesn't do anything.

30

Doesn't own anything?---I don't think so.

Doesn't undertake any activities?---No.

And what's it a holding company of?---Oh, we just set it up one day with a, we were going to purchase something in that name but we never did.

All right. And is there also an Arthur Street Facility Management Propriety Limited?---Yes. Yeah. That owns a block of land in Arthur Street.

40

In Arthur Street, which suburb?---Ryde.

Right. And are you a director and shareholder in that company?---Yes I am.

And is that land, is it a residential premises?---Residential block of land, that's all.

And is there a plan to develop that land?---No.

All right. Now, are you also, do you also have an interest in Salcorp Property Investments Propriety Limited?---Yes.

Is that a company in which you're a director and shareholder?---Yes.

And does that, can you tell us what does that own or what does it do?---It owns nothing. It's just another holding company.

All right. And then Salcorp Facility Management Propriety Limited?--That's correct.

Is that a company of which you're a director - - -?---Yes.

- - - and shareholder?---Yes.

And does that own anything or undertake any activities?---It does, it does fitout works, commercial fitout works and it also owns another block of land in Ryde.

20

And where's that located?---Um. in Arthur Street.

Is it adjoining the loan, the land that the Arthur Street company owns?---Ah, there's a road in between it.

All right. So is there any plan to have those two blocks being developed?--- At this stage, no.

And do you have an interest in Cerreto Investments Propriety Limited?--30 Yes.

Are you a director and shareholder?---Yes.

And what does that company own or do?---Nothing.

Does it - - -?---Doesn't do anything.

All right. Now, is it the case that across the road from Delitalia in Coxs Road there is another type of shopping centre?---Yes.

40

And is that a shopping centre which you understand is owned by a family called the Bietola family?---Oh, not just by them, but yes.

Them and others?---That's correct.

Is all, is it partly owned by Mr Fazzolari?---Yes.

And is it the case that the landowners, being on your side of the road, your company, Alramon and on the other side of the road, is it owned by a company, the shopping centre across the road?---Enrico Bietola Pty Limited.

How do you spell the first name?---Enrico.

Oh, E-n-r-i-c-o?---Yes.

Did those two companies, that is Enrico Bietola on one side of the road and Alramon on your side of the road get together and form a landowners group for the purposes of creating a master plan?---Um, I was invited to on behalf of Council.

Right. And can you tell us roughly when that was?---Towards the end of '09 from memory.

And was the idea that the, well can you explain to us what you understood the purpose of creating a master plan was?---Oh, well Council wrote to us to, for the landowners to get together, which included the church across the road and Council, to come up with a blueprint for the next 20 years of the future of Coxs Road.

And was it for the purpose did you understand, to have the Local Environmental Plan for the area revised?---Yes.

And, so do you, your company, Alramon and Enrico Bietola Propriety Limited then cooperate for the purposes of having a landowner's master plan created?---Yes. Along with the church.

30

Along with the church. And can you tell me when was that that the landowner's master plan was brought into existence?---Oh, somewhere along the lines of 2010.

In 2012 were there particular events happening in respect of the - - -?---It was the public exhibition period.

And by that point was there one master plan that had been created by the Coxs Road landowners?---Yes.

40

Being your company, Alramon and Enrico Bietola?---Yes.

Was there also a competing Council master plan?---Yes.

And were they both up for the public exhibition?---Yes.

And was part of your master plan, that is the landowners' master plan to redevelop the Coxs Road area on both sides of the road?---Yes.

To put in certain new facilities?---Correct.

So there would be shops?---Yes.

Restaurants?---Yes.

Residential units?---Yes.

10 A footbridge?---Yes.

20

And other community facilities?---That's correct.

And was the idea that it would be redeveloped, that is both sides of the road would be redeveloped to put in those facilities?---One day.

And that between your company Alramon and Enrico Bietola then the commercial part of it, that is the shops, restaurants and units would be rented out or sold?---Well, the master plan's just an idea, it had a lot to go through before - - -

Oh, I understand it was a long-term plan?---Yeah, yeah. Ultimately, maybe within 15, 20 years, yeah.

Okay. Now, can I ask you about your relationship with Councillor Petch, he's someone you've known for many years?---Yes.

And would you count him as a friend?---Yes.

Can you tell me how many years back does your relationship with Councillor Petch stretch?---When I was a child, maybe 30 years.

Right. And is he someone that you speak to regularly?---Yes.

Is he someone that you meet with regularly?---Oh, every now and again, yeah.

Is he someone that comes to your café Delitalia from time to time?---Yes.

And I take it you talk about some matters that have nothing to do with Council?---Yes.

You also talk about Council matters from time to time with Councillor Petch?---From time to time.

And are you also familiar with John Goubran?---Yes.

Now, can you tell us how long you've known him?---Oh, I've known John for maybe 10 years.

And is he someone who is a property developer in the Ryde area as well? ---Yes.

And have you - you've told us - - -

MR NEIL QC: Well, Commissioner, could I just take an objection in that that seems to assume that Mr Cerreto is a property developer. Now his evidence is not to that effect and there may be some importance on the point, I don't know, but I just want to draw my learned friend's attention to the, to the point that I don't think he would concede he's a property developer.

ASSISTANT COMMISSIONER: Well, I think he has developed property hasn't he?---No.

So you've never built anything or - - -?---No.

20

Never had a DA before the Council?---I've had a DA before Council for five villas but it lapsed, I've never built anything.

I guess you were a prospective property developer.

MR DOWNING: Perhaps I'll just explore that. I understand my friend's objection. In respect of the premises on Coxs Road - - -?---Yes.

--- you've told us that some, was it about 10 years ago a DA was put in --- 30 --?---Yes.

--- and it was reconfigured if I can put it that way?---Not really reconfigured. We bought the property next door and we joined the first floor together with offices, that's all.

But you made some alterations what, on the first floor?---No, the second floor.

Did you make any alterations to what was on the land?---Ah, yes.

40

Sorry, on the ground floor of the land?---On the ground floor, yes.

And after those works were done you've told us that - - -?---We rented them out.

You've told us that a DA was put in for the purpose of doing those works? ---Yes.

The Council approved it?---Yes.

And at the end of it you rented out what, some shops and restaurants?---Just shops and offices.

All right. Thank you. Now, would you accept that that amounts to undertaking some form of property development?---Not really.

So you say what, buying land, making improvements to it and then renting it out doesn't amount to property development?---In my opinion it doesn't.

All right. I understand. Well, to your understanding is Mr Goubran a property developer?---Yes.

And do you understand that he has some interests, that is business interests in the Ryde area?---Yes.

And that he owns some land in the Ryde area?---Yes.

Are you aware of particular land that he owns on Victoria Road?---No.

Well, could you tell me what land you understand that he owns in the Ryde area?---I know he owns a property in Waterloo Road and a property - - -

Is that in Ryde, sorry?---Yes, yes, yes, and a, and a property in Eastwood.

All right. And where in Eastwood, is that Trelawney?---Yes.

Trelawney and Rutledge Street?---Yes.

30

40

Do you understand that he has, that he along with others own a particular strata property somewhere in Victoria Road?---No. College Street I do but not Victoria Road.

Does College Street meet Victoria Road?---Ah, I believe at some point, yes.

Right. Okay. And do you understand that the College Street property that you've referred to, is that a property you understand that Mr Goubran has been seeking to change the zoning so that he can change the use of the property?---I believe so, yes.

And, sorry, I asked you this before but I don't recall the answer, for how many years have you known Mr Goubran?---About ten years.

And how did you first come to know each other?---Through his son Simon.

Was that because you had business dealings with Simon or he was a friend?--Just friends.

All right. Now you also know Mr John Booth don't you, the editor of - - -?--Yes.

--- Weekly Times? And for how long have you known him?---Probably about twenty years.

Now he's someone that you've placed ads with from time to time?---Yes.

Have you known him prior to placing ads?---Yes.

So it's always been on the basis of your relationship as a customer who places ads?---And also he's been in the area for a long time. He's come through and shopped at our place.

Okay. So he's actually - - -?---A customer.

- - - a customer at your, your Delitalia business?---And previously a fruit shop many years ago when my father was there.

20

And were the ads that you've placed to do with the businesses the fruit shop and then Delitalia?---Yes.

And then more recently the Coxs Road landowners master plan?---Yes.

All right. Do you know Mr Anthony Stavrinos?---Yes.

Is he someone that you understand to be a publicist - - -?---Yes.

30 --- or a PR person?---Yes.

And how long have you known him?---About 12 months.

And in what circumstances did you first come to meet him?---I had a meeting with Bill Pickering and Bill Pickering advised me to use Anthony for the Coxs Road master plan as a publicist.

That is to assist you in having it publicised?---That's correct.

40 And did that, sorry, did that then lead to a series of ads being placed in the Weekly Times?---That's correct.

In order to promote the Coxs Road landowners master plan?---Yes.

Now, Mr Cerreto, do you recall becoming aware earlier this year that a complaint had been made against John Neish? Now you, I'll stop there. You knew John Neish as a former General Manager of the Council? ---Correct.

And you knew that he ceased his work as General Manager in early this year, early 2013?---Yes.

Do you recall some time early this year prior to his cessation of employment learning that a complaint had been made against him to the effect that he'd accessed pornography on his laptop computer?---Yes.

Can you recall who you first heard that from?---I think it was Ivan.

10

When you say Ivan you mean Councillor Petch?---Yes.

And can you recall and just in order to set the time frame around it do you recall that it was on the 8 February that Mr Neish finished up his employment?---I couldn't tell you that, no.

Do you recall seeing a media release around the time about him finishing up work?---I remember it was advertised, yeah.

Doing your best how did you first come to hear about it from Councillor Petch?---I think we, he came and saw me once and said that they've found porn on his computer.

All right. What, in person?---Yes.

And had you discussed Mr Neish and his employment with Councillor Petch previously?---Not particularly, no.

Well did you have a view about Mr Neish?---I did.

30

And what was that?---I thought they acted appropriately in sacking Mr Neish back in June.

Right. Well prior to them sacking to Mr Neish did you have a negative view about him as General Manager?---Not so much a negative view of himself, no, but the way he handled the situation, yes.

Do you mean, when you say the situation are you referring to the, the Ryde Civic Precinct redevelopment?---Correct.

40

And had you spoken to Councillor Petch about that?---Oh, yes, we did.

Well you're aware weren't you that he was very much opposed to the Ryde Civic Precinct redevelopment?---Yes.

Had he ever expressed to you the view that Mr Neish was actively promoting it?---Yes.

And had he ever expressed the view that because Mr Neish was actively promoting it he wanted to get rid of him?---Not in those terms, no.

You don't recall him saying that at all?---No.

So you say you recall what Mr, Councillor Petch coming to see you and telling you about the discovery of pornography on Mr Neish's - - -? ---correct.

10 --- computer? And was that before Mr Neish finished work?---I don't recall.

All right. Well can I ask you first of all to listen to a particularly piece of audio which will be played, now the transcript will come up.

20 MR DOWNING: Now, Mr Cerreto, you heard that call then and I take it you saw the transcript in front?---Yes.

Do you accept that's a phone call between yourself and Councillor Petch?---Yes.

The date on the transcript is 1 February, 2013 and the time is 8.35 in the morning?---Yep.

Does that assist you to recall now that that was the time at which Councillor 30 Petch - - -?---Yes.

- - - telephoned you? Commissioner, I tender the audio and the transcript.

ASSISTANT COMMISSIONER: That will Exhibit 63.

#EXHIBIT 63 - COPY OF AN AUDIO CASSETTE AND TRANSCRIPT OF A TELEPHONE CONVERSATION BETWEEN MR CERRETO AND COUNCILLOR PETCH ON 1 FEBRUARY 2013 AT 08:35:09

MR DOWNING: Now, to the best of your recollection was that the first time at which you heard about the discovery of the material on Mr Neish's laptop?---Um, from my recollection it was. But possibly it was mentioned before. I can't remember.

40

Well when you say mentioned before do you think there might have been an earlier conversation with Councillor Petch?---Possibly, but I'm not, I can't recall.

But you, you believe that it was him who revealed it to you the first time?---Correct.

Now, in the conversation Councillor Petch asked you whether you were going to be up there today. Was that a reference - - -?---To my work.

10

- - - to your understanding to Delitalia?---Correct.

And do you recall, or in the discussion Councillor Petch suggested that about half past 10.00 might be a time that he would be up. Do you recall if he came up that day?---No, I don't think I was there that day. That's to my recollection.

You don't recall seeing him at all that day?---Not to the best of my ability, no.

20

Do you recall being present at a time when Councillor Petch came up to the café and saw a succession of people?---No.

You don't recall being present when he sat down at the café with Robbie Patterson?---Not that I recall, no.

Do you know Robbie Patterson?---No.

A journalist for the Northern District Times?---No.

30

Do you recall, being present when he came and sat down with a lawyer, Mr Bryan Belling?---I don't recall that, no.

Do you know Mr Belling?---I've met him once.

So to the best of your recollection you weren't present at the café that day?-40 -To the best of my recollection, that's right.

Now, in the, in the phone call Councillor Petch reveals to you that someone has been found surfing the net for pornography?---Ah hmm.

And did you understand that was a reference to Mr Neish?---I did.

Now, Mr Neish wasn't actually named was he, in the conversation?---I don't believe so.

So you'd obviously been speaking with Councillor Petch beforehand about Mr Neish?---Possibly.

Do you recall now that there might have been a discussion before this point when Councillor Petch expressed the view that he wanted to get rid of him?---It's a possibility.

Do you recall after, you were aware weren't you in 2012 of the Supreme Court proceedings that had been commenced?---Yes I was.

And the injunction that had been obtained to prevent the Council in effect sacking Mr Neish?---Correct.

Do you recall Councillor Petch ever indicating to you that despite that injunction he was still looking for a way to get rid of Mr Neish?---Not really.

Now, in the conversation Councillor Petch indicated to you that he had the whole, leaving out the obscenity, the whole files?---Yes.

And I take it that matters to do with complaints against staff for inappropriate use of their computers, you'd understand that would be Council business?---Ah, not really.

What, would you think that it would be appropriate for Councillor Petch to be discussing that with persons who weren't part of the Council?---I thought if Ivan's able to discuss it he'd know better than anyone what he can talk about.

30

So you figured that if it was talking to you then it must be okay?---Yeah.

You didn't give any thought to whether he might be actually disclosing something that was confidential and internal to Council?---No.

Well, you indicated to him in the course of the conversation that you, you needed to get that in the right hands. I take it you meant hands that could make sure that this was made public?---No, I mean in legal hands.

40 So you were suggesting that he should see a lawyer?---Oh, I suggested he should, yeah.

Are you being honest in that response, Mr Cerreto?---I believe so, to the best of my recollection.

You laughed, you said, "God love you, mate, we've got to get that in the right hands."?---Mmm.

And you, you suggest that was a reference to wanting to get it into a lawyer, a lawyer's hands?---After I discussed that later on with him that's what I told him.

Well, I'm talking about the conversation here. What you were suggesting weren't you was that you were excited about the discovery of this and you wanted to get it into hands so that it could be used to damage Mr Neish? ---I don't recall it meaning that at all.

Well, when you laughed and said, "God love you, mate," what were you trying to express?---Just a bit of a joke.

You thought it was funny that this had been revealed to you?---Yes.

Can I suggest to you that what you meant was you wanted to make sure that this material was provided to people who could then use it in a way to publicise it and damage Mr Neish?---No.

Did you know Mr Stavrinos at this point?---Yes.

20

Do you think he might have been referring to Mr Stavrinos?---No, I don't recall.

Because he was someone you knew that would be good at publicising something like this, didn't you?---Not really.

Well, he was a PR person, a publicist wasn't he?---Correct.

You don't think you were referring to him?---No.

30

Well, Mr Cerreto, Mr - Councillor Petch in the course of the conversation says he'd show it to you and that he'd bring you a personal copy?---Correct.

Do you recall that he in fact did that?---Yes, he did.

So the copy that he gave you, was it a disc or was it a page with thumbnail pictures?---I think it was a disc and thumbnail pictures.

So you got both. Now, do you recall when it was that he gave you those things?---I think it was on the Sunday.

Well, do you recall 1 February, 2013 was a Friday, are you saying you believe it was on the weekend, a Sunday two days later - - -?---Correct.

CERRETO

(DOWNING)

- - - that he gave it to you?---That's right.

And did he come and see you at Delitalia then?---Yes.

And delivered it to you. Did you give any thought to whether this was something that you should have?---Not really.

You obviously weren't a Councillor?---No.

You're not a member of the Council staff?---No.

Did Councillor Petch indicate to you that, that the way he'd had this, the way he'd obtained this material was that there'd been a complaint made against Mr Neish by someone from the IT department?---On the Sunday?

Yes?---Yes.

10

So you understood it was a complaint against Mr Neish, the General Manager by another member of the Council staff?---Correct.

And did you give any thought to whether in those circumstances this was something that you should have?---No, I thought it was okay.

Is it the case that you didn't really care whether it was material that you should have?---Perhaps, yeah, but I was of the understanding that if, if Ivan was giving it to me he'd know what he can and can't give out.

You were just assuming that if Ivan was giving it to you then that's good enough for me?---Yeah.

What I'm suggesting to you is you knew at the time that this was confidential and quite damaging material that Councillor Petch was giving to you?---No.

30

Do you recall getting a SMS from Councillor Petch on the following day, that is Saturday, 2 February, 2013?---It's a possibility.

Well, I'll ask you to have a look at a document. Have a look at what's on the screen in front of you and you'll see that it's described as a SMS from Councillor Petch to you reading, "Hi, Norm, are you at Coxs Road this afternoon? I have the data we discussed. Regards, Ivan."?---Yes.

Do you recall receiving that?---No.

40

But do you, you say that you did receive the disc and the pictures you think on the day following this that is the 2nd?---I, I remember it because I think it was, he was coming from church.

I, I'm sorry. I think I confused the - sorry, it was Sunday 3 you said? ---Yeah.

So sorry, he was coming from church, on the way back from church - - -?

---That's what I recall, yeah.

--- he dropped off the disc?---Well he came into see me. That's what I recall anyway.

What, indicating that he'd just been to church?---Yes.

All right. I know you say you don't recall receiving this SMS but you don't deny it?---No, I don't, no.

Well tell me what do you recall discussing with Mr, Councillor Petch about his intended use of this material?---He was going to go off and get a legal advice.

Well he was going to get legal advice about what?---About what to do with the contents of the disc.

Do you recall if he indicated that he wanted to do, what he wanted to do was get a legal advice to confirm that it was genuinely material from, that Mr Neish had accessed?---Perhaps.

But do you say what - that you don't recall any discussion at all about, with Mr, Councillor Petch where he indicated an intention to try and get Mr Neish to resign because of this discovery?---I don't recall that conversation, no. I recall he was going to get legal advice as to his options.

Do you recall if Councillor Petch indicated to you that as well as trying to get Mr Neish to resign that he was, that there'd been a proposal that Dominic Johnson would resign as well?---No, I don't I don't recall that.

Do you recall if you ever got a message to that effect from Mr Laface the lawyer?---No, I don't recall that.

And you understand that he's a particular official at the Council?---Correct.

And that sometimes Mr Goubran communicates with you and asks that things to be passed on to Councillor Petch?---Perhaps.

MR DOWNING: Mr Cerreto, I wanted to ask you some questions about that conversation. You make reference in it to the source that Councillor Petch wanted and some water and that it was coming. Can I ask did Councillor Petch from time to time ask you to arrange deli items for him? ---Yes.

And did he ever pay for any of them?---Yes, he did.

He did. What in cash, by card?---Either or, probably cash.

Are you sure about that?---Yes.

20

And when he would come by and frequent the coffee would - sorry, the coffee shop would he sometimes not pay for meals or drinks?---Oh, I'd offer him coffee from time to time, yes, I would.

Now, in the course of the conversation he indicated, and this in the transcript, page 1 of 5, that he'd probably be up some time in the afternoon, "I'm dealing with, as you know, yesterday I sacked Neish"?---Ah hmm.

So do you recall that he had told you beforehand that that's what he was planning to do?---No, I don't.

So in seeing the words that he spoke in the conversation, "I'm dealing with, as you know, yesterday I sacked Neish," what, do you say you don't recall any discussion beforehand about a plan to get rid of Mr Neish?---Not particularly, no.

On reflection you can't recall him indicating to you some time between 1 February when he told you about the discovery of the material on the laptop and this point that he was going to use that as a means of getting Mr Neish to resign?---He told me he was going to go discuss his legal options.

Now you say, you recall also in the conversation that Councillor Petch indicated that he almost had the other fellow but he wanted 38 weeks' severance and that they'd laugh at him if he put that up. Do you see that at the bottom of the page?---Yes.

Did, did you understand that as a reference to Dominic Johnson?---Not particularly, no.

Well, in the course of the conversation you didn't ask him who he was referring to, you must have had some idea at the time I take it?---Not that I can recall.

Well, you see later in the conversation at page 4 of 5 towards the bottom of the page you actually say, "Good, good, fantastic, and see what we can do for that second one, huh."?---Mmm.

And Councillor Petch said, "Yeah." You said, "The second fellow." He said, "Yeah," Councillor Petch said, "Yeah, we will." You said, "All right, mate." You obviously had someone in mind because you were suggesting that with Mr Neish gone there was a second fellow you were hoping Councillor Petch might be able to deal with as well?---Mmm.

On reflection do you think that might have been a reference to Mr Johnson or was there someone else at Council?---It could have been Mr McCann, I can't recall.

Were you keen for Mr McCann to be gotten rid of as well?---Oh, not particularly but - - -

Well, looking, thinking back and remembering as best you can who did you understand Councillor Petch was referring to when he told you that he almost had the other fellow?---I, I, I was going to ask him in person.

Well, you didn't stop him at any point in the conversation and say who are you meaning did you?---No, I wasn't really interested.

Well, it would suggest given what was said later in the conversation that you had a pretty clear idea in your mind about someone that you were hoping that Mr, Councillor Petch might be able to get rid of as well? ---Perhaps.

So let's go through people - - -?---I can't recall who it was.

--- it might have been. Mr Johnson is someone that you were quite keen that would be gotten rid of at that point?---Oh, not quite keen, not really.

Well, he didn't say my strategy, he said "our strategy"?---Mmm.

Did - had there been occasions when you and Councillor Petch had spoken about his plans for instance to get rid of Mr Neish in order to prevent the Ryde Civic Precinct project going ahead?---It's a possibility, yes.

That's earlier in time?---It's a possibility.

MR DOWNING: Well, Mr Cerreto, you didn't say that's of no interest to me, Ivan, did you?---Sorry?

You didn't say that's of no interest to me?---I didn't on the phone, no.

You didn't say why are you telling me about this, I'm not interested, Ivan? ---He's very happy here with the information, I'm not going to burst his bubble.

ASSISTANT COMMISSIONER: And Mr Cerreto, towards the end of the conversation you yourself raised the second fellow again of your own volition?---Yes.

Trying to get rid of him?---Perhaps.

Well, that shows a level of interest doesn't it?---Not really, not in my opinion.

Well you weren't just responding to what he was saying, you yourself brought up again the topic of getting rid of the second fellow?---Not in my opinion.

Well it's not a matter of opinion you did?---Mmm.

Didn't you?---That's what - - -

You can read it?---Yes.

Well? So that shows a level of interest doesn't it?---Oh, for him, for Ivan yes, make him feel good but for me I had no real interest.

So you were just feigning interest to make him feel good?---Yeah.

MR DOWNING: Mr Cerreto, at page 3 of 5 at the top of the transcript Councillor Petch said words of, "So many bits of pieces I got to fill in that and then I was trying to get a hold of the other fellow John and let him know" and you said "Yeah" and you, Councillor Petch said "That I'd, I'd" and then you stepped into the conversation and said, "Oh, don't worry we were informed, anyway that's fantastic"?---Mmm.

Did you understand that he was referring to John Goubran?---Possibly.

And in indicating we were informed anyway what were you indicating you and Mr Goubran had been informed of?---Perhaps the news of Neish resigning.

Right. Do you think it might have also involved the, the news of why Mr Neish had resigned that is the discovery the material on his computer? ---Perhaps.

Thinking about it now do you think there might have been a discussions where you told Mr Goubran about that?---Perhaps.

30 And you'll see Councillor Petch said, "And I asked Stefano to" you said "Yeah", Councillor Petch said, "Update people what was happening." So do you recall if Mr Laface had updated you or Mr Goubran to your knowledge about what was happening with Mr Neish's employment?---I don't recall that night he was saying anything regarding that. Possibly that morning there was. He used to pass through my work very early on the way to his work so maybe - - -

Sorry, who's that Mr?---Stefano.

40 Laface?---Yeah.

Did you understand that Councillor Petch - I withdraw that. Were you indicating that the person coming in half an hour for a coffee with you was Mr Stavrinos?---Possibly, I don't recall.

Well who do you recall you met with that morning, do you have any recollection now?---I think it was Laface.

Well, Mr Laface would he someone that would write a press release?---He could possibly help him do a proper one legally.

Well normally the person that you used for press releases and publicity related matters was Mr Laface wasn't it?---No.

I'm sorry, I meant Mr Stavrinos?---Yes.

20 So looking at what you said at the time do you think it might have been that it was actually Mr Stavrinos who was coming - - -?---It's a possibility.

And Councillor Petch responds without again naming the person saying yeah, he was with me until half past 1.00 this morning. Did you understand at this time that early February this year that Mr Stavrinos was doing some work assisting Councillor Petch?---I wasn't aware, particularly, no.

Mr Cerreto, would you agree with me that on reflection the material that Councillor Petch was providing in respect of the discovery of material on Mr Neish's laptop was confidential and sensitive material?---No.

You still don't accept that now?---I don't.

And, and as, as you answered before you do say that on the basis that well if, if Councillor Petch was telling me than that must be okay?---Well I've got no understanding of what confidential is so Ivan's been a Councillor for over what, 35 years he should know what he can and can't give.

Well just on what's confidential when, you understand don't you that when for instance an application for a development goes to Council the Council looks at it and considers it?---Correct.

It gets advice from internal Council staff?---I assume so.

Well you assume that there'd be town planners and people of that nature who would be looking at it and giving advice to the Council about to approve or not approve?---Correct.

And you understand don't you that that advice that's received by individual Councillors from town planners is not normally something that's released to members of the public?---Sorry?

That would be something that wouldn't normally be released to members of the public?---Oh, I don't know, maybe it would.

Well I'll deal with another example. For instance when Council goes to tender for things like say garbage services they would get a number of tenders. You'd understand that wouldn't you?---Perhaps, yes.

And that Council would then look at them and compare them and decide, try and rate them?---I don't know how they do their things.

Well you understand about tenders don't you? I mean you do building fit out work, presumably from time to time you need to tender for work?---No.

Do you say you have no understanding what a tender involves?---No, I understand what a tender is but I don't really understand what's involved on behalf of Council.

Well, well let's just deal with the basics. A tender would normally involve asking a number of people to express an interest in perhaps competing for a job?---Yes.

And then once the tenders are all in looking at them and working out which one you think is best?---Yes.

And you'd expect wouldn't you if Council was for instance looking at say a tender for waste services it would get tenders from different parties?---Yes, yes.

What I'm suggesting to you is that the material that Councillor Petch had released to you involving a complaint against Mr Neish by someone from the IT section - - -?---Ah hmm.

- - - related to the use of his laptop was something which you understood was confidential?---No.

Now it's the case isn't it that at various times over recent years Councillor Petch has forwarded you by email communications in respect of Council business?---Yes.

Now can I ask you to have a look at Exhibit 62 which is I think in front of you and open that to, well, sorry. Before I get you to open it, are you on Facebook, Mr - - -?---No.

No. Can I ask you to look at page 1169 which should be the first page. Were you previously on Facebook?---My wife might have put me there but no, I will not, never been on Facebook.

Well do you see that at page 1169 there's an email from Facebook to Councillor Petch indicating that Norm confirmed you as a friend on Facebook?---Yes, yes.

And just in terms of who Norm is it's got the name Norm Cerreto?---Yes.

And it refers to below to viewing Norm's profile. Do you see say that you had nothing to do with - - -?---No.

- - - you having a Facebook - - -?---I wouldn't have a clue about Facebook.

Did your wife tell you that she confirmed Councillor Petch as a friend on Facebook?---No.

Now, Mr Cerreto, could I ask you to have a look at page 1172. Tell me when you've got that open. Do you have that open?---Sorry, which one was it, sorry?

Sorry. Top right numbers, top right - - -?---Yes.

--- corner of where the numbers are and it's page ---?--Yes, yes.
--- 1172. And do you see at the top of the page that's an email from Councillor Petch to, to you with a hotmail address of 26 May 2011?---Yes.

At 17.38?---Yes.

Now do you recall whether Councillor Petch has more than one email address?---I think he may have two.

So he has a work one for his Council duties obviously. Do you know if he had a separate a hotmail address or - - -?---For memory he's got two, yeah.

Do you know when he would send you emails of this type where they would come from?---No.

Can't recall?---No.

All right. Now this is an email of 26 May 2011 to you?---Yes.

And Councillor Petch says, "I just received this email from Terry Dodds." Now did you know that Terry Dodds was the Group Manager of Public Works?---Yes.

And do you recall receiving this email from Councillor Petch?---Yes.

And who's Antonio Salerno?---He's a friend of mine.

Do you think it might have been that Antonio Salerno approached you and said, "Can you get some material for me"?---No.

So Councillor Petch approached you and indicated that he wanted you to send this on to Antonio Salerno?---Correct.

All right. So were you meeting with Mr Salerno that day?---No, they just turned up for a coffee and Ivan, as usually we do we'll be sitting at the front having a coffee.

Right. Well, can I ask, you say that Councillor Petch indicated that Mr Salerno wanted to know how to put a tender together?---Not Mr Salerno, Mr Salerno's friends.

MR NEIL QC: I object. He didn't say that.

MR DOWNING: I'm sorry.

MR NEIL QC: Well, I think my friend understands what I'm saying. The witness said that it was someone in the group who wanted it. And Petch was going to send it to the witness to send to Salerno because Salerno was one of the group, not that Salerno wanted it.

30

MR DOWNING: I'll clarify that, Commissioner. Did you understand from what Councillor Petch was saying to you that he wanted you, he was going to forward you an email to do with waste and - - -?---Yep.

- - waste disposal and waste collection, he wanted you to send it on to someone - -?---Correct.
- - and was that person Mr Salerno?---He didn't say Salerno. He said, "Forward it on to the young fellow over there so he knows how to put a tender together."

And - - -?---And I didn't know who this young fellow was so I just gave it to Tony and that was it.

Did you forward it on or print it out and give it to him?---I forwarded it from my phone.

So the young person that, that Councillor Petch was motioning towards, you didn't know who he was?---No, not particularly.

Did you ask Councillor Petch who it was that it was to go to?---He said, "The young fellow over there."

Did you ask Mr Salerno who that person was?---Yeah I did.

And what was his name?---Alf.

Alfonso?---Yes.

All right. So Alfonso wanted to have this material so he could know how to put a, a tender together?---Correct.

Now, so you don't, you didn't know Alfonso?---No.

So you didn't know for what purpose Alfonso might want this material?---From what I understood it was for an assignment of some sort or a university, putting together a tender, that's all.

Well, you were, but how did you say you understood that it was for a university assignment?---Well Ivan indicated to me that he needed a hand to know how to put tenders together.

Well, that could have meant couldn't it that it was for the purpose of him actually putting a tender together?---No.

Well, on what basis can you say that that wasn't the reason?---It was, it was basically he wanted to know like, a generic way of putting together a waste tender.

You say that Councillor Petch said to you, "I'm going to send you an email and I want you to send it on so it gets to that young fellow over there because he wants to know how to put a tender together"?---That's my recollection.

Well that could mean couldn't it that he's interested in actually putting a tender together for a particular business?---I didn't get that feeling, no.

40

Well, you didn't make any inquiry about it did you?---No. I didn't care.

You didn't care. So the material you received in this email on 26 May, 2011 - - -?--Ah hmm.

- - - you would understand that would be commercially sensitive material from Council wouldn't you?---Not really.

So you're told about when the contract is going to expire in the email and what the actual cost to Council is for disposal and collection?---I don't know, I didn't read it. If that's what it says that's what it says.

So what, you took no interest in the content of it?---Couldn't care less.

All right. Can you then go to page 1173?---Yep.

And you'll see that's another email from Councillor Petch to you of 29 September, 2011?---Yep.

Sorry, the date this time being 29 September, so later in that year, at 17.37. And if you look at that page and the next page do you see that in the email Councillor Petch has said, "I've just received this information as an email. Would you please read through it and let me know if that's what you need"?---Ah hmm.

And then he goes on. Now, do you recall you'd actually asked Councillor Petch to, to send you this material?---Yeah, I remember because um, Ivan

20 had met a few times afterwards at my work with these people and apparently the young fellow had asked for a break up of some rates of some sort. Ivan said to me, "Mate, can you just shoot me an email to remind me of this so I can get the information the young fellow needed."

So he wanted a break up of rates?---Of some sort, yes.

Would that tender suggest to you that Mr Alfonso's interest might have been more than perhaps putting together a university assignment but actually to look at, I don't know, tendering for the waste and disposal contract at Council when it might come up?---No it didn't. I didn't particularly think of anything.

Didn't cross your mind?---No.

So you'll see that in this email Councillor Petch had obtained from Terry Dodds, the Group Manager, Public Works some material in respect of the particular waste collection and disposal at the Council?---Yeah, I can see that's there.

40 Do you see that?---Yep.

So that there was a Council resolution to accept a particular contract, a WSN Environmental Solutions on 18 October, '05 and the report to Council regarding a tenders received and the letter of offer?---Yes. It's all there, it's there.

And that was something that was, they were all attached as documents to the email weren't they?---I'm sure they were, yeah.

And you forwarded them on?---Yes.

And so Councillor Petch had asked you if you could read through it and let him know if that was what you need?---Ah hmm.

You say that that was not something you had any interest in at all?---No. Nothing. I didn't even read it.

Do you recall if you actually confirmed to Councillor Petch that what he'd sent you was what you needed?---No, after this we never discussed it again.

Never again. All right. Can you go to the next document, 1175. And do you see Councillor Petch on 3 November, so later in that year again, sends you an email? And do you see it seems to attach the same documents, that is tender reports - - -?---Ah hmm.

- - - waste collection disposal tender resolutions, a letter of offer, and it's again comes originally from an email that Terry Dodds has sent to
 Councillor Petch?---Yes.

So it looks like, do you recall if, I'll withdraw that. Do you recall if you asked Councillor Petch to send it through to you again?---No I don't.

Do you know how it came to be that he sent you this email attaching the same documents in September and then again in November?---I don't.

Is it possible that you asked for him to send it again?---I don't recall. I don't think so.

30

Well, look at the documents that follow. You see at 1177 there's an actual report?---Are they the attachments?

Look at 1177?---Yep.

There's a report from the Group Manager, Public Works. And do you see there's then, if you go through the pages a report to Council setting out the different tenders that had been received in respect of the waste collection and waste disposal identifying the companies that had put in tenders?---I don't know, I - - -

Look at 1180?---1180. I'm sure they're all there.

And do you see a recommendation at the bottom of 1183 about who the particular contract should go to?---Yes. Is this back from 2006?

Ah, you'll see the - - -?---2005, yeah.

- - - document is 2005?---Yeah.

So that was the actual waste contract that was in place at that time?---Yeah, okay, yeah.

And you'll see at 1185 there's a report from the Group Manager, Public Works again setting out the different criteria by which the tenders were to be judged, look at 1186, the reference there to pricing being 40 per cent, technical matters being 30 per cent, environmental matters being 20 per cent and social matters being 10 per cent and again at 1188 there's the recommendation from the Group Manager and the General Manager about who the contract should be awarded to. Now, if you look at 1191 and 1192 you'll see there's the actual letter of offer to the successful tenderer back in 2005?---Yes.

So this is an email you got receiving those documents as attachments for the second time?---Okay.

Did you look at them?---No.

20

You didn't have any interest?---No.

Mr Cerreto, are you making an honest attempt to answer these questions? ---Yes.

Would you accept onlooking at the documents that these were confidential and commercially sensitive documents from Council?---Oh, if Ivan had forwarded them to me I would assume they were all okay.

30 So if Ivan sends you anything then you assume that it's all okay?---Yes.

So is it the case you don't feel the need to look at them at all?---They're not confidential to me.

Well, on the basis that anything that Ivan sends to you or says to you isn't confidential?---Not particularly, no.

Well, sorry, when you say not particularly do you say you give no thought at all to these issues because if it comes from Ivan that's good enough?

---Well, they're not confidential to me. None of these emails are confidential to me.

Explain what you mean by that please?---Well, what's confidential about this document to me? If Ivan is, Ivan should know what he can and can't send me, I'm assuming he knows what he, what he's allowed to do.

You'd understand wouldn't you that if different companies were quoting for, or I withdraw that, tendering for waste disposal and waste collection

contracts, knowing for instance exactly what the criteria by which Council were judging and the prices different tenderers had put in and why one bid was successful and another wasn't, it would be very advantageous information to have available?---Well, I'd assume this is all public, on public record. Any contract that Council would enter into would be on public record wouldn't it?

On what basis do you assume that all of this material, that is internal reports making recommendations about who the contract should be awarded to is public information?---I would assume it was.

Because Ivan gave it to you?---Yeah.

All right. And if you then go ahead to page 1194 you'll see it's another email from Councillor Petch to you, this time it's 16 November, 2011? ---Yes.

And do you see this time Mr Dodds has forwarded it to Councillor Petch which he then forwards on to you - - -?---Yes.

- - - specific information about the 2006 rates?---Yes.

And the particular component of rates, if you look at the bottom of page 1194 going to 1195 that relate to garbage collection?---Yes.

General clean up and green waste clean up. Now, this is a document that didn't require any - sorry, I'll withdraw that. This was an email that didn't require you to open any attachments did it?---Oh, I don't know.

Well, if you look at it the actual information is set out in the email itself, that is the information about the particular components of 2006 rates that referred to garbage, general clean up, green waste clean up?---It looks like that, yeah.

And do you see the words in capitals and in bold, "Commercial in confidence"?---Ah, yes.

Now is this again material that you forwarded on to your friend? ---Possibly, yes.

Mr Salerno?---Possibly, yes.

On the understanding that he was going to then send it on to Alfonso? --- That's correct.

Did you at this point pause and wonder about the nature of the university assignment Alfonso was doing?---I didn't think, give it two thoughts because I didn't really care.

Mr Cerreto, you're not giving honest responses to these questions are you? ---I am.

You would understand wouldn't you looking at these documents as you did in 2011 that what was being sent through was very sensitive and commercially, commercially confidential information about the Council's waste collection contract and waste disposal contract?---I didn't read it.

Well, you understood what, that Alfonso was doing a university assignment to do with, something to do with putting together a tender?---Correct.

So that he needed to know something about how to, you know, generically put together what would amount to a tender?---Correct.

Did you think the information that you were getting for instance in this email was a little bit beyond what would be required to put together a generic university assignment?---Not really, I didn't give it any thought.

Is it the case that Ivan Petch was your friend, correct?---Yes.

You knew that if you asked him for something he'd give it to you?---No.

And you knew that if he gave you this information well, that's good enough for me?---That's not correct.

Well, this email on its face indicates that the information contained is commercial in confidence?---Yes.

30 You read the email didn't you?---Not really.

When you say not really does that mean yes, I did but I don't want to tell you that or does it mean I didn't at the time?---No, I didn't even - this means nothing to me.

You are desperately trying to distance yourself from any knowledge of the contents of these emails aren't you?---Not particularly, no.

Because you knew at the time that Councillor Petch was your friend and he was doing you a favour?---No.

And you understood, didn't you, that this was material that could be used by whoever received it in a way to compete for the contract for waste collection and waste disposal at Ryde?---No, that's not correct.

Now, can I ask you to look at the document at page 1196 and 1197. Do you see 1196?---Ah, yes.

Now, that's an email from you to Councillor Petch?---Yes.

On 6 December, 2011 at 15.07?---Yes.

And you see it refers as, to an attachment being a Council minutes document?---Yes.

And below - well, I withdraw that. It indicates doesn't it that it's been sent from your iPhone?---Yes.

And underneath that you'll see you were forwarding on something else and that is a communication that Christina at Senaca Project sent to you?---Yes.

Now, Christina was someone was she that worked for you at Senaca Projects?---Correct, correct.

And she'd forwarded you an email earlier that day?---Possibly yes, yes.

Well, have a look at the next page which is the attachment and you'll see what it appears to be is a proposed motion to go to Council?---Yes.

Now thinking back about it do you recall that you'd had someone assist in drafting a motion that might go to Council?---Possibly.

Do you recall who it was?---No.

Can you recall why it was Christina was forwarding this on to you?---No, I don't.

Well, if you look at the actual text of the document at 1197 it seems to be a motion in respect of the landowners master plan, do you see that?---Yes.

And was that something to do with the Coxs Road landowners' master plan? ---Possibly.

And the motion which seems to be set out in the text of that document is, "In view of the landowners' master plan being satisfactory that Councillors direct planners to incorporate the landowners' master plan and conditions into the current LEP" and then there's further content there in terms of directions to staff about bringing a report to Council?---Correct.

Now, can you think about this please, at this time in December 2011 had you spoken to Councillor Petch and suggested that you had a motion that you wanted him to put up to Council?---No.

Well, can you think why it was you were sending him this document, this draft motion?---I think there was a, I think there was a, on that date a staff

workshop, a Councillor workshop with representatives that was there doing a presentation.

Well, what, what would this particular draft motion have to do with a Council workshop?---Well, perhaps they were going to get up and discuss it that night.

Well, you had an interest didn't you in the Coxs Road landowners' master plan?---Of course.

10

You had a significant commercial interest in it?---Of course.

And would you agree that what this seems to be is you suggesting to Councillor Petch the text of a motion that he would put up in respect of that item?---He can't put it up, it's a workshop, it's just a general around the table discussion.

Well, this document, I thought you'd agreed with me that it appears to be a motion to be put before Council, a draft of one?---I didn't agree with that.

20

You don't?---I said it looks like something of that sort but on the 6th that was a staff workshop I recall.

You have a clear recollection of that now, Tuesday, 6 December?---Yeah, it was a staff workshop. On, on that night there was David Furlong there representing the church, there was our representatives there, they got up and spoke on behalf of all landowners.

So what, was there a meeting to do with the landowners master plan?---Not a meeting it was just a workshop where there were staff present and Councillors that could be bothered to turn up.

But to do with the Coxs Road master plan?---Of both master plans, yes.

Okay. So it was a meeting at which, at which what, the Councillors would be present?---Some, yeah.

Council staff would be present?---Yeah.

And they would discuss what might happen with the Coxs Road landowners master plan?---Well not the landowners all of them. What they were going to do with the, what they were going to do with the master plan.

Right. And - - -?---It was just a workshop.

But you were keen on promoting the landowners master plan weren't you?---Of course

So was the idea of sending Mr Councillor Petch that you wanted him to put up at that meeting this particular proposal that is set out at page 1197?---Not that I can recall.

Well can you think of any other reason why you were sending this Councillor Petch?---I can't recall why I sent it to him.

Well can I suggest this to you - - -?---I don't even remember him being in that meeting.

Can you recall a discussion with Councillor Petch where you asked him whether he could put this up so that the Council would be, with a view to possibly persuading the Council to accept as satisfactory your landowners master plan?---No. I can't recall.

Do you think you might have had a discussion with him where you asked him if you could put it up so that it would assist in making the landowners master plan be the one that the Council then settled on and - - -?---No.

20 --- incorporated into the LEP?---No, not that I can recall, no.

ASSISTANT COMMISSIONER: Well why did you send it to him?---I don't recall why I sent it to him at the time.

Well have a think, have a think?---Well I can't.

MR DOWNING: Commissioner, is that a convenient time? ASSISTANT COMMISSIONER: Yes. We will adjourn for 15 minutes.

MR DOWNING: Thank you, Commissioner.

Just before the break, Mr Cerreto, I was asking you about the document at page 1196 and 1197?---Yes.

Can I suggest to you that what you were doing through sending that document through to Councillor Petch was trying to, or seeking that he push your interests at the Council workshop to promote the landowners master plan to be adopted?

MR NEIL QC: Well, your Honour, Commissioner, I object. The matter is one in which you've made a plan that the merits of these matters are not to be got into and he was in favour of it, in my submission he would be entitled

24/07/2013 E12/1191 to ask for Councillors to favour it. I thought the Commission was not going to go into the merits of the matters.

ASSISTANT COMMISSIONER: Well I don't think it's going into the merits, just to ask him what his purpose was in sending this message to Mr Petch.

MR NEIL QC: Well there could hardly be any wrongful purpose in asking for what in his view was a mediatory development to be considered.

ASSISTANT COMMISSIONER: Yeah. I think it's just part of the relation, evidence about the relationship between him and Councillor Petch.

MR NEIL QC: If it please the Commission.

ASSISTANT COMMISSIONER: Yes.

MR DOWNING: Were you seeking through sending this document to Councillor Petch to have him promote your interests at the committee with the view to having the landowners master plan adopted?---I would have probably sent it to him so it can be around the table discussion between all the Councillors there that night and staff.

Can I ask you to have a look at - - -

ASSISTANT COMMISSIONER: Sorry, can I just say on the point that's been raise by Mr Neil so, so we all understand where we're going you had a commercial interest in a, this master plan didn't you?---Yes.

- And eventually the Council was going to have to decided whether to incorporate that master plan into the LEP or not. That was one of the issues - -?--One day.
 - - they had to look at?---One day, yeah.

And if they did incorporate your suggestions then that might have some commercial benefit to you?---Correct.

Yeah. So that was your interest which is fine, you're a businessman you've got a commercial interest. Now obviously the Council's interest is quite separate. The Council has a duty to the whole community and Councillor Petch had a duty to the whole community. So I just want to put on the record that I see this as being an issue where conflicts of interest could arise between the commercial interests of Mr Cerreto and the good of the community and it's in that context that we have to examine the relationship between Councillor Petch and Mr Cerreto to see how the tension between those interests was handled and whether there was a conflict of interest which was not declared. Thank you.

MR DOWNING: Thank you, Commissioner.

Can I ask you look at page 1198 and 1199 of the exhibit. And do you see that's an email from Councillor Petch to you of 2 December, sorry, 2 February 2012 at 18.24?---Yes.

And what he was forwarding onto do you see was an email he'd received from the Council in respect of a particular development application regarding 3 to 5 Trelawney Street - - -?---Yes.

--- Eastwood?---Yes.

Now that's the land that you understood or you know is owned by Mr Goubran?---Correct.

And you'll see the document that's sent on is a summary for Councillors of, from Mr Johnson the Group Manager Environment and Planning of particular submissions that had been received in respect of the development?---Correct.

So setting out, identifying particular persons who'd made submissions and indicating what their position was?---Correct.

Did you forward that onto Mr Goubran?---Possibly, yes.

Well you would have understood in receiving it that it was something that was of interest to him?---Possibly, yes.

Well it was of no interest to you was it?---No.

Do you recall having a discussion with Councillor Petch about the fact that this was a matter that he would be forwarding some documents to you in respect of?---No.

Do you, do you accept that oh, I'll withdraw that. At the time did you give some consideration as to whether this was a document that was available to the public generally?---Oh, not really.

Do you think a document identifying by name people who'd made submissions and indicating their positions would normally be a communication that would be from Council staff to Councillors but not made available to the public?---Oh, I think that's made available to the public.

And what basis do you have for that belief?---From my experience in the past. If people object to it you can find out who and why.

So you think a table summarising the issues raised by the people who'd made submissions from Mr Johnson that's sent to Councillor Petch, that would be something available to the public?---Correct.

ASSISTANT COMMISSIONER: Is that on the basis of some development you've done?---Yes.

What was that?---Well, not a development, like a, if you've lodged a DA and there's objections, you know, Council notify you of the objections.

Yes, so is that in respect of a DA you've lodged?---Yes.

Which was that?---Ah, Hunts Avenue for the, the villas. And um, yeah. And from other experiences I understand from other people.

And in respect of the Hunts Avenue application you were provided with information about the objectors and the grounds?---No, but you can ring Council and you, you um, tell them your DA number and they'll tell you over the phone if anything's wrong and they can email you the submission if someone's put a submission in on a particular DA.

So they'll send you the submission and the name of the person - - -?---Correct.

- - - who's made the objection?---Correct.

Thank you.

MR DOWNING: Can you go next to page 3021 and 3022 which is at the back of the bundle, the last two pages?---Yes.

You see that's an email again from Councillor Petch to you this time - - -?---Yes.

- - - 3 September, 2012?---Ah hmm.

And again it's forwarding on something from Dominic Johnson to the Councillors?---Correct.

40 Copied to Mr Neish, the then General Manager. And again to do with this development application for Trelawney and Rutledge Street?---Correct.

And is this something you also forwarded on to Mr Goubran?---Possibly, yes.

Can I ask were you getting communications of this nature from Councillors other than Councillor Petch?---Not that I recall, no.

So he's a personal friend - - -?---Yes.

- - - and he's sending you these communications?---Ivan was sending me all types of emails during this time.

Did you, did it ever occur to you that what you were getting was something that members of the public might not be able to get?---No.

Notwithstanding the fact that you weren't getting communications like this from any other Councillors?---No.

You didn't think that you were getting some particular treatment or favouritism through your friendship with Councillor Petch?---Not particularly.

Would you say that in respect of this document you regarded that as something that was just available to the public as well?---Oh, I assumed if Ivan's sending it off ah, it's available to anyone.

Well, is that your approach that you don't care what the content of a document is, if it comes from Ivan then it must be available to everyone?--Pretty much.

All right. Can I ask you then to go to pages 1200 to 1202, that'll be back in the bundle. Now, do you recall in about June of last year there was an article in the Sydney Morning Herald and the ABC to do with the Coxs Road master plan?---Yes. I remember it well.

And there was a suggestion raised at that time that in some way the community support for the, the master plan hadn't been, well it wasn't legitimate?---Correct.

And do you recall at that time receiving this email from Councillor Petch?---Yes I do.

So he forwarded on to you on 12 June a report from - - -?---What page was that sorry, 1200?

1200 to 1202?---Yep. Yep. Yeah.

A report from Mr Neish, the General Manager to Councillors and also forwarding on Dominic Johnson's report in respect of that matter?---Correct.

And did you regard these as matters that were available to the public or did you regard these as internal Council communications?---I didn't think anything of it. I just forwarded it straight to my solicitor.

And do you see it's an email forwarding on a particular statement of position that had been received from a resident of Ryde in respect of the different master plans?---Correct.

And this was forwarded to you by Councillor Petch?---Correct.

And again it's a document that identified the person who was making the, stating her position?---Yes.

Did you understand this to be something that was publicly available?---Yes.

Can I ask you to go to page 1206. And do you see at pages 1206 to 1208 what you have was an email from Councillor Petch on 25 June - - -?---I don't have '08.

I'm sorry?---I've only got 1206.

I'm sorry. Can we - we'll need to add them.

MR NEIL QC: Commissioner, ours jumps from '01 to '06 to 2290.

MR DOWNING: Well, I'm sorry. The pages should have been included. We'll have them brought up on the screen and we'll have them added so that everyone gets them for their exhibit.

If you have 1206 physically in front you - - -?---Yes, I do.

If we could bring up 1207 on the screen. Do you recall in June 2012 becoming aware of a particular community organisation the Ryde Concerned Citizens Association?---Not particularly, no.

Well do you recall that Councillor Petch on the 25 June forwarded to an email that he received from John Mahony?---I can see it in front of me but I didn't mean much to me at the time.

Well what it, what it enclosed if you, if we go down you'll see that there's an email from John Mahony to Councillor Petch?---Mmm.

If you go to the bottom of the page you'll see that was indeed forwarding on a further email from Gary Best at Clayton Utz to Mr Mahony?---Ah hmm.

Now that was sent to you at the time?---Yes.

Yeah. 'Cause do you see it does tend to suggest the email that he was seeking your advice or input about what might be done in response to the lawyer from Clayton Utz?---Correct.

Did you have any involvement with the Ryde Concerned Citizens Association?---Not at all. I didn't even know who they were.

And it asks that you speak to Ray Fazzolari - - -?---Yes.

- - - as a matter of urgency?---Yeah.

Do you say there'd been no discussions at all with Councillor Petch about the Ryde Concerned Citizens Association and its activities?---Correct. What I understood from Ivan was that he was contemplating putting a, an injunction of the Civic Centre and he needed an advice of a solicitor

Well, but did you read these documents at the time?---No.

So you, you got them and did nothing?---That's correct.

someone that could get him some media exposure.

Do you recall receiving this?---Not really.

10 If you knew of what, someone that could print a brochure?---Correct.

You say he was asking for advice from you about a company that might print brochures?---Correct.

Did you have any involvement with organising the brochures?---Not that I can recall.

Did you pay for brochures?---No.

So are you suggesting to the Commission that the limit of your involvement after receiving this call was to give him some advice about a particular printer?---Ah, perhaps, but I also helped him during the - put him in touch with the right people.

Well, right people for what?---Well, for what he needed for the election.

Well, what, what are you referring to?---Oh, advertising or the, the pamphlets or whatever like that, just put him in touch with the right people.

So asking for payment of \$2,001.83?---That's correct.

And you'll see if we go back to 1291 Mr Cooper then forwarded that on to Councillor Petch?---Yes.

And Councillor Petch forwarded it to you and said, "Norm, this seems to come from left field"?---Correct.

Did you speak to Councillor Petch about it?---No, I didn't.

Do you recall him indicating that he had an email that he wanted to use to try and establish that Mr Johnson had in some way misrepresented advice that he received from the Department of Planning and Infrastructure?---Well I wasn't aware it was an email but he said he had documents and Council documents that he believed there was some corruption.

And he, do you recall him expressing the, the view that he wanted to take some steps to bring Mr Johnson to account?---Yes.

Do, did you make any inquiry from him about where he got the documents?---No.

Would you accept that in the course of this call that your discussion with Mr Goubran indicated you giving him some advice about strategy and tips about how this might be managed?---Possibly, yes.

In the first page of the transcript you referred to the fact that you'd spoken to Mr Stavrinos?---Yes.

And you asked if, Mr Goubran if Mr Stavrinos rung him back?---Yes.

Was Mr Stavrinos undertaking some task in respect of this matter?---No.

Well what did you understand that Mr Stavrinos would be ringing Mr Goubran about?---Oh, our job at Concord.

All right. Now in the course of the conversation you spoke with Mr Goubran at some length about the legal advice that was being sought? ---Correct.

And the QC's opinion that was being sought on the issue of Mr Johnson's conduct?---Correct.

Now having seen that do you recall if at around this time there had been a discussion involving you, Mr Goubran and, and by that point Mayor Petch about the complaint being made and the way in which Councillor or Mayor Petch would handle it?---Possibly.

Do you recall Councillor Petch giving suggestions as to how it might be handled?---No.

Do you recall talking to the Mayor with Mr Goubran about the complaint that was to be made and requesting that it be managed in some way?---I recall speaking with Ivan saying the solicitors are putting a, an opinion together to formulate and present to the Council.

So that he was aware of that before the letter from the lawyers turned up? ---Correct.

Was he aware that the QC's opinion was being sought?---Correct.

And do you see that at the bottom of page 3 of 8 you speak to Mr Goubran and talk about working out an exact strategy and you say that you've got something in mind and refer to the fact it's got to be done properly?---Yes.

So was it the case that you were taking a fair degree of interest in the way in which this complaint was to be presented to the Council?---I wanted this complaint to be handled properly.

All right. Despite the fact it had nothing to do with you?---No, for John's sake.

Now at page 4 of 8 you refer to the fact that the person providing the advice was Mr McNally of Senior Counsel. Was that something that you learned about through discussion with Mr Parisi?---Correct.

Now at the bottom of page 5 of 8 you'll see that Mr Goubran refers to someone asking that you present him with it formally with a legal opinion so he could see the disparity and he can press the buttons to correct the wrong?---Yes.

Did you understand that he was referred to Councillor Petch there?---No.

Who did you understand he was referring to?---The other landowners in College Street. That's who had the meeting with the Mayor when, when I first said it.

So you say that - - -?---Ray Dresner I think his name is.

So that, that person could see the disparity after being presented with a legal opinion and press the buttons to correct the wrong?---Correct.

You don't, you deny that what Councillor Petch had said look get your legal opinion, send it to me and then I'll take whatever steps I can to write the wrong?---I don't deny that but I'm saying in reference to that this is what took place. Mr Dresner apparently is a solicitor.

So over the page at page 6 of 8 do you see Mr Goubran says, "So I said it's imperative that you write to him because you understand and that's what he wants." Do you say that that wasn't a reference to, to Mayor Petch?

40 ---No.

That's Mr Dresdner was it?---Mmm.

Had there been a discussion with Councillor Petch about, with, between you, Mr Goubran and Councillor Petch about the fact that Councillor Petch had forwarded originally the advice from Department of 20 June and that it was, it needed to be handled sensitively that is the complaint was then to be made based on that information?---No, not that I can recall.

You don't recall that at all. Do you, do you recall whether there was ever a discussion between you, Mr Goubran and Councillor Petch about how this whole complaint process should be managed from beginning to end?---I do recall we had a chat and we said that we would formalise a legal opinion and do it through the right channels, get a QC's opinion and let the solicitor give him a copy of the complaint.

And do you recall what Councillor Petch said he'd do?---He would forward it to the General Manager and forward it off to ICAC.
