- 4. On 5 April 2012, my husband, Graham Colbran, and I purchased a 2004 Kenworth T404 Tipper truck, silver in colour, which at the time displayed New South Wales registration plate details KEN-604. The Gross Vehicle Mass ("GVM") for this particular truck was 24,100 kilograms.
- 5. We purchased truck KEN-604 (NSW) after it was advertised on a truck sales website: - www temperature from my recollection there was approximately six (6) of photographs in the advertisement for the truck and several of these photographs clearly displayed the registration plate details (KEN-604). I believe that the advertisement also indicated the odometer reading at the time that the truck was advertised on the website for sale.
- On 17 April 2012, my husband, Graham Colbran, and I attended the Dubbo Motor Registry and surrendered NSW registration plates KEN-604 on from the recently acquired Kenworth Tipper truck and transferred a previous set of NSW registration plates my husband had owned onto the truck. The registration details for the truck were changed over to BP92VS (NSW). These registration plate details remain on the truck to this date.
- 7. I have never removed registration plate number KEN-604 (NSW) from the truck until such time as we transferred the registration details to BP92VS (NSW) at the
