- 8. On 16 September 2013, I attended Drummoyne Post Shop and inspected the location of the outlets only facsimile machine. Later that day I telephoned Drummoyne Post Shop and had a conversation with the Postal Manager Evangeline PAPA, whereby certain things were said. As a result of this conversation I can say that between 01 January 2012 and 31 May 2013, the only facsimile machine at Drummoyne Post Shop was located behind the counter and could only be accessed by staff members and authorised contractors.
- 9. I have checked Australia Post records and can say that the standard cost of sending a facsimile from an Australia Post corporate retail outlet to a location within Australia is \$5.00 for the first page and \$1.25 per page after that. I can say that when a facsimile is lodged at an Australia Post corporate retail outlet, it is brought to account in the Australia Post Electronic Point Of Sale (EPOS) system under transaction code 6000 and then sub-code E60. There are multiple other transactions processed in EPOS using the tran-code 6000 and as such it is not possible to identify facsimile transactions only in a search of EPOS.
