THE COMMISSIONER: Yes, now just before we start, yes, Dr Chen.

MR CHEN: Commissioner, I was simply going to announce that there is a need for the Commission to take some evidence in private and that's what has delayed things this morning regrettably, but that's a step that the Commission, in our submission, would need to take before proceeding further with the public inquiry.

THE COMMISSIONER: Very well. Thank you. Well then just before we start, I'll announce the program that's to follow, but before I do that are there any appearances here, applications for appearance?

MR VOROS: Commissioner, my name is Voros, V-o-r-o-s.

THE COMMISSIONER: Yes, Mr Voros.

MR VOROS: I do seek leave to appear on a limited basis for Mr Petroulias. The limited basis is really confined to his re-examination.

THE COMMISSIONER: Right. Well, Mr Voros, yes, thank you for that. It's not necessary really for you to advise us of the terms of your retainer but I understand you're being retained as you've stated on that basis and I will authorise and grant you leave to appear on behalf of Mr Petroulias.

MR VOROS: Petroulias, thank you.

THE COMMISSIONER: Yes, thank you. I apologise for the delay in the proceeding this morning. There have been a few matters requiring my attention. So far as the program for this morning is concerned, as Senior Counsel Assisting has indicated, I will be taking some evidence in private hearing. I then intend to resume the public inquiry but that won't be before 12.00 midday. So I will shortly adjourn for five to 10 minutes. I will resume in private hearing. Only those concerned with the private hearing will be entitled to be present. I'll deal with that when I resume. Accordingly on that basis, I'll adjourn this public inquiry. Anything else, Dr Chen?

MR CHEN: No, there's not, Commissioner.
