Dear Sir,

You are aware of the dysfunctional board of the Awabakal Land council .

Since Stephen Sles dismissal there has been no productive meeting of this board .

There are two fractions that will never agree to attend at the same time.

There is no way forward for this organisation in the current situation.

I have served on boards of sporting clubs, registered companies licensed Bowling clubs and never seen anything like this.

I was unavailable for land council business from 28th April to 21 st October. 2015 and I believe you are aware of my circumstance.
In passing I am more than confident I will not be convicted of these charges.

I tendered my resignation on the 29th of October as I would not want my circumstance to attract attention to our organisation. However I withdrew it straight away where it was alleged in pamphlets distributed by someone that I may have been involved or supported corrupt conduct within the board. These allegations are completely unfounded ..

There has been one board room meeting since that time with an attendance of 5 of the nine members. Signatories' were elected to try and get the place going again. Those that did not attend were not happy about that and the rumour mill starts again.

There been resignation from the acting CEO that was withdrawn and she is currently working in the office with staff but has no support and really wants to go..

I am aware of the Investigation in progress about he legality of actions taken in my absence.

I cannot believe that this has been allowed to go on for so long.

I cannot see any possible way forward with this board and it is with regret that I Resign as aboard member of the Awabakl Land Council this day.
