HAWATT: Yeah Pierre [I was talking to myself].

AZZI: [Yeah the line was disconnected. Yeah] sorry.

HAWATT: Oh I'm talking (INAUDIBLE) –

AZZI: Oh I – I know.

HAWATT: Yeah so look well we can't do anything until after Easter, when I get back we'll follow it through and we'll (UNINTELLIGIBLE) alright.

AZZI: Yeah [but] understand you're gonna fuckin follow (UNINTELLIGIBLE) stupid things mate [and all the] councilors panicking, [and all the] council [want to fill up]. No one can do anything. [That is] stupid fuckin things [we are] stupid what we can do?

HAWATT: It – it's a dumb promise he made very – very (INAUDIBLE) –

AZZI: Dumb [but I talking with Karl Assfour and Karl said to me, “we should now talk] in the position and if (unintelligible) and insist [and the government wants that. Then Michael has work and] it's gonna be very tough and hard to push for people we want to be in the transition [you know how, the] councilors. [You understand how?
