At approximately 9:00 am on 19 / February / 2014 I was performing my duties as Search Team Two at Unit 3 when the following incident occurred:  
Whilst searching cell 146 belonging to inmates known to me as [REDACTED] and [REDACTED] I lifted a toilet roll off the bench in the cell and underneath it sitting on the bench was a folded packet of Clive of India tea. I opened the packaging and it contained an amount of white powder. Inmate [REDACTED] was brought into the cell and I asked him if he agrees that the item was located within his cell. He said "Don't play games you know what it is". I asked [REDACTED] if he could tell me what it is and he said "You know what it is, send it off and when you find out what it is I will own up to it". The item was then placed on the scales and weighed 0.2 grams. Inmate [REDACTED] was asked if he agreed that the scales read 0.2 grams and he replied I'm not playing games you know it's fucking bupe". The item was placed into evidence bag numbered 600536.  
At no time was [REDACTED] given permission to possess this item.
