Whilst there, Senior Investigator KANE and I spoke with the manager director, Alex WOOD aka Alex WU. Mr WOOD amongst other matters was spoken to about the computers that Steve TONG and Quanbao LIAO used whilst working at WU International Investments Pty Ltd. Mr WOOD indicated that the Toshiba laptop sitting on the table we were seated at in the boardroom was the computer that Steve TONG used and the computer that Quanbao LIAO used was still in the office.

- 5. About 9.40am on 8 August 2018, Senior Investigator Kane and Smith attended Wu International Investments where a Section 22 Notice was served on Alex WOOD for the computers used by Steve TONG and Quanbao LIAO. As a result of this order, Alex WOOD identified and handed to ICAC investigators a laptop sitting on the boardroom table as the computer used by Steve TONG. Shortly after, Alex WOOD left the room and returned with a Personal Computer he identified as being used by Quanbao LIAO.
- 6. That same day, I caused the laptop computer identified as being used by Steve TONG to be entered into ICAC Property as a Toshiba Satellite Notebook Computer P50T-B Serial No. 8E075197S. This property was given Property Reference No. E18/0093-AS-02-014/PR-0001. I also caused for the personal computer identified as being used by Quanbao LIAO to be entered into ICAC Property as HP Pavilion Desktop All-In-One computer Model No. 24-B015A
