I haven't made any donation to a Political Party. Have your guy do use my name to make this donation? Than Alex Wu told me, it is his father use my name to make the donation at the Dinner Time, but this is no any problem, if have any problem our company will fix it, don't worry, I dofew times donation before with my name. I said If no problem why don't use your own name to make this donation? What can I do later on? He just told me no need to do anything, let company to fix it.

At that time I need my job therefore no choice just shut-up only. But now I received Electoral Commission letter for "Disclosure of Political Donations for a Major Political Donor" for the year ending 30 June 2015 on 25/08/2016. I called Wu International In-Charge Mr Leo Liao, ask him what should I do? He said to me – just full up the form than send back to them, this is should be OK, don't worry. Until 14/09/2016 I received other letter, they want me provide information are as follows:

- 1. A copy or copies (if you have multiple employers or positions) of your payment summaries (the financial year) as supplied to you by your employer or employers, indication your earing for the financial year.
- 2. To provide a copy of the Notice of assessment supplied to you by the Australian Taxation Office ('ATO') for the financial year.
- 3. To provide copies of all your bank statements from 1 Feb. 2015 to 30 April 2015.

4. To provide copies of the receipt given to you by the person/s or organization/s who received your donation on either the 12/03/2015 or the 9 April 2015 when you donated \$5,000 to the Country Labor Party ('CLP').

The above information must send and received by before at 10.00Am on Wednesday 28 September 2016.

When I received this letter than call Mr Leo Liao, ask him what happen on this donation? He told me to provide all above four items copies and he will arranged their Accountant Mr Leon to help fix it. The whole situation for this donation may be done otherwise
