





Dear Mr Neish

I refer to your letter of 23 December 2011, regarding difficulties in conducting Council business due to the lack of quorum at recent Council meetings.

I understand that Council has been left inquorate on seven (7) occasions between May and December 2011 with the result that it has been unable to conduct or complete its business, and that this again occurred on 17 January 2012 when Councillors Butterworth, Li, Perram, Petch, Salvestro-Martin and Tagg failed to attend the Council Meeting, which had been previously adjourned on 13, 14 and 20 December 2011.

From the information provided, it appears that, of those occasions where Council has been left without a quorum, only one Councillor's absence was further to a leave of absence granted by Council (Councillor Petch – 13 and 14 December 2011).

I also note that on 8 November 2011 and 14 December 2011 the meetings were adjourned following the departure of Councillors Butterworth, Li, Perram, Petch, Salvestro-Martin and Tagg at 11:06 pm and Councillors Butterworth, Li, Silvestro-Martin and Tagg at 10:20 pm, respectively. I note that apologies had been received from Councillors Perram and Petch and that they were not present at the Meeting of 14 December 2011.

While the circumstances of each Councillor are not known, I observe that only Councillor O'Donnell has been present at all meetings between May and December, and that only Councillors Campbell and Petch have been granted a leave of absence by Council for any meeting held during that period.

Although it does not appear that any Councillor has missed three (3) consecutive meetings, I would remind Councillors of the provisions of section 234(1) of the Local Government Act 1993, which provides that if any councillor fails to attend three consecutive ordinary council meetings without leave of the council it is deemed that there is a vacancy in civic office. This happens automatically by operation of that section of the Act.



I would also note that, while councils are free to make provision for the tendering of apologies in their codes of meeting practice, such apologies are not recognised in the Act or in the Local Government (General) Regulation 2005 and do not constitute a leave of absence, which is a formal permission granted by a council to a councillor not to attend a particular meeting(s).

Section 439 of the Act requires that councillors exercise a reasonable degree of care and diligence in carrying out their functions. Absent exceptional circumstances, councillors are expected to attend meetings of councils, and to remain at those meetings to deal with council business in an orderly and timely manner. Furthermore, the community would expect its elected representatives to act responsibly and to demonstrate leadership, particularly with respect to controversial or unpopular proposals or issues.

Council must be able to effect its business in a timely and efficient manner. It is of serious concern that the transaction of Council business appears to have been impeded by the failure of Councillors to either attend or remain at meetings of Council, thereby leaving Council inquorate. The impact of this situation, should it continue, on the reputation of Council in the local community, and on local government more generally, needs to be fully appreciated by each and every Councillor.

I expect an immediate and sustained improvement in Councillor attendance patterns. The Division will closely monitor the situation. In the event that Council continues to be unable to transact its business in a proper and timely manner, or demonstrates an unwillingness to do so, I will provide advice to the Minister on the possible exercise of his powers under section 740 of the Act to call a public inquiry into the operations of Council.

I request that you provide a copy of this letter to the Mayor and each Councillor, and that this letter be tabled at the next available Council meeting.

The Notice of Motion referred to in your email has no effect at this point in time on the implementation of a resolution of Council so does not in any way hinder the signing of any SWICAC agreement with Lend Lease. I can confirm however that there has been nexthing the agreement yet reached in our negotiations with Lend Lease.

In accordance with Council's resolution, I need to be reasonably satisfied that hurdles as established by Council in the Commercial and Risk Principles have been met and this is likely to take some time.

I am currently seeking legal advice as to the validity of a Notice of Motion which has the same affect as a previous motion which was subject to a defeated rescission motion. Whilst I, the Group Manager of Corporate Services and our General Counsel believe that the motion is out of order, I have requested an opinion externally to Council to confirm that this is the case.

CIVIC PRECINCT REDEVELOPMENT

Thank you for your response of 3 July 2012.

Our legal advice is that the Notice of Motion is valid. In particular and without limitation, the Notice of Motion is sufficiently different from the previous Notice of Motion for there not to be an issue as you suggest.

More importantly however it is the view of the six Councillors who have proposed the Notice of Motion, that in circumstances where:

- (a) serious concerns have been raised with respect to the proposed arrangements with Lend Lease;
- (b) the proposed arrangements do not have community support,

it is incumbent on you to recommend to the other six Councillors including the Mayor, that in all the circumstances no further action should be taken by you, despite Council's current resolution, until such time as the Notice of Motion has been determined.

That is even more so the case in circumstances where you are or should be aware that the likely new Council from September this year, will seek to set aside any arrangements that you enter into with Lend Lease prior to those elections.

If all of that were not enough, we also have legal advice that Council did not have the power to delegate authority to you, as contained in the resolution of Council of 12 June 2012.

Accordingly, on behalf of the six Councillors, I am putting you on notice that proper exercise of care, diligence and prudence in this matter requires you to recommend to the Mayor, that all negotiations with Lend Lease be put on hold until such time as the Notice of Motion is dealt with.

In summary, whether or not the Notice of Motion is valid (which we believe it is) the real question is whether you, as General Manager, will exercise due care and diligence so that you will be recommending to the Mayor that negotiations with Lend Lease be stayed until after the next Council elections.

Perhaps, in that respect you should take legal advice as to your personal responsibilities and possible liability in this matter, particularly in light of that contained in this letter.

I look forward to hearing from you shortly.

Council has considered and passed resolutions on a number of occasions, including those on 18 October 2011, to proceed with the Ryde Civic Precinct Development.


As a result, a public procurement process has been undertaken in accordance with Council's resolutions, including:

Dear Mr laface,

I refer to our telephone conversation and to the urgent advice requested.

I understand that you act for Councillor Ivan Petch and various other councillors of

Ryde City Council who wish to give notice of an Extraordinary General Meeting at which will be proposed a resolution to terminate the agreement of the Council with the current General Manager Mr John Neish dated 14 October 200. The proposed HBIT termination is pursuant to clauses 10.3.5 and 11.3 and Schedule C of the agreement.

My advice is requested on whether under the agreement Mr Neish's employment can be terminated summarily without cause and whether that will expose the councillors proposing the resolution to any laibility in defamation.

I am instructed that the councilors proposing the resolution are acting in good faith, out of concern for Mr Neish's apparent close connection with a developer and support for a proposed development for the reasons outlined in a letter from Mahoney Taren Lawyers received by the Council on 22 June 2012, and for the benefit of the Council and the ratepayers, and feel obliged to propose the resolution notwithstanding the failure of the Council to rescind the resolutions referred to in the letter from Mahoney Taren Lawyers.

Mr Oliver and I have conferred as to the appropriate form of the proposed resolution and he will communicate it to you.

I confirm my advice that, in my opinion, in accordance with clauses 10.3.5 and 11.3 and Schedule C of the agreement with Mr Neish, Mr Neish's employment can be terminated summarily, without cause and without giving Mr Neish notice or affording Mr Neish any opportunity to be heard. In my opinion that is the effect of the agreement on its true construction. Other provisions concern termination for cause, which would involve different considerations. In my opinion, clauses 10.3.5 and 11.3 and Schedule C on their true construction provide a machinery for summary dismissal, taking effect immediately, upon payment of specified compensation.

The resolution proposed, which Mr Oliver has sent to you, is in the following terms:

That:

- 1. The Council's contract with John Neish dated 14 October 2009 be terminated, with immediate effect, pursuant to clauses 10.3.5 and 11.3 and Schedule C thereof, and that John Neish be thereby removed from the position of general manager with immediate effect.
- 2. Pursuant to s 336(1) of the Local Government Act 1993, insert name be appointed to act in the vacant position of general manager, pending appointment of a new general manager pursuant to s 334 of the Act.
- 3. Pursuant to clause 11.4 of his contract with the Council dated 14 October 2009, John Neish's entitlements under clause 11.3 of that contract be calculated and paid to him forthwith.

In my opinion, the content of the resolution is not defamatory, but in any event should attract a defence of qualified privilege (on my instructions the councilors are not acting with malice, for the purposes of the law of defamation) and in any event the councilors may well be protected by section 731 of the Local Government Act 1993 (NSW) in relation to their giving notice of the proposed resolution. The Council would of course be within section 731 in relation to the further publication required by law.

There remains a question whether, if the resolution were passed, the Council would be liable for damages arising out of the manner of termination for breach of an implied obligation of good faith and mutual trust and confidence in Mr Neish's employment agreement. In the light of the terms of the agreement, it is doubtful whether such an obligation would be implied (see clause 4.6, with clauses 10.3.5 and 11.3 and Schedule C) even if the implication of such an obligation be part of the law of New South Wales and Australia (see the discussion of authorities in Shaw v State of New South Wales [2012] NSWCA 102). In any event, in my opinion, it would be unlikely that the councillors and the Council, acting in good faith as I am instructed, would be held to be in breach of the content of the implied obligation. This is, at present, a difficult area of the law, and the opposite view to the one I have expressed is open, although I do not think it correct.

Please let me know if any further advice is desired.

I thank my instructing solicitor for his instructions.

CITY OF RYDE MOTION TO DISMISS GENERAL MANAGER JOHN NEISH

We act for City of Ryde ('the Council') on instruction from the Mayor, Councillor Artin Etmekdjian.

Public Interest Disclosure and Investigation

The General Manager, Mr John Neish, has made Public Interest Disclosures, pursuant to the *Public Interest Disclosures Act 1994*, to the Mayor and to the Independent Commission Against Corruption concerning alleged corrupt conduct by others within the meaning of Part 3 of the *Independent Commission Against Corruption Act 1988*.

We have been instructed that a number of Councillors are implicated in the allegations.

The alleged corrupt conduct has been reported to the Independent Commission Against Corruption (ICAC) and the Division of Local Government (DLG). Mr Neish has provided consent pursuant to section 22 of the *Public Interest Disclosures Act 1994* to permit the disclosure of the fact that he has made a public interest disclosure.

We are instructed that as a consequence of the disclosures the ICAC has determined to undertake a preliminary investigation.

We have advised the Mayor of the law in relation to reprisal actions. In particular, it is an offence under section 20 of the *Public Interest Disclosures Act 1994* to take "detrimental action against another person that is substantially in reprisal for the other person making a public interest disclosure". This offence carries a penalty of 100 penalty units and/or 2 years of imprisonment.

Termination Motion and Rescission Motion on 14 August 2012

On 23 July 2012 at an Extraordinary Council Meeting, Council resolved (6 to 5) to terminate the employment of the General Manager Mr John Neish (the Termination Motion). Subsequently, a rescission motion for the Termination Motion was lodged and this is to be dealt with on 14 August 2012 at an Ordinary Council Meeting (the Rescission Motion).

In the circumstances where General Manager Mr John Neish has made a public interest disclosure under the *Public Interest Disclosures Act 1994*, we are of the view that the Termination Motion to dismiss the General Manger and any actions by Council giving effect to the Termination Motion, may be characterised as a detrimental action, and may constitute a breach of section 20 of the *Public Interest Disclosures Act 1994*.

For completeness section 20(2) of the Public Interest Disclosures Act 1994 relevantly states:

In this Act, "detrimental action" means action causing, comprising or involving any of the following:

- (c) discrimination, disadvantage or adverse treatment in relation to employment,
- (d) dismissal from, or prejudice in, employment,
- ... (emphasis added)

Required Undertaking

In the circumstances, the Mayor has instructed us to write to you, to seek the following undertaking:

1. I agree and undertake to refrain from voting against the Rescission Motion on 14 August 2012, pending the report of investigations by the ICAC; and

Council requires a written undertaking from you to the above, or to a similar effect, to be received at this office by 10.00am Friday 10 August 2012.

In the event Council does not receive your undertaking, the Mayor has instructed us to seek the approval of the Attorney General, and to apply to the Supreme Court for an urgent interlocutory injunction against you, to prevent a contravention of section 20 of the *Public Interest Disclosures Act* 1994.

We look forward to your cooperation and the receipt of the undertaking.

I refer to Council's previous letter dated 9 October 2012 regarding the above development application (DA).

Some of the additional information requested in Council's previous letter remains outstanding, namely the requirements of Council's Heritage Officer. Attached for your information is an updated assessment by Council's Heritage Officer which includes a Heritage Assessment of the proposal and details of the additional information required.

In particular, you will note that a Conservation Management Plan (updated) is required. I note that you have previously stated that there has already been a CMP prepared for this site, however that document was prepared in March 2007 and related to a different development than the current multi-dwelling housing proposal. Therefore, this previous CMP is not a satisfactory plan to be used in the current proposal and is outdated being over 5 years old. Accordingly, an updated CMP needs to be prepared by a suitably qualified person/organisation which makes specific reference to the current subject proposal.

Also, you will note that concerns are raised regarding the impacts of the development on the Wallumetta Heritage Item. You are requested to provide a detailed statement in response to this matter (ideally by the same person/organisation as is preparing the updated CMP) as part of the submission of additional information.

If you wish to have a meeting the Assessing Officer and Council's Heritage Officer to discuss these matters, please contact Mr Chris Young on 9952 8237 to make the necessary arrangements.

Please submit this material within 21 days of the date of this letter. I note that this DA has been called up to a Planning & Environment Committee meeting, and this information is required before a report to the Committee can be prepared.
