are responsible for the running of the Club. The President is a Board Member who

is responsible for chairing the meetings and being the face of the Club. The

President is usually elected in February of each year and holds the position for a 12

month period.

5. In about 2014/2015 I was the President of the Club. In February 2018, I was elected

as Vice President of the Club. In June 2018, I took over as President when the Club

President stepped down due to health reasons.

6. I don't know a person by the name Amir Balicevac or Tejan (or Dejan) Velickovic.

7. I don't know any person called 'Boris' who has ever held the position of President

of the Club. The only 'Boris' I knew associated with the Club was Boris Bolevski

(or similar) who was the General Manager about 15 years ago. The General

Manager could not be confused with the President, they are two entirely different

positions.

8. I know the Club does purchase gaming machines through its usual suppliers. The

General Manager makes a recommendation to the Board to purchase new machines

and the Board approves that purchase. The machines are then purchased through

the usual suppler such as Aristocrat. The General Manager is responsible for the

actual purchase of the machines.

9. The Club does have a few amusement games such as a pool table, vending machine

and 3 kids games, but these are through a supplier in a share profit arrangement, in

that we don't own the machines but we share the profits with the owner who
