SIROUR: Atif Ali, Atif Ali, Jawad, Mohammed Kawser Alam, Mohammed Yassin, Gol Amiri, Kerem and Medhat. Why these guys are collected and now there's a fight between two – between three (UNDECIPHERABLE) for Amyna and Salam.

LU: No, no, no, that's all sorted. That one is sorted.

SIROUR: So look, Frank, as you know I don't care, you do whatever you want to do brother. I don't have any problem for here but when I see other guys like Kawser Alam, Atif, Ali, Medhat trying to collect the hours – this guy is now -

LU: They're not – they're not Tommy. Tommy they actually went to the job.

SIROUR: They went to the job, there is no problem. The only problem is I need you please to explain to me because today I was doing the thing with the – I haven't been out of the office because Lyn, today she's got her sonar for her baby, alright, and Linda she was doing the other thing, so I had to get Amy – well Amy a hand. SIROUR: Yeah with the crossing, yeah, with the crossing yeah. With the crossing name, yeah.

LU: Mate, it's all good that, Tommy. You know no one – no one is claiming nothing.

LU: No one is claiming nothing but – yeah.

SIROUR: Look the problem is, you do whatever you like.

SIROUR: You do whatever, Emir, look I'll tell you what. If you and Emir collecting all the hours at Sydney University at least I'm in peace because I know you guys can cover it but when I see some guys that come and say 'oh you know what Tommy, this guy' – look you know what happened to (UNDECIPHERABLE) at Macquarie University?

LU: What?

SIROUR: I swear to God, one of the guards was collecting all the timesheets and getting a photocopy of all the timesheets every single day.

LU: Mm, yeah.

SIROUR: And put it in his office - in his house.

LU: Yeah, yeah.

SIROUR: When they try to get rid of him he went and he started threatening the security – the big security company which is my –
