Hi Daryl

Thanks for sending that letter across.

I can confirm that the department is working well with us; whilst we are waiting for the release of the strategy we are providing the department a detailed study on the provision of important local infrastructure which will support the development and provide reference to the positive impact the development can have towards the improvement of the Campsie Town centre.

It is also encouraging that the Minister has committed that the next release of the draft strategy will be first half of 2017.

The council however is still completely hopeless, and in our opinion working directly at odds with the government's policy settings creating unnecessary and expensive obstacles to the provision of housing. For example; we find it strange that the government appointed Administrator has recently supported a recommendation of the council staff stating that the housing targets in the draft regional strategy are too high. This type of attitude is completely at odds with the state and federal governments objective to increase supply.
