Aleks has shown me the GHD business case. The CBA it contains is utterly non-compliant with NSW Treasury guidelines. I was under the impression that we did not ask them to do a CBA, just produce a business case that contained certain information that would enable my guys to do a CBA. Given that the document does seem to contain such data and that its CBA is unusable, I suggest that Alek's team (very quickly) produces a CBA based on the GHD document. I will need to confirm with Aleks, but this could probably be done next week.

In terms of next steps, I am no wise than Margaret. Given that the Regional Growth Tourism and Environment Fund has been launched and EoI are due soon (6 April), perhaps it can be considered as an Eol?

The proposal for \$5.5 m funding for the Wagga Wagga Clay Target Association proposed by NSW Office of Sport went to ERC during December 2016. ERC determined that the business case had to be reviewed or redone by INSW so that it can qualify for funding from the Regional Growth Tourism and Environment Fund.

Infrastructure NSW then asked that Office of Regional Development take the lead on the project to upgrade the Australian Clay Target Association (ACTA) club house and inclusion of a conference centre at Wagga Wagga

Gary Barnes has advised that we (ORD) will fund an update to the original GHD plan.
