Have you ever received any money from G8way International?---No, I haven't.

You're absolutely sure about that?---I'm absolutely sure of that.

What about from Mr Maguire?---No, I haven't received money from Mr 10 Maguire either.

And what about from Mr Elliott?---No, I haven't received money from Mr Elliott. When I would, I would organise visas, I would pay for them on my credit card if you want, and then I would be reimbursed the visas. But otherwise, no, if I made any profit from G8way, no.

How would you arrange reimbursement for the visas? Was there a paper trail?---I would just have the receipts and then when Daryl would come up to Sydney Phil would give him the money and reimburse me in cash that 20 way, so I didn't, I didn't have any, there were no bank transfers or anything like that.

How much did a visa cost at the time?---Maybe about, I'm looking a few years back here, maybe \$150 per visa. It would depend on what type of visa, if you were getting a one-entry visa or a multiple-entry 12-month visa, it would depend.

G8way has a distribution of funds to deposit." And your response to that email is that you don't recall him providing you any money?---(No Audible Reply)

Ms Hatton, please don't look ahead.---Oh, sorry.

That's all right. We're just going to concentrate on the email in front of you.

THE COMMISSIONER: Yes or no? It wasn't no recollection this morning, it was definitely not or absolutely not.---I, yeah, I definitely, I don't recall. I could certainly go through my bank details.

THE COMMISSIONER: Can we take it whether or not you actually received money that you were providing your bank details for the purpose of getting money from G8 or G8way International?---That must have been the case.

MS ELLIS: And what did the distribution relate to?---I don't recall even the distribution so I certainly couldn't recall what it related to.
