On the recommendation, the advice we had from our CFO was for wording as highlighted below, which is a bit more specific than your updated draft:

i) Approve the appropriation of cash funding and a budget adjustment to net cost of service of \$5.5m in 2016/17 to the Office of Sport to provide a grant to the Australian Clay Target Association (ACTA) for the development of a large clubhouse / conference facility and associated infrastructure at their existing facility in Wagga Wagga, NSW subject to:

a. confirmation of the ACTA cost estimates through a competitive tender process

b. development of a project delivery plan

c. ACTA undertaking to meet all on ongoing maintenance and operational costs and any capital costs for the facility that are greater than \$5.5m
