


THE COMMISSIONER: Sorry, problem with?---One of his sites, his property sites. To the best of my recollection.

And what was the reason that he was meeting with you about those sites? ---He had some issues with RMS, I think, and perhaps council.





about concealing your involvement in that company?---I, I would have to say yes.




