- Riverina Conservatorium of Music/RCM is being evicted from New England Uni land which is being sold.

- Daryl Maguire is lobbying hard to have a former-RMS office block (\$3.5m) in Wagga gifted to RCF, and another \$25m for renovations.
- Transport vacated the RMS site under the PAUT, so it expects to recycle proceeds into new capex.
- To interrogate the right mix, I think RCM be listed on the RCF.
- RCF can work on a business case, including RCM's requirements, location, etc. RCF can also purchase the site (or part) and act as landlord.

I understand from Craig Limkin that you have a list of RCF's projects for next year. Can I propose to GB that we add RCM to the list?
