Analysis:	Nominations to the Regional Communities Development Fund closed on Friday 31 August. A total of 37 projects requesting \$235.8 million were nominated by regional MPs and the Deputy Premier. 35 projects have been assessed as eligible and will be invited to submit a full application. One project was nominated by three different MPs.					
Deadline:	All nominating MPs will be advised of the outcomes and appllicants will be invited to apply on 10 September 2018.					

Key reasons

A total of 37 nominations were submitted to RCDF

- Nominations for the RCDF closed on Friday 31 August 2018.
- A total of 37 nominations were received requesting
- All projects have been checked by DPC program staff against the program eligibility criteria.
- 35 projects requesting a total of will be invited to submit a detailed application / business case. Some of these projects will be asked to provide specific information in their detailed application to support their eligibility.
- An exemption from the 25 per cent co-contribution for hardship or disadvantage has been granted for seven projects.
- A list of all eligible and ineligible projects is provided at **Attachment A**.

Next steps

- On Monday 10 September 2018:
 - Morning: All MPs who submitted a nomination will be notified whether their project has been invited to submit a detailed application (Attachment B).
 - Afternoon: All applicants with an eligible project will be invited to complete a detailed application \circ form or business case (Attachment C).
 - 18 applicants seeking funding of less than \$5 million will be required to complete a detailed Application Form. 17 applicants seeking over \$5 million will be required to complete a full business case and data sheet.

Financial or other impact

Funding of \$80 million for the RCDF has been allocated from the Consolidated Fund and was included the 2018-19 Budget.


