Hi Daryl,

I've spoken to Tony and given him the update:

- We've been in constant dialogue with the Department and almost ready to go on this one now.
- The new information in the business case demonstrated the dual aims of the project (shooting & conference facility) to enable the economic appraisal to assess those benefits.
- The letter with the positive economic appraisal is being prepared for Infrastructure NSW now.
- That will enable INSW to recommend to ERC that the project be funded out of Restart NSW (Regional Tourism infrastructure) and once ERC approves, the deeds can be drawn up.
- INSW are due to receive the economic appraisal this week and we will look to fast track the approval process over the ensuing couple of weeks – it is a matter of INSW and ERC meeting to provide approval.

I think it registered well with Tony that this is the “poles and wires money” being invested in regional infrastructure and that's why there's a few hurdles to clear.

We anticipate awarding and signing the contract for building in early July including agreeing to a deposit and timeline for payments based on milestones for completion of works.

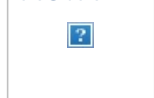
Can you provide me with someone to deal with in relation to the grant so I don't have to annoy you.

Sorry to be a constant pain, I had the chief of staff from the deputy Premiers office ring regarding the grant, he said he would send the "paper work" I still haven't seen anything and need to understand the terms of the grant for acquittal purposes and to ensure we are clear on how the money is to be spent.

My understanding is that the money was granted to build the facility of the size as agreed with former Minister Stuart Ayres.

I need confirmation of the terms and timeframe for getting access to the grant. I just want to ensure I adhere to all of the requirements of the grant. Once this is clear I can have GHD measure and report against it.

The DA was submitted two weeks ago and we have a meeting with Council tomorrow regarding the submission. We don't anticipate any further holdups.

The timeframe for commencement is the 1st of July with a completion date of the 6th February 2018.
