Notification of Allegations and to Attend Disciplinary Interview

Dear Mr Steyn

In our letter dated 20th June 2019 you were advised that an investigation had commenced into concerns raised about your conduct as an employee of Roads and Maritime Services (RMS).

At this stage, the information being canvassed about the alleged conduct relates to you having breached the Transport Code of Conduct and various related RMS Policies and Procedures by failing to disclose conflicts of interest and inappropriately using Roads and Maritime systems and resources.

The purpose of this letter is to set out the allegations against you which you are to respond to and direct you to attend a formal disciplinary interview.

The interview has been scheduled to take place at 12:30pm on 5 August 2019.

Mr David Faust, Investigations Analyst, Corruption, Prevention and Investigation Section, (CP&IS) will be conducting the interview which will be audio recorded and transcribed. Please confirm your attendance at least **24 hours** before the scheduled interview by sending an email to **David.Faust2@rms.nsw.gov.au**.

You may have a support person in attendance during the interview. This support person cannot, unless otherwise agreed to, act as your advocate or speak on your behalf. The support person should not be connected to the allegations of misconduct or a potential witness.

In accordance with Roads and Maritime Services' Discipline Guidelines and to provide you due process and procedural fairness, the purpose of the disciplinary interview is, amongst other things, to provide you with an opportunity to respond to allegations against you. The interview will give you an opportunity to provide an explanation of events, to provide comment on any relevant issue, and to present any relevant information that you believe should be considered. If you have any documents which you believe may be of assistance, please bring them with you.

The forty-six (46) allegations that are being investigated **to date**, based on information received by Roads and Maritime, are attached at '**Annexure 1**'.

<u>Please note</u>: Should you fail to attend the interview scheduled for **date**, the matter will be finalised in your absence based on the information currently available to Roads and Maritime Services.

The conduct set out in the attached allegations, if proven on the balance of probabilities, may represent breaches of the following policies, procedures and Code of Conduct that applied at the time:

 - Perceived existing where it appears, is perceived or could be perceived, that a staff
 member's private interests could improperly influence the performance of their duties –
 whether or not this is in fact the case.

Possible Outcomes

After conducting relevant interviews and considering all available information, an Investigation Report will be prepared. If a breach, or breaches, of the Transport Code of Conduct and/or any Roads and Maritime or Transport policy or procedure has occurred, and the conduct is considered serious misconduct, a preliminary decision may be made regarding disciplinary action in response to the breaches which you will also be asked to respond to.

Disciplinary action may include one or more of the following:-

- Caution or reprimand
- Deferral of the payment of an increment
- Reduction of salary and demotion to a lower position or grade
- Suspensions from duty without payment of salary
- Dismissal

Independent of any disciplinary action, Roads and Maritime may take management action including transfer, counselling supervision and monitoring, training development, staff rotation or transfer, manage performance and issue warning or take other measures in the interest of Roads and Maritime.

Confidentiality requirements will equally apply to your support person, personal advisors and immediate family members.

Any Roads and Maritime staff member found to have breached confidentiality requirements may have disciplinary action taken against them. If you believe confidentiality has been breached, please advise Ms Julia Holden immediately on telephone 0429 061 831.

Integrity of Information

Where complaints are made, Roads and Maritime expects its staff members to raise complaints in good faith and that information provided in the investigation is not false or misleading. Disciplinary action, including dismissal may be taken against those found to have provided false or misleading information or made malicious complaints.

Victimisation

Victimising or retaliating against a person who is involved in an investigation because of their involvement will not be tolerated. Any finding of victimisation or retaliation against anyone who is involved in the investigation may result in disciplinary action being taken, including dismissal.

All participants of the investigation process have been advised of this. You should immediately contact me if you experience any difficulties in this regard.

- 1.14. On 7 December 2017, you received an email Ann Elisha (<u>ann@acbc.nsw.edu.au</u>) with no subject in the subject line. The message reads, "*Craig Is Ashley ok Sandy emailed me this morning and freaked me out!! I cant get in touch with her been trying Ashleys mobile and home......*"

Allegation 1:

Around 21 June 2012, you failed to disclose your personal connection with AA Steel Piping Pty Ltd (AA Steel Piping) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of AA Steel Piping to conduct "Work on design fault @ P2P site" to the value of \$26,400.00.

Allegation 2:

Around 16 July 2012, you failed to disclose your personal connection with AA Steel Piping Pty Ltd (AA Steel Piping) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of AA Steel Piping to conduct "Work on design fault @ P2P site" to the value of \$20,500.00.

Allegation 3:

Around 16 October 2012, you failed to disclose your personal connection with AA Steel Piping Pty Ltd (AA Steel Piping) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of AA Steel Piping to conduct "Works as ordered for P2P sites" to the value of \$18,000.00.

Please review report and comment. I will revise accordingly as I am home today."*

b) On the same day, you sent an email to "Marty" at M&M Inspections with an attachment titled "Site Inspection Record. Jerilderiedocx". The message you sent reads, *"Please see some notes."* The attached document has been modified by additional words in red font.

c) On the same day, you received an email from "Marty" at M&M Inspections with an attachment titled "Site Inspection Record. Jerilderie Rev1". The message from "Marty" reads, *"Hi Craig, please find revised report attached."*

2.9. On 10 July 2018, you sent an email to "Marty" at M&M Inspections with an attachment titled "RFQ 1". The message you sent reads, *"Please sign and return to me?"* The attached document relates to a request for quote 18.0000302935.0986 due on 9 July 2018. The properties for this document indicate: "Last Modified By STEYN Craig G" at 11:41am on 10 July 2018.

Allegation 23:

Around 29 May 2018, you failed to disclose your personal connection M&M Inspections Pty Ltd (M&M Inspections) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of M&M Inspections to conduct "Conduct Quality Assurance Safety Control" to the value of \$38,500.00.

Allegation 24:

Around 9 July 2018, you failed to disclose your personal connection M&M Inspections Pty Ltd (M&M Inspections) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of M&M Inspections to conduct "Physically check and observation of works been delivered for RMS" to the value of \$47,300.00.

Allegation 25:

Around 23 October 2018, you failed to disclose your personal connection M&M Inspections Pty Ltd (M&M Inspections) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of M&M Inspections to conduct "Average Speed Enforcement Prgm" to the value of \$47,300.00.

- 3.3. On 4 November 2013, you sent an email to "Steven Masters" (<u>sames1@bigpond.com</u>) (SA Masters Electrical) with the subject line "Re: Site Plan Mt Ousley". The message you sent reads, "*Thanks Steve You can pick up the key from my place Wed or Thur morning !.*
- 3.4. On 1 June 2018, you sent an email to "Steven Masters" (<u>sames1@bigpond.com</u>) (SA Masters Electrical) with the subject line "Re Tax Invoices". The message reads *"Hi Steve Can you please review to identify the correct PO on each invoice is been used? My system shows on PO 4200028806 has a value of \$24,255.00 available."*
- 3.5. *a)* On the 10 July 2018, you sent an email to "Steven Masters" with the subject line "*RFQ*" with an attachment titled "*RFQ 1.doc*". The message you sent reads, "*Hi Steve/Julie Can you please provide a quote for the works in the RFQ?*"

b) On the 17 July 20108, you received an email from "SA Masters Electrical Services" with the subject line "Quotation–ASC Program–S.A. Masters Electrical Services" with an attachment titled "Quotation 00004040.pdf". The message reads "Dear Sir/Madam, Please find attached as requested, a completed Quotation provided by S.A. Masters Electrical Services".

c) On the same day you replied to this email. The message reads *"Hi Steve Can you please return a signed copy of the RFQ I sent out for your response please?"*

d) On the 24 July 2018, you received an email from 'SA Masters Electrical Services" with the subject line *"RE: Quote–ASC Program–S.A. Masters Electrical Services"* with an attachment titled *"Signed Quote Documentation – ASC Program.pdf"*. The message reads *"Good afternoon Craig, As requested, please find attached a signed copy of the Quote re: ASC Program"*

The attachment to this email is a single page pdf document from the original quote sent on the 10 July 2018, there is no dollar value recorded within the required section however the document is signed by Steven Masters.

Allegation 26:

Masters Electrical Services (Steven Masters) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of S.A. Masters Electrical Services to conduct "Maintenance of Portable generator" to the value of \$25,000.00.

Allegation 27:

Around 23 July 2015, you failed to disclose your personal connection S.A. Masters Electrical Services (Steven Masters) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of S.A. Masters Electrical Services to conduct "Installation of elec & Data supply" to the value of \$11,000.00.

Allegation 28:

Around 13 August 2015, you failed to disclose your personal connection S.A. Masters Electrical Services (Steven Masters) and failed to disclose information about those connections in the context of your approval and / or recommendation for the engagement of S.A. At this stage, the further information being investigated relates to you having breached the Transport Code of Conduct by submitting false timesheet information, being untruthful to your manager and disobeying a reasonable direction.

The purpose of this letter is to set out the additional allegations against you which you are to respond to and to direct you to attend another formal disciplinary interview.

Mr David Faust, Investigations Analyst, Corruption, Prevention and Investigation Section, (CP&IS) will be conducting the interview which will be audio recorded and transcribed. Please confirm your attendance at least **24 hours** before the scheduled interview by sending an email to **David.Faust2@rms.nsw.gov.au**.

You may have a support person in attendance during the interview. This support person cannot, unless otherwise agreed to, act as your advocate or speak on your behalf. The support person should not be connected to the allegations of misconduct or a potential witness.

In accordance with Roads and Maritime Services' Discipline Guidelines and to provide you due process and procedural fairness, the purpose of the disciplinary interview is, amongst other things, to provide you with an opportunity to respond to allegations against you. The interview will give you an opportunity to provide an explanation of events, to provide comment on any relevant issue, and to present any relevant information that you believe should be considered. If you have any documents which you believe may be of assistance, please bring them with you.

The additional seven (7) allegations, numbers forty-seven (47) to fifty three (53) that are being further investigated are attached at 'Annexure 1.1'

Where complaints are made, Roads and Maritime expects its staff members to raise complaints in good faith and that information provided in the investigation is not false or misleading. Disciplinary action, including dismissal may be taken against those found to have provided false or misleading information or made malicious complaints.

Victimisation

Victimising or retaliating against a person who is involved in an investigation because of their involvement will not be tolerated. Any finding of victimisation or retaliation against anyone who is involved in the investigation may result in disciplinary action being taken, including dismissal.

- 4. On 17 July 2019, you sent two text messages to Ms Danielle Salib, "Morning. My apology was for you having to experience the unfortunate events of people come to invade your personal stuff at work. I understand this really upset you and for that, I am sorry D". And, "Thanks D."
- Around 6 August 2019, you met in person with Mr James Sheridan at the XS Espresso Café, situated on the corner of Windsor Road and James Ruse Drive, North Parramatta and discussed topics that included the ICAC investigation and ongoing RMS projects relating to the M7.

Proposed Disciplinary Action – Show Cause Termination of Employment

I refer to the disciplinary investigation into allegations that you breached the Transport Code of Conduct and the RMS Corrupt Conduct and Maladministration Prevention Policy. The disciplinary investigation has now concluded.

The investigation examined a total of fifty three (53) allegations of misconduct against you. A summary of the investigation findings is as follows:

- Allegations 1 to 25 against you are substantiated
- Allegations 26 to 33 against you are unsubstantiated
- Allegations 34 to 53 against you are substantiated

The investigation found evidence to support forty five of the fifty three allegations against you, in that you had engaged in fraudulent and inappropriate conduct through the following activities:

- Between 2012 to 2019 awarded contracts to vendors without disclosing a personal relationship or connection to the vendors.
- Used RMS motor vehicles for personal advantage between 29 March 2017 and 9 November 2018.
- Procured stationary items through RMS employee Ms Danielle Salib, Project Officer for Fixed Camera Support for a non-business purpose around 17 January 2018.
- Procured RMS apparel through RMS employee Ms Danielle Salib for a non-business purpose around 11 April 2018.
- Submitted timesheets and fraudulently claimed unworked hours between 16 March 2017 and 13 December 2018.
- Around 18 October 2018, provided false and misleading information to Mr Arnold Jansen, Senior Manager for Compliance and Regulatory Services (CaRs) regarding an application to work remotely from your residential address. Subsequently, you travelled to Perth WA for non-work related purposes during the same requested period.
- Disobeyed a reasonable direction given by Ms Melinda Bailey, Executive Director for Compliance and Regulatory Services (CaRS) on 19 June 2019 which prohibited you from contacting RMS employees unless advised otherwise.

The specific allegations put to you and the investigation findings are detailed in the document attached.

I consider that as a result of your substantiated conduct you have breached the following policies:

The Transport Code of Conduct:

Section 3: Staff Responsibilities

- Behave in a lawful, professional and reasonable manner and always act in the best interest of Transport.
- Comply with agency policies and procedures, as well as relevant legislative and industrial requirements that apply to you.
- Understand the duties, responsibilities and accountabilities of their role, and perform these safely, honestly, courteously and fairly.
- make impartial decisions that demonstrate your agency's values and promotes confidence in the integrity of public administration.
- Comply with reasonable lawful requests, directions and instructions given in the course of you
 duties by any person with authority to do so.

Section 5: Ethical decision making

We must ensure that our decisions:

- Are made lawfully, ethically and impartially;
- Promote agency values;
- Align with overall organisational objectives;
- Are in the public interest;
- You must consider the implications of your conduct, decisions and actions for yourself, customers, colleagues and Transport. Any information or advice you give or any decisions you make must not lead to personal gain ahead of public interest.

Section 15: Corrupt conduct and public interest disclosures

As a NSW public sector employee, corrupt or unlawful conduct by you in the course of your duties is not acceptable and will not be tolerated.

Section 19: Use of official resources

Private use of fleet vehicles is not permitted except in an emergency, exceptional circumstances or when permitted in agency policy or industrial instruments.

RMS Corrupt Conduct and Maladministration Prevention Policy

Staff must:

- not engage in any corrupt or unlawful conduct in the performance of their duties;
- act at all times within their delegated authority, comply with approved policies and procedures and carry out the responsibilities and accountabilities associated with their position in an ethical, conscientious and productive manner.

Proposed Disciplinary Penalty

Roads and Maritime is required to have trust and confidence in all its employees that they will conduct themselves appropriately, fairly and professionally. I am of the view that the conduct you have found to have engaged in goes to the question of whether Roads and Maritime can continue to have trust and confidence in you as an employee. I consider your substantiated conduct amounts to misconduct as set out in the Conduct & Discipline Handling Procedure which warrants the taking of disciplinary action.

Accordingly, the following disciplinary penalty is being considered:

• Termination of Employment

Given the seriousness of the substantiated conduct and the proposed disciplinary penalty, I am providing you with the opportunity to respond to me before coming to a final decision. I invite you to make a written submission to me within seven (7) days from the date of receipt of this letter with regard to the penalty, and also to provide me with any further information or material you may wish to be taken into account.

You are also welcome to discuss the matter with me personally at a time and date to be agreed. Please contact Kevin Mullins, Manager Professional Standards on 0481 008 461or <u>kevin.mullins@rms.nsw.gov.au</u> if you wish to make an appointment for this.

You will remain suspended from duty with pay pending the finalisation of this matter. The decision to suspend you from duty is not disciplinary action, and has been made having regard to the requirements identified in the Conduct and Discipline Handling Procedures.

Confidentiality

Pending finalisation of this matter, you are required to maintain confidentiality about the matters the subject of this letter. You are also directed not to discuss these matters with colleagues, including any colleague involved in the disciplinary investigation.

Around 17 January 2018, you inappropriately requested Danielle Salib to order and purchase stationary items from RMS supplier 'Complete Office Supplies' (COS) for non-work related purposes and intended personal use of your son in accordance with the stationary requirements specified by Hills Adventist College.

Finding – Substantiated

Allegation 46:

Around 12 April 2018, you inappropriately requested Danielle Salib to order and purchase apparel items from RMS supplier 'Riverina Workwear' for non-work related purposes and intended personal use.

Finding – Partially Substantiated

Mr Steyn inappropriately requested apparel items from Ms Danielle Salib to be purchased through RMS Supplier Riverina Workwear without corporate identity (substantiated), but did not request the subject work wear for a non-work related purpose (unsubstantiated).

Allegation 47

Around 16 March 2017, you inappropriately and dishonestly submitted your timesheet for the period 10 February 2017 to 9 March 2017 making a fraudulent claim for approximately 3 hours and 50 minutes worked on 1 March 2017.

Finding – Substantiated

Allegation 48

Around 11 May 2017, you inappropriately and dishonestly submitted your timesheet for the period 10 March 2017 to 6 April 2017 making a fraudulent claim for approximately 2 hours and 45 minutes worked on 29 March 2017.

Finding – Substantiated

Allegation 49

Around 11 May 2017, you inappropriately and dishonestly submitted your timesheet for the period 10 March 2017 to 6 April 2017 making a fraudulent claim for approximately 2 hours and 45 minutes worked on 29 March 2017.

Finding – Substantiated

Allegation 50

Around 19 December 2018, you inappropriately and dishonestly submitted your timesheet for the period 16 November 2018 to 13 December 2018 making a fraudulent claim for 4 hours and 10 minutes worked on 13 December 2018.

Finding – Substantiated

Allegation 51

Around 18 October 2018, you failed to behave in a professional, honest, and respectful manner by requesting permission from Mr Arnold Jansen, Senior Manager for Compliance Monitoring, to work from home due to family issues or similar between 5 and 9 November 2018, knowing that you would travel to Perth during the same period for non-work related reasons.

Allegation 52

Around 6 December 2018, you inappropriately and dishonestly submitted your timesheet for the period 19 October 2018 to 15 November 2018 making a fraudulent claim for approximately 42 hours worked between 5 November and 9 November 2018 inclusive.

Finding – Substantiated

Allegation 53

Between 28 June 2019 and 17 July 2019, you disobeyed a reasonable written direction given by Ms Melinda Bailey, Executive Director for Compliance and Regulatory Services, on 19 June 2019 that states, "...you are directed not to approach or contact any Roads and Maritime employee unless advised otherwise" by contacting RMS employees Ms Danielle Salib and Mr James Sheridan.
